When employed under 15 years of age, 3d. per hour.

Whem employed at 15 and under 16 years of age, 4d. per hour.

When employed at 16 and under 17 years of

age, 5d. per hour. When employed at 17 and under 18 years of age, 6d. per hour.

When employed at 18 and under 19 years of. age, 71d. per hour.

When employed at 19 and under 20 years of

age, 9d. per hour. When employed at 20 and under 21 years of

age, 101d. per hour. When employed at 21 and under 22 years of

age, 1s. 0d. per hour. When employed at 22 years of age and upwards, is.  $1\frac{3}{4}$ d. per hour.
