NATIONAL HEALTH INSURANCE.

Increase in Compulsory Health Insurable Limit in the Case of Non-Manual Workers.

The compulsory provisions of the National Insurance (Health) Acts have been extended in terms of the National Health Insurance Act, 1919, as from the 15th instant, to include all non-manual workers whose rate of remuneration does not exceed £250 a year. The compulsory Health Insurable Limit of remuneration for such workers was previously £160 a year.

The position is therefore now that employers must pay Health Insurance contributions in respect of persons employed by them under contract of service, as follows:—

(1) For non-manual workers where the rate of remuneration does not exceed £250 a year;

(2) For manual workers irrespective of the rate of remuneration.

In consequence of the Act, those insured persons whose free period of insurance had not expired before 30th June 1919 (i.e. in general, those for whom contributions were paid up to 30th June 1918, or later) and who on and after 30th June 1919 have been in employment remunerated at over £160 and not over £250 a year, will have their insurance made continuous on being brought again into compulsory insurance through the raising of the remuneration limit. Such persons will have the right to pay arrears in respect of any period for which ordinary contributions were not payable.

The new Act also provides that any person shall be entitled to a Certificate of Exemption who proves, on an application made before the 1st January 1920, or such later date as the Scottish Board of Health may allow in particular cases, that since the 29th of June 1919 he has been engaged in a non-manual employment at a rate of remuneration exceeding £160 a year

but not exceeding £250 a year.

Forms of application for exemption may be obtained at any Post Office or an application to the Board. The effect of the grant of such a Certificate is to relieve the employee from payment of contributions. The employer is, however, required to pay his own contributions, 3d. a week, on a special Card which is supplied to the exempt person. It rests entirely with the employed person to decide whether or not he wishes to claim exemption; as an exempt person he would be entitled, under certain conditions, to sanatorium benefit and also to either medical benefit or a contribution towards the cost of any medical treatment that he may obtain, but he could not receive other benefits.
