RULES PUBLICATION ACT, 1893.

INDIAN CIVIL SERVICE.

In conformity with the provisions of section 1 of the Statute 56 and 57 Victoria, ch. 66, notice is hereby given that the Secretary of State for India in Council proposes, with the advice and assistance of the Civil Service Commissioners, at the expiry of forty (40) days from the date of this Gazette, to make rules as shown below, in pursuance of the powers conferred on him by section 1 of the Indian Civil Service (Temporary Provisions) Act, 1915 (5 and 6 George V., ch. 87).

RULES.

Recruitment in India.

The following rules relate to the appointment during the year 1919 to the Indian Civil Service otherwise than by the annual Open Competition (which will still continue to be held) of Natives of India and Burma. It will rest with the Government of India to determine whether candidates are qualified in respect of nationality, age, character, and education, as defined in the following Regulations:—

1.—(a) Every candidate must be either a British subject or a ruler or subject of any State in India in respect of whom the Governor-General in Council has made a declaration under section 96 (a) of the Government of India Act, 1915, as amended by section 3 of the Government of India (Amendment) Act, 1916,

(b) If the candidate (being a British subject) or his father or his mother was not born within His Majesty's Dominion and allegiance, the father must at the time of the candidate's birth have been a British subject or the subject of a State in India and still be (or have continued to be until his death) a British subject or a subject of such State.

2. Every candidate must have been born on or after the 2nd August 1894, and on or before the 1st August 1898.

3. Every candidate must be of good moral character and sound physique.

4. Every candidate must produce satisfactory evidence that he possesses a degree in Arts or Science of an Indian or British University, or has passed the examination for the higher diploma of the Mayo College, Ajmer, or the diploma of the Aitchison Chiefs' College at Lahore.

5. Any person who possesses the qualifications prescribed in the foregoing rules is eligible to apply for nomination, whether he be already in Government service or not.

6. Every candidate, being a British subject, must submit to the local Government of the Province in which he resides an application in the form annexed to these rules, together with the fee prescribed in that form.

7. Every candidate, being a ruler or subject of a State in India who is qualified under rule 1, must submit his application through the

Durbar of the State to the local Government of the Province in which he wishes to serve.

8. Candidates will be nominated by the Government of India on the recommendation of the local Government.

9. Candidates nominated by the Government of India will be accepted by the Secretary of State for India in Council as Selected Candidates for the Indian Civil Service, subject to any further enquiries that he may find it necessary to institute, and will be required to undergo a period of probation for two years at a College or University in the United Kingdom approved by the Secretary of State. Selected candidates will be entitled to free passages to and from the United Kingdom and will be paid an allowance at the rate of £200 sterling per annum during the period of probation, subject to good conduct. At the end of this period of probation they will be tested by the Civil Service Commissioners, or by an Authority in India specially empowered in this behalf, in Indian Law and Languages, and in any other subjects which may be prescribed, and in riding. They will not be appointed to the Indian Civil Service until they have been certified to have fulfilled these tests.

10. Any attempt on the part of a candidate to enlist support for his application through persons of influence will disqualify him for appointment. Spontaneous recommendations from persons who are not themselves acquainted with the candidate's work at school, or at the University, or otherwise, will be disregarded.

Recruitment in United Kingdom.

For Rule 5 of the Rules of 7th January 1919, relating to the appointment of candidates who have served in H.M.'s Forces during the War which stands as follows:—

"5. Every candidate must have received continuous and systematic education of a high type until at least the age of 18, and must produce satisfactory evidence that if he has not received University education, he would have been justified in proceeding from school to a University with a view to taking high honours."

it is proposed to substitute the following rule:—

"5. Candidates must satisfy the Civil Service Commissioners that they have received whole-time continuous and systematic education up to the age of 18, or to the date of entering H.M.'s Forces, whichever is the earlier, and must also produce satisfactory evidence that if they have not received University education they would have been justified in proceeding from school to a University with a view to taking high honours."

On account of urgency the Secretary of State for India in Council has, under Section 2 of the Statute 56 and 57 Victoria, ch. 66, made the above rules to come into operation forthwith as provisional rules to continue in force until rules have been made in accordance with the provisions of Section 1 of that Act.

TRADE BOARDS ACTS, 1909 AND 1918.

SPECIAL ORDER MADE IN PURSUANCE OF SECTION ONE OF THE TRADE BOARDS ACT, 1918, WITH RESPECT TO THE STAMPED OR PRESSED METALWARES TRADE.

Whereas the Trade Boards Acts, 1909 and 1918, apply to the trades specified in the Schedule to the Trade Boards Act, 1909, and to the Trades specified in the Schedule to the Trade Boards Provisional Orders Confirmation Act, 1913, and the Minister of Labour is empowered under and by virtue of Section One of the Trade Boards Act, 1918, to make a Special Order applying the Trade Boards Acts, 1909 and 1918, to any specified trade to which they do not at the time apply, if he is of opinion that no adequate machinery exists for the effective regulation of wages throughout the trade, and that accordingly, having regard to the rate of wages prevailing in the trade, or any part of the trade, it is expedient that the Trade Boards Acts, 1909 and 1918, should apply to that trade:

And whereas the Trade Boards Acts, 1909 and 1918, do not apply to the trade specified in the Appendix to this Order, and the Minister of Labour as respects that trade is of the opinion aforesaid:

Now, therefore, I, the Minister of Labour, in pursuance of the powers given to me by Section One of the Trade Boards Act, 1918, and by any other Statute in that behalf, do hereby make a Special Order that from and after the 4th day of November 1919, the following provision shall have effect (that is to say):—

ARTICLE 1.—The Trade Boards Acts, 1909 and 1918, shall apply to the Trade specified in the Appendix to this Order.

ARTICLE 2.—This Order may be cited as the Trade Boards (Stamped or Pressed Metalwares) Order, 1919.

APPENDIX.

TRADE.

The Stamped or Pressed Metal-ware Trade, that is to say, the manufacture from metals (other than precious metals) by the processes of cold stamping or cold pressing (including cutting or piercing) of cabinet fittings, window fittings, curtain accessories, stationers' sundries, drapers' sundries, fittings for gas or electric light, fittings for suitcases or handbags or purses, buckles, eyelets, ferrules, labels, collar studs, tieclips, thimbles, photograph frames, stamped chains, bells, fancy nails (excluding the shanks), parts of safety razors (excluding the blades), parts of braces or suspenders, corset steels or busks, whistles, tin-openers, medals, or any similar articles or metal parts of such articles:

including:

(a) the operations of annealing, hardening, barrelling, polishing, bronzing, nickelling, lacquering, japanning, non-vitreous enamelling, tinning or assembling where these operations are carried on in association with or in

conjunction with the manufacture of such stamped or pressed metal articles;

(b) the operations of carding, boxing, packeting, labelling, weighing, packing, warehousing or despatching where these operations are incidental to or appertaining to the manufacture of such stamped or pressed metal articles;

but excluding:

(a) the operations specified in the Trade Boards (Hollow-ware) Order, 1913;

(b) the making of buttons or any operations incidental thereto;

(c) the making of coffin furniture or any operations incidental thereto;

(d) the making of pins, hairpins, hocks and eyes, hair-curlers, snap fasteners or safety pins or any operations incidental thereto;

(e) the making of steel pens and the making of stationers' metal sundries or other similar metal articles when carried on as a subsidiary branch of work in association with or in conjunction with the making of steel pens, so as to provide a common or interchangeable form of employment for the workers;

(f) the minting of coinage of the realm;

(g) the process of hand-embossing.

The Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Trade (that is to say):—

1. The making of such articles as are specified in (a) and (b) below, from linen or cotton or mixed linen and cotton fabrics (excepting knitted fabrics), or from other textile fabrics when the work is carried on in establishments mainly en-

gaged in the making of such articles from the before-mentioned fabrics: viz.—

- (a) Handkerchiefs (including mufflers or flags when made in association or conjunction with handkerchiefs);
 - (b) bed-linen, towels, dusters, table-napery, bed-spreads, tea-cloths, table-centres, side-board-covers, cushion-covers, or similar household articles;
- including all or any of the following operations:—
- (i) Hooking, cutting, or tearing the material;
 - (ii) Vice-folding;
 - (iii) Machine hemming, hem-stitching, spoking, over-locking, tambouring, button-holing, and other plain or fancy machine stitching;
 - (iv) All processes of embroidery or decorative needlework done by machine, whether before or after the making of the articles of the description specified above;
 - (v) The following processes if done by machine: Thread-drawing, thread-clipping, top-sewing, scalloping, nickelling, and paring;
 - (vi) All processes of laundering, smoothing, folding, ornamenting, boxing, finishing, warehousing, packing, and other similar operations incidental to or appertaining to the making of the articles of the description specified above.

2. The making up in linen warehouses or in establishments mainly engaged in linen lapping, of linen or mixed linen and cotton or other textile fabrics in the piece, or of linen or mixed linen and cotton or other textile articles cut from the piece, including:—

Measuring, cutting, lapping, ornamenting, boxing, warehousing, packing, and similar operations.

TRADE BOARDS ACTS, 1909 AND 1918.

The Trade Board established under the Trade Boards Act, 1909, and the Trade Boards Provisional Orders Confirmation Act, for the Tin Box and Canister Trade in Great Britain as defined in the Regulations made by the Board of Trade and dated 12th June 1914, have given notice that they have varied the General Minimum Time Rates for female workers from 5½d. to 7½d. per hour, and for male workers (other than knife hands or press hands) of the age of 21 years and upwards from 3s. 3d. per week of 52 hours to 1s. per hour, and for male knife hands or press hands of the age of 21 years and upwards to 1s. 2d. per hour, with variations in the General Minimum Time Rates fixed for younger female and male workers.

The Trade Board have also given notice that they have fixed Piece Work Basis Time Rates for female and male workers, 25 per cent. above the General Minimum Time Rates applicable, and have fixed Overtime Rates for male and female workers whether employed on Time Work or on Piece Work to apply to Overtime as defined by them on the basis of time and a quarter for the first two hours of Overtime, time and a half thereafter, and for all Overtime on Saturdays, double time for all time worked on Sundays and Customary Public and Statutory Holidays.

The Trade Board have also given notice that they have received notification from the Minister of Labour that he has made an Order dated

30th October 1919 under Section 4 (2) of the Trade Boards Act, 1918, confirming the minimum rates of wages as varied and fixed by the Trade Board, and specifying 3rd November 1919 as the date from which the rates shall become effective.

On application to the Trade Board, further information will be given as to the minimum rates fixed, if in the opinion of the Trade Board the applicant is likely to be affected thereby.

1. Mariners are warned that a certain number
 of mines have sunk without exploding. It is
 possible that some of these mines lying on the
 bottom may still be dangerous. Surface vessels
 navigating these areas should therefore when-
 ever possible, have a clear depth of at least six
 feet between their keels and the bottom when
 in the vicinity of shoal water or in the approaches
 to ports and harbours which were subjected to
 mining operations during the war.

2. Mariners are notified that the positions of

sunken mines are sometimes marked by a buoy with a black square mark on the staff. Such buoys are to be avoided and not interfered with.

3. Mariners are notified that a small percentage of drifting mines are known to exist in a waterlogged condition, a fraction of which may be dangerous. This type of mine is hard to see, and special precautions are therefore necessary to ensure that a good lookout is kept. The striking of low floating flotsam should be avoided.

4. A serious accident has occurred to a vessel at anchor from the explosion of a drifting mine which came into contact with an obstruction on the hull.

When vessels have to anchor in areas where drifting mines may be found it is necessary that all obstructions should as far as possible be removed and gangways triced up before dark in order to minimise risk.
