A PROCLAMATION

REVOKING SECTION 4 OF THE CURRENCY AND BANK NOTES ACT, 1914 WHEREBY BANK NOTES ISSUED BY A BANK OF ISSUE IN SCOTLAND OR IRELAND WERE MADE LEGAL TENDER.

GEORGE R.I.

WHEREAS by Section 4 of the Currency and Bank Notes Act, 1914, it was provided as follows:—

"Any bank notes issued by a bank of issue in Scotland or Ireland shall be legal tender for a payment of any amount in Scotland or Ireland respectively, and any such bank of issue shall not be under any obligation to pay its notes on demand except at the head office of the bank, and may pay its notes, if thought fit, in currency notes issued under this Act:

"Provided that notes which are legal tender under this section shall not be legal tender for any payment by the head office of the bank by whom they are issued for the purpose of the payment of notes issued by that bank.

"This section shall have effect only until His Majesty by proclamation revokes the same, and any proclamation revoking this section may provide for the calling in or exchange of notes affected thereby:"

And whereas it is desirable that in accordance with the powers thereby conferred the said section should be revoked as from the date hereinafter specified in that behalf:

Now, therefore, We have thought fit, by and with the advice of Our Privy Council, to issue this Our Royal Proclamation, and We do hereby proclaim, direct, and ordain as follows:—

Section 4 of the Currency and Bank Notes Act, 1914, is hereby revoked as from the first day of January nineteen hundred and twenty, and accordingly as from that date any bank notes issued by a bank of issue in Scotland or Ireland shall cease to be legal tender, and any such bank shall be under the same obligations with respect to the payment of its notes as it was before the said section came into operation.

Provided and it is hereby declared that nothing in this Proclamation operates so as to prevent any such bank as aforesaid from paying its notes in currency notes issued under the said Act.

Given at Our Court at Buckingham Palace, this Twentieth day of December, in the year of our Lord One thousand nine hundred and nineteen, and in the Tenth year of Our Reign.

THEREAS by Sub-Section four of Section four of the Scottish Board of Health Act, 1919, it is enacted that His Majesty may by Order in Council make provision for the transfer of any property, rights, or liabilities

held, enjoyed, or incurred by any Government Department in connection with any powers or duties transferred to the Scottish Board of

Health by the provisions of the Act:

Now, therefore, His Majesty, by and with the advice of His Privy Council, in pursuance of the Scottish Board of Health Act, 1919, and of all other powers enabling Him in that behalf, is pleased to order, and it is hereby ordered, as follows :-

1. All funds, bonds, securities, investments, sums of money, and other property, rights and assets belonging to, or vested in, or held in trust for the Highlands and Islands (Medical Service) Board in relation to the powers and duties transferred to the Scottish Board of Health by the provisions of the said Act shall be, and shall from the 1st September 1919, be deemed to have been, transferred to and vested in and held in trust for the Board as successor of the Highlands and Islands (Medical Service) Board without the necessity of any transfer, assignment, or other instrument, but subject to all debts, and liabilities affecting the same, and shall be held by the Board for the purposes for which they are now held, or would have been held, if the said Act had not passed.

2. The Interpretation Act, 1889, applies for the purpose of the interpretation of this Order | shall not be deemed to be an original member.

PRESENT,

The KING's Most Excellent Majesty in Council. THEREAS by Section 5 of the Scottish Board of Health Act, 1919, it is enacted as follows:

- (1) It shall be lawful for His Majesty by Order in Council to establish consultative councils for giving, in accordance with the provisions of the Order, advice and assistance to the Board in connection with such matters affecting or incidental to the health of the people in Scotland as may be referred to in such Order.
- (2) Every such council shall include persons of both sexes, and shall consist of persons having practical experience of the matters referred to the council, and due regard shall be had in constituting them to any special interests (including those of local authorities and of labour) which may be involved.

Now, therefore, His Majesty, by and with the advice of His Privy Council, in pursuance of the Scottish Board of Health Act, 1919, and of all other powers enabling Him in that behalf, is pleased to order, and it is hereby ordered, as follows :-

- 1. Consultative Councils shall be established in pursuance of the foregoing provisions for giving, in accordance with the provisions hereinafter contained, advice and assistance in connection with such matters as relate severally
 - (1) Medical and Allied Services.
 - (2) National Health Insurance (Approved) Societies' work).
 - Health Administration (3) Local General Health Questions.
 - (4) Highlands and Islands.
- 2. Each council shall consist of such number of members, not exceeding 20, as the Board may determine, being persons having, in the case of each council, practical experience of the matters for the purposes of which the council in question is established, and due regard shall be had in constituting such council to any special interests (including those of local authorities and of labour) which may be involved.

3.—(1) The members of a council shall be appointed by the Board, and shall include

persons of both sexes.

(2) At the expiration of one, two, and three years respectively from the first appointment of the members of the council, one-third of the original members, to be selected by lot, shall go out of office, but for the purpose of this provision an original member who has been re-appointed (3) Subject to aforesaid the members of a council shall hold office for three years and shall then go out of office; provided that on a casual vacancy occurring in a council the person appointed to fill the vacancy shall hold office until the time when the person in whose place he is appointed would regularly go out of office, and shall then go out of office.

(4) A member of a council on the expiration of his term of office may be re-appointed, so, however, that no member shall remain in office

continuously for more than six years.

4. Each council shall nominate its own Chairman. The Chairman of each council shall hold office until the next periodical expiration of the term of office of members of the council, but may be re-appointed so long as he remains a member of the council.

5. The Board shall appoint a person to be the Secretary of each council; and the person so appointed shall hold office during the pleasure

of the Board.

6.—(1) A council shall meet at such times, and notice of meetings shall be given to the members of the council in such manner as the council may, with the approval of the Board, determine:

Provided that the council shall meet at least three times in each year.

(2) At a meeting of a council 5 shall be a

(3) No act or proceeding of a council shall be questioned on account of any vacancy in their

body.

- 7. A council may, for special purposes approved by the Board, appoint committees of their members, and any Committee so appointed may, within the limits approved by the Board, add to their numbers persons not being members of the council.
- 8. The Board may convene joint meetings of any two or more councils established under this or any other Order, or of committees of such councils.
- 9. If a member of a council is absent, except for some reason approved by the Board, from the meetings of the council for a period of six months or for a period including three meetings of the council, whichever is the longer, his office shall become vacant.
- 10.—(1) A council shall consider and report upon the questions from time to time referred to them by the Board, including—
 - (a) questions arising upon the draft of Orders in Council and of Regulations, Orders, and Special Orders proposed to be made by the Board;

(b) questions involving considerations of important principle and scientific difficulty affecting or incidental to the

health of the people;

(c) any other questions in connection with such of the powers and duties of the Board as relate to matters affecting or incidental to the health of the people;

and the Board shall place at the disposal of the council the information required to enable them to consider the matters thus referred to them.

(2) A council may propose to the Board from time to time that any question in connection with such of their powers and duties as relate to matters affecting or incidental to the health

of the people, if pertaining to the functions of the council, shall form the subject of a reference to the council, and the Board shall receive and consider

any such proposal.

(3) A council may also present to the Board from time to time a report on any matter affecting or incidental to the health of the people if pertaining to the functions of the council, which has not been made the subject of reference to the council under the foregoing provisions of this Order, and the Board shall receive and consider such report.

11. Subject to the provisions contained in this Order, a council may regulate their own pro-

- (d) The manufacture from ceramic materials of dolls or dolls' parts, dolls' china, marbles or similar articles when carried on in association with or in conjunction with the manufacture of other pottery.

(e) The making of articles from sugar confectionery.

(f) The making of hollow-ware, including boxes and canisters, from sheet iron, sheet steel or tinplate, or any operations incidental thereto.
