Extract of a Letter from Sir G. H. B. IRLOW, to the Secret Committee of the Court of Directors, dated on the River Culna, 2d February 1806.

I have great satisfaction in apprizing your Ho-nourable Committee, that, on the 22d December, a ratified copy of the treaty concluded between the Right Honourable Lord Lake and the accredited Vakeel of Dowlut Rao Scindiah, (a copy of which was inclosed in my dispatch to your Honourable Committee of the 4th of that month,) was received by his Lordship, with a slight and unobjectionable alteration in the sixth article, namely, the omission of the renunciation of that Chieftain's claims to Tonk Rampoorah and Bamingham, which, probably, resulted from a consideration, that, as these districts never actually belonged to him, the renunciation was unnecessary.

Extract of a Letter from Sir G. H. BARLOW to the Secret Committee, dated on the River, 5th February 1806.

I have great satisfaction in communicating to your Honourable Committee the important intel-Rao Holkar, upon terms which are highly honourable and advantageous to the British Government, and which are calculated to secure permanent tranquillity to the British power in India.

In my dispatch to your Honourable Committee of the 4th of December, I had the honour to transmit a copy of my instructions to the Right Hon. Lord Lake, for the regulation of his conduct in concluding a pacification with Jeswunt Rao Holkar. The treaty now concluded with that Chieftain has been founded upon those instructions, and corresponds with the spirit of

I have the honour to transmit, inclosed, a copy of the Right Hon. Lord Lake's dispatch of the 7th ult. containing a copy of the treaty.

With the exception of the second article, the

provisions of which I have judged it proper to

annul by a declaratory article annexed to the ratified copy of the treaty, your Honourable Committee will observe that the stipulations of the treaty involve no engagements of a nature calculated to prove the source of future disagreement between the British Government and Holkar, and the probability of the continuance of Holkar's

and the probability of the continuance of Holkar's pacific disposition, and of his adherence to the faith of his engagements, may be considered to be proportionably augmented.

I beg leave to offer to your Honourable Committee my cordial congratulations on the conclusion of this honourable and advantageous peace with Jeswunt Row Holkar, which, combined with the preceding adjustment of all our differences with Dowlut Row Scindiah, and with all the arrangements now in progress for the complete settlement of all our external relations, promises a durable period of tranquillity and prosperity to the

settlement of all our external relations, promises a durable period of tranquillity and prosperity to the Hon. Company's possessions.

I discharge a satisfactory part of my public duty in expressing to your Hon. Committee the high sense which I entertain of those able and distinguished exertions on the part of the Right Hon. Lord Lake, by which the peace has been accomplished, and which, I trust, will appear to your Hon. Committee to establish his Lordship's claim to the highest approbation and applause.

I consider it to be a duty also to express my sense of the zeal and ability manifested by Lieutenant-Colonel Malcolm in the conduct of the negociations for the conclusion of peace, which was entrusted to him by the authority of Lord Lake. The merits and services of that valuable officer are already well known to your Honourable Committee; but I trust that his exertions on this occasion will appear to your Honourable Committee to have augmented his claim to public approba-

To the Honourable Sir G. H. BARLOW, Bart. Governor-General, &c.

I have the honour to inclose a treaty which I we concluded with Jeswunt Row Holkar, and which I this morning received ratified by that Chief.

The circumstances which led to a negociation with Jeswunt Row Holkar, and the whole progress of that to its conclusion, will be fully communicated, under my orders, to the Secretary in the secret department.

I offer you my most cordial congratulations on an event which promises to restore complete tran-quillity to India, and which you will, I am satisfied, judge to be highly favourable to the interests of the British Government.

You were before informed of the situation of Jeswunt Row Holkar at Amruh Sir, and of his efforts to form a combination in this quarter against. the British Power. These were alone defeated by the advance of the army under my command, which had also the effectof reducing Jessunt Row Holkar to the necessity of concluding the present treaty, and of renouncing all those views of ambition which he had so long cheriched against the tion which he had so long cherished against the British Government.

I feel it again my duty to call your attention to the exertions of Lieutenant Colonel Malcolm, by whose knowledge and ability this treaty has been. negociated under my direction, and whose many and important services will; I trust, meet that re-compence to which I consider them so justly entitled.

It is my intention to march the day after tomorrow towards the British territories; and on my arrival there, I shall lose no time in placing the army under my command in cantonments.
