TRADE BOARDS ACTS, 1909 AND 1918.

STAMPED OR PRESSED METAL WARES TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO VARY GENERAL MINIMUM TIME-RATES AND OVERTIME RATES FOR CERTAIN CLASSES OF MALE WORKERS.

In accordance with the Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 31st October 1918, the Trade Board established in Great Britain under the Trade Boards Act, 1918, for the Stamped or Pressed Metal Wares trade, as specified in the Trade Boards (Stamped or Pressed Metal Wares) Order, 1919, hereby give Notice as required by Section 3 (5) of the Trade Boards Acts, 1918 (the Minister of Labour having given his consent to such Notice being given) that they Propose

to Vary the General Minimum Time-Rates and Overtime Rates for Male Workers at present fixed and set out in their Notice, dated 9th September 1920, in respect of certain classes of Male Workers, so that in lieu of such Minimum Rates the General Minimum Time-Rates and Overtime Rates for the classes of workers specified below, shall be as follows:—

# PART I.

PROPOSED VARIATIONS OF GENERAL MINIMUM TIME-RATES FOR MALE WORKERS.

Section I.—Male Workers of 21 years of age and upwards who are employed as Braziers, Burnishers, Drop-Stampers, Dippers, Dippers who are also Bronzers, Annealers or Brass Polishers:—

Variations Proposed.

(a) Braziers, Burnishers or Drop-Stampers:
Workers of Grade I., as hereinafter defined,
from 1s. 4½d. per hour to 1s. 8½d. per hour.

Workers of Grade II., as hereinafter defined, from 1s. 4½d. per hour to 1s. 10½d. per hour.

Workers of Grade III., as hereinafter defined, 1s. 4½d. per hour to 2s. per hour.

(b) Dippers:
During the first twelve months of employment after the age of 21 years, from 1s. 4½d. per hour to 1s. 5½d. per hour.

On and after completion of 12 months' employment after reaching the age of 21 years, from 1s. 4½d. per hour to 1s. 8½d, per hour.

(c) Dippers who are also Bronzers:

Workers of Grade I., as hereinafter defined, from 1s.  $4\frac{1}{2}$ d. per hour to 1s.  $8\frac{1}{2}$ d. per hour.

Workers of Grade II., as hereinafter defined, from 1s.  $4\frac{1}{2}$ d. per hour to 1s.  $10\frac{1}{2}$ d. per hour.

Workers of Grade III., as hereinafter defined, 1s.  $4\frac{1}{2}$ d. per hour to 2s. per hour.

(d) Annealers who can take charge of their own work, from 1s. 4½d. per hour to 1s. 8½d. per hour.

(e) Brass Polishers:

'Workers of Grade I., as hereinafter defined, from 1s. 4½d. per hour to 1s. 8½d. per hour.

Workers of Grade II., as hereinafter de-

Workers of Grade II., as hereinafter defined, from 1s.  $4\frac{1}{2}$ d. per hour to 1s. 11d. per hour.

Workers of Grade III., as hereinafter defined, from 1s. 4½d. per hour to 2s. 0½d. per hour.

Section II.—For the purpose of the above proposed Rates the following definitions shall apply:—

Braziers:

A Brazier of Grade I. is a Male Worker of 21 years of age or over employed on brazing and not fulfilling the conditions of Grade II. or Grade III. next hereinafter respectively defined.

A Brazier of Grade II. is a Male Worker of 21 years of age or over who has had not less than six years' experience as a Brazier and who is an expert in brazing in all classes of metal except aluminium.

A Brazier of Grade III. is a Male Worker of 21 years of age or over who in addition to fulfilling the conditions of Grade II. as above defined is also an expert in brazing aluminum or is a charge hand with the duty of being responsible for all work and order in the shop.

Burnishers:

A Burnisher of Grade I. is a Male Worker of 21 years of age or over employed on burnishing and not fulfilling the conditions of Grade II. or Grade III. next hereinafter respectively defined.

A Burnisher of Grade II. is a Male Worker of 21 years of age or over who has had not less than six years' experience as a Burnisher and who is an expert hook and straight Burnisher at the vice and satisfactorily burnishes

deep thin shell work at the lathe.

A Burnisher of Grade III. is a Male Worker of 21 years of age or over who in addition to fulfilling the conditions of Grade II., as above defined, is an expert in speed and quality in all classes of work, or is a charge hand with the duty of being responsible for all work and order in the shop.

Drop-Stampers:

A Drop-Stamper of Grade I. is a Male Worker of 21 years of age or over employed on drop-stamping and not fulfilling the conditions of Grade II. or Grade III. next hereinafter respectively defined.

A Drop-Stamper of Grade II. is a Male Worker of 21 years of age or over who has had not less than six years' experience as a Drop-Stamper and who undertakes all classes of deep or shallow work in all strengths of the metal used.

A Drop-Stamper of Grade III. is a Male

Worker of 21 years of age or over who, in addition to fulfilling the conditions of Grade II., as above defined, is an expert in all classes of work or is a charge hand with the duty of being responsible for all work and order in the shop.

Dippers who are also Bronzers:

A Worker of Grade I. is a Male Worker of 21 years of age or over employed on dipping and bronzing and not fulfilling the conditions of Grade II. or Grade III. next hereinafter respectively defined.

A Worker of Grade II. is a Male Worker of 21 years of age or over who has had not less than six years' experience as a Dipper and Bronzer and who is an all-round Dipper and Bronzer and also does art bronzing and colouring, or electro-plating or has a knowledge of

electro-plating.

A Worker of Grade III. is a Male Worker of 21 years of age or over who, in addition to fulfilling the conditions of Grade II., as above defined, also has an expert knowledge of art bronzing or metal colouring or electro depositing and solutions or is a charge hand with the duty of being responsible for all work and order in the shop.

Brass Polishers:

A Polisher of Grade I. is a Male Worker of 21 years of age or over employed on polishing and not fulfilling the conditions of Grade II. or Grade III. next hereinafter respectively defined.

A Polisher of Grade II. is a Male Worker of 21 years of age or over who has had not less than six years' experience as a Polisher and is an expert in all processes of any class of common work and can emery-bob and mop best work.

A Polisher of Grade III. is a Male Worker of 21 years of age or over who, in addition to fulfilling the conditions of Grade II., as above defined, is also an expert in all processes of both common and best work or is a charge hand with the duty of being responsible for all work and order in the shop.

SECTION III.—Male Workers under 21 years of age who are employed as Braziers, Burnishers, Drop-Stampers, Dippers, Dippers who are also Bronzers, or as Annealers who can take charge of their own work:—

#### Variations Proposed.

Workers under 15 years of age, from 4½d. per hour to 5d. per hour.

Workers of 15 and under 16 years of age, from 6d. per hour to 7d. per hour.

Workers of 16 and under 17 years of age, from 7d. per hour to 8½d. per hour.

Workers of 17 and under 18 years of age, from 8d. per hour to 101d. per hour.

Workers of 18 and under 19 years of age:

- (a) With less than two years' experience in the branch of trade in which they are engaged, from 9d. per hour to 11d. per hour.
- (b) With not less than two years' but less than three years' experience in the branch of trade in which they are engaged, from 9d. per hour to 1s. per hour.

(c) With over three years' experience in the branch of trade in which they are engaged, from 9d. per hour to 1s. 1d. per hour.

Workers of 19 and under 20 years of age:

- (a) With less than three years' experience in the branch of trade in which they are engaged, from 11½d. per hour to 1s. per hour.
- (b) With not less than three years' but less than four years' experience in the branch of trade in which they are engaged, from 11½dper hour to 1s. 2d. per hour.

(c) With over four years' experience in the branch of trade in which they are engaged, from 11½d. per hour to 1s. 4d. per hour.

Workers of 20 and under 21 years of age:

- (a) With less than three years' experience in the branch of trade in which they are engaged, from 1s. 2d per hour to 1s. 3d. per hour.
- (b) With not less than three years' but less than five years' experience in the branch of trade in which they are engaged, from 1s. 2d. per hour to 1s. 5d. per hour.
- (c) With not less than five years' experience in the branch of trade in which they are engaged, from 1s. 2d. per hour to 1s. 6d. per hour.

#### PART II.

PROPOSED VARIATION OF OVERTIME RATES.

Overtime Rates calculated on the proposed Minimum Rates specified in Part I. of this Notice, in the manner set out in Part III. of the Notice issued by the Trade Board, dated 9th September 1920, shall apply in substitution for the proposed Minimum Rates otherwise applicable, as set out in Part I. of this Notice, in respect of all hours worked in excess of the number of hours declared by the Trade Board in the above-mentioned Notice, dated 9th September 1920, to be the normal number of hours of work in the trade.

#### PART III.

The above proposed Minimum Rates of Wages shall apply, subject to the provisions of the Trade Boards Acts, to all workers of the classes specified above in respect of any time during which they are employed in any branch of the trade specified in the Trade Boards (Stamped or Pressed Metal Wares) Order, 1919, that is to say:—

The manufacture from metals (other than precious metals) by the processes of cold stamping or cold pressing (including cutting or piercing) of cabinet fittings, window fittings, curtain accessories, stationers' sundries, drapers' sundries, fittings for gas or electric light, fittings for suit-cases or handbags or purses, buckles, eyelets, ferrules, labels, collar studs, tie-clips, thimbles, photograph frames, stamped chains, bells, fancy nails (excluding the shanks), parts of safety razors (excluding the blades), parts of braces or suspenders, corset steels or busks, whistles, tin-openers, medals or any similar articles or metal parts of such articles:—

 (a) The operations of annealing, hardening, barrelling, polishing, bronzing, nickelling

- lacquering, japanning, non-vitreous enamelling, tinning, or assembling where these operations are carried on in association with or in conjunction with the manufacture of such stamped or pressed metal articles;
- (b) The operations of carding, boxing, packeting, labelling, weighing, packing, warehousing or despatching, where these operations are incidental to or appertaining to the manufacture of such stamped or pressed metal articles;

but excluding

- (a) The operations specified in the Trade Boards (Hollow-ware) Order, 1913;
- (b) The making of buttons or any operations incidental thereto;
- (c) The making of coffin furniture or any operations incidental thereto;
- (d) The making of pins, hairpins, hooks and eyes, hair-curlers, snap-fasteners or safety pins or any operations incidental thereto;
- (e) The making of steel pens and the making of stationers' metal sundries or other similar metal articles when carried on as a subsidiary branch of work in association with or in compunction with the making of steel pens, so as to provide a common or interchangeable form of employment for the workers;
- (f) The minting of coinage of the realm;
- (g) The process of hand-embossing.

#### PART IV.

Section I.—The above proposed Minimum Rates of Wages shall be paid clear of all deductions, other than deductions under the National Insurance Act, 1911, as amended by subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any superannuation or other provident fund.

SECTION II.—The above Proposed Minimum Rates of Wages are without prejudice to Workers who are earning higher Rates of Wages, or to Agreements made or that may be made between Employers and Workers for the payment of Wages in excess of these Minimum Rates of Wages.

The Trade Board will consider any Objections to the above Proposals which may be lodged with them within two months from the 20th September 1920. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address) and should be sent to The Secretary, The Stamped or Pressed Metal Wares Trade Board (Great Britain), 5 Chancery Lane, London, W.C. 2.

It is desirable that the Objections should state precisely, and so far as possible with reasons, what is objected to.

· In pursuance of the powers conferred on him by the Trade Boards Acts, 1909 and 1918, the Minister of Labour is pleased to establish a Trade Board in Great Britain for the branch of the trade specified in the Trade Boards (Waste Materials Reclamation) Order, 1920, which is set out below :-

The Cotton Waste Branch of the Waste Materials Reclamation Trade, that is to say !-

- 1. The collecting, sorting or grading of cotton waste when carried in in an establishment in which such operations are the main or principal business;
- 2. The following operations when carried on in or in association with or in conjunction with any establishment of the kind specified in paragraph 1 above :-
  - (a) the willowing, machining, breaking-up, scouring or putting down mixings of cotton waste;
  - (b) the collecting, sorting or grading of any of the materials or articles, other than cotton waste, specified in paragraph 1 or paragraph 2 of the Appendix to the Trade Boards (Waste Materials Reclamation) Order, 1920;
  - (c) the operations specified in paragraph 3 of the Appendix to the above-mentioned Order, other than those specified in subparagraph (a) above;
- 3. The operations of receiving, packing, compressing teagling, craning, despatching or warehousing when carried on in association with or in conjunction with any of the operations included in paragraphs 1 and 2 above; but excluding—
  - (i) Any of the operations mentioned in paragraphs 1, 2, and 3 above when carried on in the establishment in which the waste materials are produced or in which they are used as raw materials for further manufacture;
  - (ii) the making or repairing of sacks or bags when carried on in a factory or workshop engaged solely or mainly in the making or repairing of sacks or bags.

#### List of Materials and Articles.

Rags, waste paper, paper stock; [woollen, worsted, jute. flax, hemp or other textile waste; textile clippings or cuttings; used bags, sacks or sacking; scrap rubber; scrap iron or other scrap metal; fur cuttings; rabbit skins; bones or fat; used tins; broken glass or earthenware; discarded clothing (including head-gear or foot-gear); discarded textile articles, old ropes; used bottles or used jars.

## List of Operations.

The ripping of worn clothes for rags; the picking of old ropes; the trimming of paper salvage; the washing of used bottles or used jars; the washing of used tins; the breaking of scrap metal; the drying of rabbit skins; the making or repairing of sacks or bags; the willowing, pulling, scouring, carbonising or putting down mixings of textile waste (other than cotton waste).
