The KING has been graciously pleased to approve of the award of the Albert Medal to Mr. Harry Smith, Commissioned Engineer, R.N., for gallantry in saving life at sea.

The following is the account of the services in respect of which the decoration has been conferred :—

On the 13th May last, while H.M. Torpedo Boat Destroyer "Rob Roy" was proceeding at utmost speed on a full-power trial, a fire broke out in the forward boiler-room.

With entire disregard of his own safety, Mr. Smith immediately went below to search for the

two ratings who were still there, and to shut off the boilers under extreme difficulties owing to the heat, escaping steam, and water, well knowing in doing so the danger he ran from the burning oil fuel and the unconsumed gases accentuated by the confined and congested space of a destroyer's boiler-room.

Owing to his prompt action and presence of mind, Mr. Smith localised the damage and saved the lives of all who were below.

## SCOTTISH BOARD OF HEALTH.

ORDER OF THE SCOTTISH BOARD OF HEALTH in terms of Section 64 (3) of the National Insurance Act, 1911, providing for a combination of the County of Dunbarton and the Burghs of Dumbarton and Clydebank for the provision of a Sanatorium, etc.

Whereas by Section 16 (1) (b) of the Finance Act, 1911, a sum is made available, in such manner as Parliament may determine, for the purposes of the provision of, or making grants in aid to, Sanatoria and other institutions for the treatment of Tuberculosis;

And whereas Section 64 (1) of the National Insurance Act, 1911, provides that the aforesaid sum is to be distributed by the Local Government Board with the consent of the Treasury;

And whereas Section 64 (2) of the National Insurance Act, 1911, provides that, if any such grant is made to a County Council, the Local Government Board may authorise the County Council to provide any such institutions, and, where so authorised, the County Council shall have power to erect buildings and to manage and maintain the institution, and for that purpose to enter into agreements and make arrangements with Insurance Committees and other authorities and persons, and to do all such things as may be necessary for the purposes aforesaid;

And whereas Local Authorities under the Public Health (Scotland) Act, 1897, have power under Section 66 of that Act to provide, furnish and maintain such institutions;

And whereas Section 64 (3) of the National Insurance Act, 1911, provides as follows:—

“For the purposes of facilitating co-operation amongst County Councils, County Borough Councils and other Local Authorities (not being Poor Law Authorities) for the provision of such sanatoria and other institutions as aforesaid, the Local Government Board may by order make such provisions as appears to them necessary or expedient, by the constitution of Joint Committees, Joint Boards or otherwise, for the joint exercise by such Councils and Authorities of their powers in relation thereto, and any such Order may provide how, in what proportion, and out of what funds or rates the expenses of providing such institutions, so far as they are not defrayed out of grants under this Section, are to be defrayed, and may contain such consequential incidental and supplemental provisions as may appear necessary for the purposes of the Order, and an Order so made shall be binding and conclusive in respect of the matters to which it relates;”

And whereas by Section 16 of the Local Government (Emergency Provisions) Act, 1916, it is enacted that every joint committee and every joint board constituted or to be constituted under Sub-section (3) of Section 64 of the National Insurance Act, 1911, shall be a body corporate by such name as the Board by which it is constituted may direct and shall have perpetual succession and a common seal and may hold land for the purposes of their powers and duties without licence in mortmain.

And whereas Section 80 (3) of the National

Insurance Act, 1911, provides that in the application of the Act to Scotland the expression "Local Government Board" means the Local Government Board for Scotland;

And whereas in terms of the Scottish Board of Health Act, 1919, the powers and duties of the Local Government Board for Scotland have been transferred to the Scottish Board of Health;

And whereas Section 80 (4) of the National Insurance Act, 1911, provides, *inter alia*, as follows:—

"The expression 'County Borough' means a burgh or police burgh within the meaning of the Local Government (Scotland) Act, 1889 (in this Section referred to as the Act of 1889), containing within the police boundaries thereof according to the census of nineteen hundred and eleven a population of twenty thousand or upwards, and all other burghs and police burghs shall, for the purposes of this part of this Act, be held to be within the County, and unless already represented on the County Council shall, for the purposes of this part of this Act, be represented thereon as may be determined by the Secretary for Scotland";

And whereas the Town Councils of the for Scotland have authorised the County Council of the County of Dunbarton in terms of Section 64 (2) aforesaid;

And whereas the Town Councils of the Burghs of Dumbarton and Clydebank are Local Authorities within the meaning of the Public Health (Scotland) Act, 1897, possessing the powers aforesaid;

And whereas Section 41 (4) of the National Insurance Act, 1913, provides that for the purposes of Section 64 (3) aforesaid Burghs and Police Burghs held to be within the County may receive direct representation on any joint committees, joint boards, or other bodies thereby constituted in such manner as may be determined by the Board;

And whereas the Board have determined that the Burghs of Helensburgh, Kirkintilloch, Milngavie and Cove and Kilcreggan shall receive direct representation as aforesaid;

And whereas it is provided by Section 80 (12) of the National Insurance Act, 1911, that expenses incurred by a County Council under Part I. of that Act shall be defrayed out of the General Purposes Rate;

And whereas it is provided by Section 80 (13) of the National Insurance Act, 1911, that expenses incurred by a Town Council under Part I. of that Act shall be defrayed out of the Public Health General Assessment;

And whereas it is expedient that a combination for the purposes specified in Section 64 (3) of the National Insurance Act, 1911, be effected between the County Council of the County of Dunbarton and the Town Councils of the Burghs of Dumbarton and Clydebank;

Now therefore the Scottish Board of Health, hereinafter referred to as "the Board," in pursuance of the powers vested in them as aforesaid, do make the following Order:—

#### *Combination of Authorities.*

Article 1.—From and after the date of this Order, the County Council of the County of

Dunbarton and the Town Councils of the Burghs of Dumbarton and Clydebank (hereinafter referred to as the "Combining Authorities") shall be combined for the purpose of providing, furnishing, managing and maintaining a sanatorium for the treatment of tuberculosis, and making such other provision in connection therewith as may be deemed necessary by the Board or by the Joint Board, to be constituted in terms hereof.

#### *Formation of Joint Board.*

Article 2.—(1) The provision of such Sanatorium (hereinafter referred to as "the Sanatorium"), the furnishing, management and maintenance thereof, and the doing of all such things as may be necessary for these purposes, shall be undertaken by a Joint Board to be called "The Dumbarton Joint Sanatorium Board."

#### *Number and Qualification of Members.*

(2) The said Joint Board shall consist of nineteen members—or such other number as the Board may from time to time determine. Such members shall be members of the Combining Authorities or of the Town Councils of the Burghs aforesaid, and shall hold office only so long as they remain members of the Combining Authorities or of these Town Councils.

#### *Representation of Authorities.*

(3) Of the said members, the County Council of the County of Dunbarton shall appoint seven; the Town Council of the Burgh of Dumbarton shall appoint three; the Town Council of the Burgh of Clydebank shall appoint five; and the Town Councils of the Burghs of Helensburgh, Kirkintilloch, Milngavie and Cove and Kilcreggan shall appoint one each; Provided that when it appears to the Board necessary, and subject to what is hereafter mentioned, the Board may readjust the representation of the several authorities on the Joint Board.

#### *Tenure of Office of Members.*

(4) The said members shall be appointed by the respective authorities in the month of December in each year, and shall hold office for the period of one year from the date of their appointment, or for such shorter period as they may be members of the Authorities appointing them. Retiring members shall be eligible for re-appointment. The names and addresses of the persons so appointed shall be intimated immediately by the Clerks to the respective Authorities to the Clerk to the Joint Board.

#### *Appointment of First Representatives.*

(5) For the purpose of constituting the Joint Board, the several Authorities aforesaid shall, immediately after the date of this Order, appoint their representatives and cause the names and addresses of such representatives to be intimated to the County Clerk of the County of Dunbarton, who shall convene the first meeting of the Joint Board to be held at Dumbarton. The representatives so appointed shall hold office until the month of December 1921, when the representatives for the ensuing year will be appointed in terms of Article 2 (4) hereof.

*Annual Meeting. Election of Chairman, &c.*

(6) A General Meeting of the Joint Board shall be held yearly as soon as practicable after the representatives of the several authorities have been appointed under Article 2 (4) hereof. At that meeting the members shall elect one of their number to be Chairman for the year then ensuing and another to be Vice-Chairman for the same period;

Provided that, at the first meeting of the Joint Board convened in terms of Article 2 (4) the members shall elect one of their number to be Chairman for the period till the General Meeting aforesaid, and another to be Vice-Chairman for the same period.

*Meetings and Powers of Joint Board.*

(7) The Joint Board shall meet for the despatch of business at such other times and at such place or places as they may from time to time fix. They shall have power (1) to make Standing Orders regulating their proceedings and business; (2) to fix the quorum for meetings; (3) to appoint such sub-Committees as they may from time to time consider necessary; (4) to appoint a Clerk who may also be Treasurer, a Medical Superintendent, a Matron, and such other officers and servants as may be considered necessary, and to pay them such salaries as the Joint Board may from time to time think proper; (5) to delegate to the sub-Committees and officers so appointed such of their powers as they may see fit; and (6) to make regulations (subject to the Board's approval) with regard to the admission and rejection of patients, the conduct and duties of patients, visitors, officers and servants connected with the Sanatorium.

*Decisions of Joint Board not to be subject to review by Combining Authorities.*

(8) The decisions of the Joint Board shall not be subject to the review of any of the Combining Authorities.

*Filling up Vacancies.*

(9) In the event of any vacancy occurring in the Joint Board from any cause, the Authority in the representation of which the vacancy has occurred shall have power to fill up the same *ad interim*, and upon such appointment being made, the name and address of the person so appointed shall be intimated to the Clerk to the Joint Board as provided for in Article 2 (4); but the failure of such Authority to make such appointment or to intimate the same shall not invalidate the proceedings of the Joint Board. The person appointed *ad interim* shall hold office until the month of December next ensuing after his appointment.

*Selection of Site.*

Article 3.—(1) The Joint Board shall, as soon as practicable after the date of this Order, take steps to acquire a suitable site on which to erect the buildings necessary for the purposes of this combination. The site selected shall be subject to the Board's approval.

*Title to Land.*

(2) The title to the land to be acquired for the said buildings shall be taken in favour of the Joint Board, and shall be held by them for the ends, uses and purposes herein specified.

(3) The powers of the Joint Board under this Order shall include the power to provide all such works as may appear to the Joint Board necessary for the efficient working of the Sanatorium.

*Preparation of Plans.*

Article 4.—(1) When a suitable site has been secured and approved, in terms of the immediately preceding Article, the Joint Board shall take steps to have plans prepared of the various buildings to be erected on the said site. Before the erection of any buildings is begun, the plans thereof must first be approved by the Board, and any proposed deviation from the approved plans during the course of erection shall be submitted for the Board's approval.

*Erection of Buildings.*

(2) When the plans have been so approved, the Joint Board shall cause to be prepared specifications and schedules of measurement of the proposed works, and shall obtain estimates therefor. Before the estimates are finally accepted, they shall be submitted for the Board's approval. On such approval being given, the Joint Board shall proceed with the erection of the buildings or such portion thereof as they may, subject to the Board's approval, consider sufficient for the immediate needs of the area of the combination. Before patients are received for treatment in the Sanatorium, the Board's sanction to the occupation thereof shall be obtained.

*Plans of Additions.*

(3) The requirements of this Article shall, so far as applicable, apply to the provision of any addition to or alteration on the Sanatorium that may be made from time to time.

*Area of Combination.*

Article 5.—(1) The Sanatorium provided in terms of this Order shall be primarily for the use of the inhabitants of or persons found within the areas under the jurisdiction of the Combining Authorities suffering from or suspected to be suffering from Tuberculosis, but it shall be open to the Joint Board to admit patients from districts outwith the said area, on terms to be agreed on.

(2) In the event of any person within the area of the combination desiring special accommodation and treatment at the Sanatorium, the Joint Board shall have power to provide the same on such terms and conditions as they think proper.

*Arrangements with Other Authorities.*

Article 6.—The Joint Board shall have power to make arrangements with other authorities for the treatment in the Sanatorium of persons suffering from Tuberculosis. For the purpose of making such arrangements the Joint Board shall have power to fix a weekly or daily rate to be paid in respect of each such person, and to vary such rates from time to time.

*Appointment of Medical Superintendent.*

Article 7.—(1) The Medical Superintendent of the Sanatorium shall be appointed subject to the Board's approval, and shall not be removable from office except by the Board or with their sanction. If the duties of the Medical Superintendent permit, he shall be available for consultation as to the treatment of persons

suffering from, or suspected of, Tuberculosis, within the area of the combination, when called upon by any of the Medical Officers of the Combining Authorities, but shall not undertake any other employment or duties without the express consent of the Joint Board, provided that any difference of opinion as to whether his duties so permit shall be determined by the Board.

(2) The Medical Superintendent shall prepare and submit to the Joint Board an Annual Report on the working of the Sanatorium and the results thereof. The said report shall be printed and a copy thereof shall be furnished to the Board and to each of the authorities represented on the Joint Board.

#### *Inspection of Sanatorium.*

Article 8.—The Sanatorium shall at all times be open to inspection by the Members and Officers of the Combining Authorities, and by any of the Board's officials; and the Joint Board shall furnish to the Board such special reports and returns as may be required from time to time.

#### *Liability for Burial of Patients Dying in Sanatorium.*

Article 9.—In the event of any patient dying in the Sanatorium and no friends or relations of the deceased undertake to bury the body, it shall be the duty of the Joint Board to cause the body to be buried, and the expenses so incurred shall be defrayed by the Local Authority of the district from which such patient was sent, as defined by Section 12 of the Public Health (Scotland) Act, 1897. Failing any such Local Authority, the expenses shall be treated as part of the establishment charges aftermentioned.

#### *Basis of Contributions.*

Article 10.—(1) The charges in respect of capital expenditure incurred for the purposes of this Order shall be defrayed by the Combining Authorities in proportion to the mean of the owners' and occupiers' assessable valuation of their respective districts based upon the latest valuation rolls.

(2) The establishment of fixed annual charges, *e.g.* salaries and rations of officials, fire, light, fuel, required by officials, and other establishment charges such as cost of upkeep, repairs, taxes, insurance, &c., and the cost of conveying patients to and from the Sanatorium shall be borne by the Combining Authorities according to assessable valuation as determined for the purpose of sub-head (1) of this Article, and population (according to the latest available census returns) in equal proportions.

(3) The cost incurred for the maintenance in the Sanatorium of patients from the areas under the jurisdiction of the Combining Authorities, including food, fuel, light, clothing, medicines, and extra nurses, shall be borne by the respective Combining Authorities sending the cases for treatment in accordance with a scale to be fixed annually by the Joint Board; and in respect of patients who are sent in from districts outwith the said areas, the said cost shall be charged in accordance with the arrangements made under Article 6 hereof.

#### *Finance: Requisition for Funds.*

Article 11.—(1) The Joint Board shall certify annually, and not later than the 31st July in

each year, to each of the Combining Authorities, the amount, if any, required to be provided by such Authority for the year to the 15th May following in respect of its share (as determined in terms of Article 10 (1) and (2)), of the funds necessary to enable the Joint Board to carry on the business and duties entrusted to them, and each of the said Combining Authorities shall pay to the Joint Board such amount, and failing payment within six weeks from the date of certificate, shall pay interest on said amount at current Bank overdraft rate.

(2) The Joint Board shall have power from time to time to requisition each of the Combining Authorities for such proportion of such amount as the Joint Board may consider necessary to enable them to carry on the business and duties entrusted to them. In determining such proportions, regard shall be had to the terms of Article 10 (1) and (2). Each of the said Combining Authorities shall pay such amount to the Joint Board without delay, and, failing payment within six weeks from the date of requisition, shall pay interest on said amount at current Bank Overdraft rate.

(3) To meet the estimated expenditure for the proportion of the year from the date of this Order to the 15th May following, the Joint Board shall have power to requisition the Combining Authorities in the manner provided in sub-head (2) of this Article, and the terms of that sub-head shall apply to such requisitions.

#### *Accounts and Audits.*

Article 12.—(1) The provisions as to the preparation and Audit of Accounts of County Councils as contained in Sections 68 to 70 of the Local Government (Scotland) Act, 1889, as amended by the Local Government (Scotland) Act, 1908, shall *mutatis mutandis* apply to the preparation and audit of the Accounts of the Joint Board.

(2) The audited accounts shall show the sums payable during the year by each of the Combining Authorities under Article 10 (1) and (2) of this Order. A copy of the audited accounts shall be transmitted to each of the Authorities represented on the Joint Board, and any necessary adjustment in the accounts between the Joint Board and the Combining Authorities shall thereafter be made and intimation of the same transmitted by the Joint Board to these Authorities. A copy of the audited accounts shall also be transmitted to the Board by the Joint Board.

#### *Appeal to Scottish Board of Health.*

Article 13.—In the event of any dispute or difference as to the interpretation or implement of the terms of this Order arising among the Combining Authorities which has not been hereinbefore left to the Board's determination, the same may be submitted to the Board by any one of the Combining Authorities, and their decision shall be final and binding on all parties.

#### *Power to Amend Order.*

Article 14.—This Order may be amended by the Board from time to time as they may deem necessary, after consultation with the Joint Board.

*Date of Order coming into Operation.*

Article 15.—This Order shall come into operation on the date hereof.

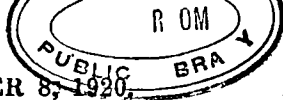
