WHEREAS on the 24th day of April 1893 a Convention with respect to the protection to be given by way of copyright to the authors of literary and artistic works was concluded between Her late Majesty Queen Victoria and His late Majesty the Emperor of Austria, King of Bohemia, and Apostolic King of Hungary, and the ratifications of the said Convention were exchanged on the 14th day of April 1894, between Her late Majesty Queen Victoria and His late Majesty the Emperor:

And whereas by Orders in Council dated the 30th day of April 1894, the 2nd day of February 1895, and the 11th day of May 1895, and made under the authority of the International Copyright Acts, 1844 to 1866, effect was given to the said Convention throughout His Majesty's Dominions, except in the Dominion of Canada, the Cape, New South Wales, and Tasmania:

And whereas by the Copyright Act, 1911, the said International Copyright Acts, 1844 to 1886, were repealed as from the date of the commencement of the said Copyright Act, 1911, in the parts of His Majesty's Dominions to which the said Act extends:

And whereas by the Order in Council dated the 24th day of June 1912 (\*) and made under the authority of the Copyright Act, 1911, the Orders in Council dated the 30th day of April 1894, the 2nd day of February 1895, and the 11th day of May 1895, were revoked as from the date of the commencement of the said Copyright Act, 1911, so far as regards the parts of His Majesty's Dominions to which the said Order applied:

And whereas by reason of the late war between the United Kingdom and Austria, the said Convention and the Order in Council dated the 24th day of June 1912 ceased to have effect:

And whereas by the Trading with the Enemy (Copyright) Act, 1916, it was provided that copyright in all works first published or made in an enemy country during the present war therein referred to, the copyright wherein would had a state of war not existed have vested in any person as the owner thereof by virtue of the application to an enemy country of any

Order in Council made under the Copyright Act, 1911, should be deemed to vest or to have vested in the Public Trustee in his capacity as Custodian under the Trading with the Enemy Amendment Act, 1914:

And whereas by Article 258 of the Treaty of Peace with Austria it is provided that rights of literary and artistic property, as such property is defined in the International Convention referred to therein, shall be re-established or restored in the territories of the High Contracting Parties in favour as the case may be of the persons who were respectively entitled to the benefit of them at the moment when the state of war commenced, or their legal representatives, and that rights which, except for the war, would have been acquired during the war in consequence of the publication of a literary or artistic work shall be recognised and established in favour of those persons who would have been entitled thereto, subject nevertheless to the right thereby reserved) to impose limitations, conditions or restrictions as therein mentioned on rights of literary or artistic property acquired before, during, or after the war, as therein referred to by Austrian nationals (as defined in the said Treaty of Peace):

And whereas by the Treaty of Peace (Austria) Order, 1920 (†) and the Order of the Board of Trade dated the 9th day of November 1920 (‡) effect has been given to the provisions of the Treaty of Peace mentioned in the preceding paragraph of this Order:

And whereas His Majesty, by virtue of the authority conferred on Him by the Copyright Act, 1911, and having regard to the provisions of the Berlin Copyright Convention, was pleased to make an Order in Council, dated the 24th day of June 1912 (hereinafter called the Principal Order (§)), extending the protection of the said Act to certain classes of works to which protection is guaranteed by the said Convention:

And whereas Austria has adhered to the said Convention:

Now, therefore, His Majesty, by and with the advice of His Privy Council, and by virtue of the authority conferred upon Him by the Copyright Act, 1911, is pleased to order, and it is hereby ordered as follows:—

(1) The Principal Order shall extend to Austria as if that country were amongst the foreign countries of the Copyright Union therein named, subject to the following modifications:—

(a) The provisions of Article 2, proviso (iii) (a) shall apply as if Austria were included amongst the foreign countries named in those provisions.

(b) In the application of the provisions of Article 3 of the principal Order to works of which the country of origin is Austria the date of this Order shall be substituted for the commencement of the Act and for the commencement of the principal Order.

(c) In the application to such works of Sections 1 (2) (d) and 19 of the Copyright Act, 1911, the date of this Order shall be substituted for the commencement of the

- (e) In the case of works to which the Treaty of Peace (Austria) Order, 1927, and the Order of the Board of Trade dated the 9th day of November 1920 relate, nothing in this Order shall be construed as removing any limitations, conditions, or restrictions imposed upon such works by the said Orders.
- (2) The Order in Council dated the 24th day of June 1912, extending the protection of the Copyright Act, 1911, to certain classes of works of which the country of origin was Austria-Hungary, which ceased to have effect on the 12th August 1914, is hereby revoked as from that date, so far as regards the parts of His Majesty's Dominions to which the principal Order applies.

And the Lords Commissioners of His Majesty's Treasury are to give the necessary orders accordingly.

WHEREAS His Majesty, by virtue of the authority conferred on Him by the Copyright Act, 1911 (1 & 2 Geo. 5, c. 46), and having regard to the provisions of the Berlin Copyright Convention of 1908, was pleased to make an Order in Council, dated the 24th day of June 1912 (S.R. & O., 1912, No. 913) (hereinafter called the Principal Order), extending the protection of the said Act to certain classes of works to which protection is guaranteed by the said Convention:

And whereas Greece has acceded to the said Convention subject to the reservations mentioned in the Schedule to this Order:

Now, therefore, His Majesty, by and with the advice of His Privy Council, and by virtue of the authority conferred upon him by the Copyright Act, 1911, is pleased to order, and it is hereby ordered, as follows:—

The Principal Order shall extend to Greece as if that country were amongst the Foreign Countries of the Copyright Union therein named, subject to the following modifications:—

(a) The provisions of Article 2, Proviso (iii) (b), Article 2, Proviso (iii) (c), and Article 2, Proviso (iii) (d) of the Principal

Act in Section 19 (7) and 19 (8) wherever (d) In the application to such works of Section 24 of the Copyright Act, 1911, the date of this Order shall be substituted for the commencement of the Act wherever that expression occurs, and the 1st day of October 1920 for the passing of the Act. that expression occurs in Subsection 1, (a) and for the 26th July 1910 in Subsection 1 (b).

- (b) In the application of the provisions of Article 3 of the Principal Order to works of which the country of origin is Greece the date of this Order shall be substituted for the commencement of the Act and for the commencement of the Principal Order.
- (c) In the application to such works of Sections 1 (2) (d) and 19 of the Copyright Act, 1911, the date of this Order shall be substituted for the commencement of the

Act in Sections 19 (7) and 19 (8) wherever that expression occurs, and the 9th day of November 1920 for the passing of the Act.

(d) In the application to such works of Section 24 of the Copyright Act, 1911, the date of this Order shall be substituted for the commencement of the Act wherever that expression occurs in Subsection 1 (a) and for the 26th July 1910 in Subsection 1 (b).

And the Lords Commissioners of the Treasury are to give the necessary orders accordingly.

WHEREAS His Majesty was pleased, in exercise of the powers in that behalf conferred on Him by the Medical Act, 1886, by Order in Council, dated the 7th day of January 1915, to declare that the Second Part of the said Act should be deemed, from the date of the said Order, to apply to the Kingdom of Belgium until it is otherwise ordered:

And whereas the Kingdom of Belgium no longer affords to the medical practitioners of the United Kingdom such privileges of practising in Belgium as were offered during the late War:

Now, therefore, His Majesty doth hereby, by and with the advice of His Privy Council, order that the said Order in Council of the 7th day of January 1915 be, and the same is hereby revoked, without prejudice nevertheless to the right of any person whose names have been already entered on the register.

WHEREAS by Section one of the Midwives Act, 1918, it is provided that the Central Midwives Board may at any time represent to the Privy Council that it is expedient to modify the constitution of the Board in the manner set forth in that Section, and that the Privy Council before considering such representation shall cause it to be laid before both Houses of Parliament, and may thereafter, subject to the provisions of Subsection (3) of the said Section, report to His Majesty that it is expedient to give effect to the representation, and that it shall be lawful for His Majesty by Order in Council to give effect to the same:

And whereas the powers of the Privy Council under the said Act have now been transferred to the Minister of Health:

And whereas the Central Midwives Board have represented to the Minister of Health that it is expedient to modify the constitution of the Board in the manner hereinafter set forth, and the Minister, after causing the said representation to be laid before both Houses of Parliament, has reported to His Majesty that it is expedient to give effect thereto:

Now, therefore, His Majesty, by and with

the advice of His Privy Council, is pleased to order, and it is hereby ordered, as follows:—

- 1.—(1) This Order may be cited as the Central Midwives Board (Constitution) Order, 1920.
- (2) The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
- 2. On and after the first day of April 1921 the Central Midwives Board shall consist of—
  - (1) Four persons to be appointed for terms of three years by the Minister of Health, of whom two shall be certified midwives on the English roll of midwives; and
  - (2) Four registered medical practitioners, to be appointed annually, one by the Royal College of Physicians of London, one by the Royal College of Surgeons of England, one by the Society of Apothecaries, and one by the Incorporated Midwiyes Institute: and
  - the Incorporated Midwives Institute; and
    (3) Two certified midwives on the English
    roll of midwives to be appointed for terms
    of three years by the Incorporated Midwives
    Institute; and
    - (4) One person to be appointed for a term

- of three years by the Queen Victoria's Jubilee Institute for Nurses; and
- (5) One person to be appointed for a term of three years by the Association of County Councils; and
- (6) One person to be appointed for a term of three years by the Association of Municipal Corporations; and
- (7) One person to be appointed for a term of three years by the Society of Medical Officers of Health:

Provided that the members of the Central Midwives Board who are certified midwives on the English roll of midwives shall not at any time exceed five in number.

Any vacancy occurring by resignation or death shall be filled up, in the case of a member appointed under paragraphs (2), (3), (4), (1), (6), and (7), by the body which appointed such person, and, in the case of a member appointed under paragraph (1), by the Minister of Health, and all the members shall, on the termination of the period for which they have been appointed, be eligible for re-appointment for a like period.

Section II.—The Proposed Minimum Rates for Overtime in respect of hours worked by a Female Worker whether engaged on Time-Work or on Piece-Work in excess of the declared normal number of hours, shall be as follows:—

- 1. On any day other than Sundays, Customary
  Public Holidays and Statutory Holidays:—
  - (a) For the first two hours Overtime, Oneand-a-Quarter times the Minimum Rate otherwise applicable, i.e. Timeand-a-Quarter.
  - (b) For Overtime after the first two hours of Overtime, One-and-a-Half times the Minimum Rate otherwise applicable, i.e. Time and a Half.
  - On Sundays, on Customary Public Holidays, and on Statutory Holidays:— For all time worked, twice the Minimum Rate otherwise applicable, i.e. Double-Time.
  - 3. In any week:—For all hours worked in any week in excess of 48, One-and-a-Quarter times the Minimum Rate otherwise applicable, i.e. Time-and-a-Quarter, except in so far as higher Overtime Rates are payable under the provisions of Sub-Sections 1 (b) and 2 of this Section.

4. The Overtime Rates set out in Sub-Sections (1) and (2) of this Section are payable in respect of all hours of Overtime worked on any day, notwithstanding that the number of hours worked in the week does not exceed 48.

Note.—The hours which Female Workers, young persons and children are allowed to work are subject to the provisions of the Factory and Workshop Acts.

#### PART V.

The above proposed respective Minimum Rates of Wages shall, subject to the provisions of the Trade Boards Acts, apply, as specified above, to all Female Workers in Great Britain in respect of any time during which they are employed in the General Waste Branch of the Waste Materials Reclamation Trade, as defined in the Regulations made by the Minister of Labour, dated 27th August 1920, that is to say:—

1. The collecting, sorting, or grading of the following materials:—

Rags, waste paper, paper stock, woollen, worsted, cotton, jute, flax, hemp or other textile waste, textile clippings or cuttings, used bags, sacks, or sacking, scrap rubber, scrap iron, or other scrap metal, fur cuttings, rabbit skins, bones or fat, used tins, broken glass or earthenware.

2. The collecting, sorting or grading of the following articles when collected, sorted or graded in association with or in conjunction with the collecting, sorting or grading of the waste materials specified above:—

Discarded clothing (including head-gear or foot-gear), discarded textile articles, old ropes, used bottles or used jars.

3. The following operations when carried on in association with or in conjunction with the collecting, sorting or grading of any or all of the waste materials specified in 1 above:—

The ripping of worn cloths for rags, the picking of old ropes, the trimming of paper salvage, the washing of used bottles or used jars, the washing of used tins, the breaking up of scrap metal, the drying of rabbit skins, the making or repairing of sacks or bags, the willowing, pulling, scouring, carbonising, or putting down mixings of textile waste.

4. The operations of receiving, packing, compressing, teagling, craning, despatching, or warehousing when carried on in association with or in conjunction with any of the above-mentioned operations.

# But excluding;—

- (a) Any of the above-mentioned operations when carried on in the establishment in which waste materials are produced or in which they are used as raw materials for further manufacture.
- (b) The making or repairing of sacks or bags when carried on in a factory or workshop engaged solely or mainly in the making or repairing of sacks or bags.
- (c) The collecting, sorting, grading or drying of rabbit skins when carried on in an establishment in which such operations are the main or principal business, or when carried on in association with or in conjunction with any business, establishment, branch or department engaged in the manufacture of hatters' furs.
- (d) (i) The collecting, sorting, or grading of cotton waste when carried on in an establishment in which such operations are the main or principal business.
- (ii) Any of the operations included in paragraphs 1, 2, 3 and 4 above (other than the operations specified in paragraph (d) (i) above)

when carried on in or in association with or in conjunction with any establishment of the kind specified in sub-paragraph 1 above.

# PART VI.

GENERAL PROVISIONS:

SECTION I.—The Guaranteed Time-Rates for Piece-Workers set out in Parts I., II., and III. above, are for the purpose of securing to workers employed on Piece-Work a Minimum Rate of remuneration on a Time-Work Basis, and such workers shall be entitled to be paid not less than the Guaranteed Time-Rate applicable to a worker of her age as set out in the before-mentioned Parts of the Schedule, in any case where her earnings on Piece-Work are less than such sum.

SECTION II.—The Piece-Work Basis Time-Rates set out in Parts I., II., and III. above are applicable to the workers specified therein as follows, that is to say, that where a worker is employed upon Piece-Work, each Piece-Rate paid must be such as would yield, in the circumstances of the case, to an ordinary worker not less than the Piece-Work Basis Time-Rate applicable. In determining whether any Piece-Rate satisfies this condition, regard must be had only to the earnings of ordinary workers, i.e., workers of ordinary skill and experience in the class of work in question, and not to the earnings of workers of less than ordinary skill and experience, e.g., learners and infirm workers.

SECTION III.—The proposed Minimum Rates of Wages shall be paid clear of all deductions, other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any superannuation or other provident fund.

SECTION IV.—The above Minimum Rates of.
Wages are without prejudice to workers who
are earning higher rates of wages or to agreements made or that may be made for the
payment of wages in excess of the Minimum
Rates.

The Trade Board will consider any objections to the above Proposals to Fix which may be lodged with them within two months from 4th January 1921. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary, General Waste Materials Reclamation Trade Board (Great Britain), 5 Chancery Lane, London, W.C.2.

It is desirable that the Objections should state precisely, and so far as possible with reasons, what is objected to.

PROPOSAL TO VARY OVERTIME RATES FOR MALE AND FEMALE WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October 1918, the Trade Board established in Great Britain under the Trade Boards Act, 1918, for those Branches of the Trade specified in the Trade Boards (Tobacco) Order, 1919, hereby give Notice as required by Section 3 (5) of the Trade Boards Act, 1918, that they propose to vary (the Minister of Labour having given his consent to such Notice being given) the Overtime Rates at present fixed and set out in the Schedule to their Notice dated 17th July 1920, and effective under the Order of the Minister of Labour dated 14th July 1920, and to declare the Normal Number of Hours of Work in the trade for the purpose of the application of the Overtime Rates, the proposed Overtime Rates and declared Normal Number of Hours of Work in the Trade being as shown in the Schedule set out below.

#### SCHEDULE.

# PART I.

Proposed Overtime Rates for Male and Female Workers (All Ages).

Section I.—In accordance with Section 3 (1) (c) of the Trade Boards Act, 1918, the Trade Board propose to declare the Normal Number of Hours of Work in the trade to be as follows:—

In any week ... ... ... ... ... 48
On any weekday (other than Saturday) 9
On Saturday ... ... ... ... 5

Provided that all hours worked by a worker on Sundays and Customary Public and Statutory Holidays shall be regarded as Overtime to which the Overtime Rates shall apply.

Section II.—In lieu of the Overtime Rates at present fixed and set out in the Trade Board's Notice dated 17th July 1920, and effective under the Order of the Minister of Labour, dated 14th July 1920, the Overtime Rates for Male and Female Workers to apply in substitution for the Minimum Rates which would otherwise be applicable in respect of all hours worked by Male and Female Workers, whether engaged on Timework or on Piece-work, in excess of the declared normal number of hours, shall be as follows:—

(1) For the First Two Hours' Overtime on any day, except Sundays and Customary Public and Statutory Holidays, the Overtime Rate shall be One-and-a-Quarter times the Minimum Rate otherwise applicable, i.e., Time-and-a-Quarter.

plicable, i.e., Time-and-a-Quarter.

(2) For Overtime after the First Two Hours of Overtime on any day, except Sundays and Customary Public and Statutory Holidays, the Overtime Rate shall be One-and-a-Half times the Minimum Rate otherwise applicable, i.e., Time-and-a-Half.

NOTE.—The hours which female workers, young persons and children are allowed to work are subject to the provisions of the Factory and Workshop Acts.

- (3) For all time worked on Sundays and Customary Public and Statutory Holidays the Overtime Rate shall be Twice the Minimum Rate otherwise applicable, *i.e.*, Double Time.
- (4) For all hours worked in any week in excess of 48 the Overtime Rate shall be One-and-a-Quarter times the Minimum Rate otherwise applicable, i.e., Time-and-a-Quarter, except in so far as higher Overtime Rates are payable under the provisions of paragraphs 2 and 3 of this Section.

The Overtime Rate shall be payable where on any day (not being a Sunday or a Customary Public or Statutory Holiday) the number of hours worked exceeds nine, or in the case of Saturday exceeds five, notwithstanding that the number of hours worked in the week does not exceed 48.

Provided that:-

Where it is or may become the established practice of an employer to require attendance only on five days a week, the Overtime Rates shall only be payable on such days after  $9\frac{1}{2}$  hours have been worked.

# PART II.

Section I.—The above proposed Overtime Rates shall apply as provided above and subject to the provisions of the Trade Boards Acts, to all workers in Great Britain who are employed in any branch of the trade specified in the Trade Boards (Tobacco) Order, 1919, that is to say, the manufacture of Tobacco, Cigars, Cigarettes, Cigarette Tubes and Snuff, including all preparatory processes, and including also the operations of storing, and store-keeping, boxing, packeting, labelling, parcelling and despatching and all other warehousing and packing operations incidental to the manufacture of any of the above-mentioned articles.

Section II.—The above proposed Overtime Rates shall be paid clear of all deductions, other than deductions under the vational Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any superannuation or other provident fund.

The Trade Board will consider any Objections to the above Proposal to Vary which may be lodged with them within two months from 5th January 1921. Such Objection should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to The Secretary of the Tobacco Trade Board (Great Britain), 5 Chancery Lane, London, W.C. 2.

Proposal to Vary Minimum Rates of Wages for making certain sizes of Dollied or Tommied Chain and of Hand Hammered Chain (on the Basis of the Lowest Quality).

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October 1918, the Trade Board established in Great Britain under the above Act for the Trade of Hammered and Dollied or Tommied Chain Making hereby give notice that, seeing that the specified period of operation of the Minimum Rates for making certain sizes of Dollied or Tommied Chain and of Hand Hammered Chain set out in the notice issued by the Trade Board on 1st October 1920, will expire on 31st March 1921, they again propose to vary the General Minimum Time-Rates and the General Minimum Piece-Rates set out in the notice, dated 1st March 1918, by providing that the Minimum Rates set out in the said notice dated 1st October 1920 shall be continued in operation after the 31st March 1921, subject to the variation of the General Minimum Piece-Rates for making from Iron of 3/8 in. and 13/32 in. diameter respectively, Dollied or Tommied Short Link Chain, or Short Link Hand Hammered Chain, as follows:

(a) Where the employer provides (in addition to the iron) the workshop where the work is carried on and the tools and the fuel: For 3/8 in., from 22s. 2d. per cwt. to

24s 11d per cwt.

For 13/32 in., from 17s 10d. per cwt. to 20s 1d. per cwt.

(b) Where the worker provides (in respect of iron provided by the employer) the workshop where the work is carried on and the tools and the fuel, or any of these three heads of outlay:—

For 3/8 in., from 29s. 7d. per cwt. to 33s 3d. per cwt.

For 13/32 in., from 23s. 9d. per cwt. to 26s 9d. per cwt.

This proposal is issued with the consent of the Minister of Labour.

The Trade Board will consider any objections to the above proposal to vary, which may be lodged with them within two months from 7th January 1921.
