TENDERS FOR LOANS ON TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England on Friday, the 20th May 1921, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877; the National Debt Act, 1889; and the War Loan Act, 1919, to the amount of £45,000,000, in replacement of Bills falling due.

2. The Bills will be in amounts of £5000 or £10,000. They will be dated at the option of the Tenderer on any date from Monday, the 23rd May 1921, to Saturday, the 28th May inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The person whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than two o'clock (Saturday, twelve o'clock) on the day on which the relative Bills are dated.

7. In virtue of the provisions of Section 26 of the Finance Act, 1915, Members of the House of Commons are not precluded from tendering for these Bills.

8. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

MINING INDUSTRY ACT, 1920. COAL MINES.

ORDER MADE BY THE BOARD FOR MINING EXAMINATIONS, AND APPROVED BY THE BOARD OF TRADE, 12TH MAY 1921, UNDER SECTION 9 (1) OF THE COAL MINES ACT, 1911, VARYING THE ORDER OF 19TH FEBRUARY 1915, FIXING THE TIMES AND PLACES FOR HOLDING EXAMINATIONS.

1. The operation of the Order made by the Board for Mining Examinations and approved by the Secretary of State, dated the 19th February 1915, fixing the times and places for holding Examinations, is hereby suspended so far as it may provide for the holding of an Examination in the last complete week of May 1921.

2. In lieu of the Examination which in pursuance of the provisions of the said Order would have been held on the 25th and 26th May 1921, an Examination shall be held upon a later date to be fixed hereafter by the Board for Mining Examinations, having regard to conditions due to the present State of Emergency.

3. Such later date as aforesaid shall be announced by notice issued by the Board for Mining Examinations, subject to the approval of the Board of Trade.
