TENDERS FOR LOANS ON TREASURY-
BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England, on Friday, the 12th August 1921, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914 to 1919, to the amount of £45,000,000.

2. The Bills will be in amounts of £5000 or £10,000. They will be dated at the option of the Tenderer on any date from Monday, the 15th August, to Saturday, the 20th August, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of cash or a banker's draft on the Bank of England not later than two o'clock (Saturday twelve o'clock) on the day on which the relative Bills are dated.

7. In virtue of the provisions of Section 26 of the Finance Act, 1915, Members of the House of Commons are not precluded from tendering for these Bills.

8. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the consent of the Lords Commissioners of His Majesty's Treasury, viz. :—

REGULATIONS FOR APPOINTMENT AS NATURALIST ON THE SCIENTIFIC STAFF OF THE FISHERY BOARD FOR SCOTLAND.

N.B.—These Regulations are liable to alteration from time to time.

1. Application for appointment must be made to the Secretary of the Fishery Board for Scotland at such time and in such manner as may be fixed by the Fishery Board. When vacancies occur, the Fishery Board will cause notice to be given by advertisement in the Press, which will include a statement of the last day fixed for the receipt of applications.

2. Candidates must be between 22 and 26 years of age on the last day fixed for the receipt of applications. If that date were the twenty-second anniversary of a candidate's birth he would be within the limits of age; if it were the twenty-sixth anniversary he would be beyond them: provided that he may deduct from his actual age any time during which he may have served in His Majesty's Forces between 4th August 1914 and 11th November 1918, inclusive.

3. Candidates must be natural-born British subjects, and the children of fathers also natural-born British subjects, provided that exception to the latter condition may be made in the case of a candidate who served in His Majesty's Armed Forces during the Great War.

4. Candidates must have studied science at a

university and proceeded to a degree. Account will be taken of the ability indicated by the degree and of the suitability of the sciences studied to the work of a naturalist. The most suitable sciences are natural history, biology and chemistry.

5. The completed application forms will be scrutinised by the Fishery Board, and those candidates who appear to satisfy the conditions of these regulations will be interviewed by a Selection Board consisting of representatives of the Fishery Board and a representative of the Civil Service Commission. The Selection Board will prepare a list in order of merit of those candidates whom they consider suitable for appointment.

6. The necessary number of candidates will be appointed as Probationer Naturalists subject to

their satisfying the Civil Service Commissioners that they fulfil all the conditions laid down in these regulations and are eligible in respect of health and character, and to the payment of a fee of £1 10s.

The Probationary period will be two years. If, during that period, a Probationer is found not to be suitable or satisfactory, the appointment may be terminated by three months' notice.

If the service is approved at the termination of the probationary period, a certificate of qualification for the establishment of the Probationer, who will then be required to pay £1 10s., the remaining part of the prescribed fee of £3, will be issued by the Civil Service Commissioners. Pension rights under the Superannuation Acts will then accrue as from the date of the original appointment.

Provided that the certification or registration of a Learner may be cancelled if the

other conditions of Learnership are not complied with.

Provided that an employer may employ a Female Learner on her first employment without a certificate or registration for a probation period not exceeding four weeks, but in the event of such Learner being continued thereafter at her employment, the probation period shall be included in her period of Learnership.

Provided that, notwithstanding compliance with the conditions contained in this section, a person shall not be deemed to be a Learner if she works in a room used for dwelling purposes and is not in the employment of her parent or guardian.

SECTION II.—Definition of "Retail Branch."

The Retail Branch of the Trade is that branch of the Trade referred to in Part IV. of this Schedule, in which it is the usual practice for the employer to supply the garment direct to the wearer.

PART IV.

Applicability of Rates.

The above Minimum Rates of Wages shall apply, subject to the provisions of the Trade Boards Acts, to all Female Workers in Scotland in respect of all time during which they are employed in the Retail Branch of the Trade specified in the Trade Boards (Women's Clothing) Order, 1919, as varied by the Trade Board's (Shirtmaking) Order, 1920, as set out in Part V. of the above-mentioned Notice W.D.S. (2), dated 23rd September 1920.

The General Minimum Time-Rate for Learners under 14 years of age shall be 10s. 6d. per week of 48 hours or 2½d. per hour, and such Learners shall, on reaching the age of 14, be entitled to the amount shown in Column I. above, all employment prior to that age being for this purpose disregarded.

Piece-Work Basis Time-Rates.

- (a) Workers other than Home Workers—at present fixed, 9¾d. per hour ; proposed, 8¾d. per hour.
- (b) Home Workers—at present fixed, 9¾d. per hour ; proposed, 8¾d. per hour.

In the case of all female persons employed on piece-work each piece-rate paid must be such as will yield in the circumstances of the case not less than 8¾d. per hour to an Ordinary worker. In determining whether any piece-rate satisfies this condition, regard must be had only to the earnings of ordinary workers, i.e., workers of ordinary skill and experience in the class of work in question and not to the earnings of workers of less than ordinary skill and experience, e.g., learners and infirm workers.

PART IV.

VARIATION OF OVERTIME RATES FOR MALE AND FEMALE WORKERS.

Overtime Rates calculated on the proposed Minimum Rates of Wages specified in Parts I, II. and III. of this Schedule, in the manner set out in Part III. of the Schedule to the above mentioned

Notice B. (6), shall apply in substitution for the proposed Minimum Rates of Wages set out in Parts I., II. and III. of this Schedule in respect of all hours worked in excess of the number of hours declared by the Trade Board in the Schedule above referred to, to be the normal number of hours of work in the trade.

PART V.

The above Proposed Minimum Rates shall apply subject to the provisions of the Trade Boards Acts, to (a) all Male Workers of the classes specified in Part I. of this Schedule in respect of all time during which they are employed in that Branch of the Box Trade in Great Britain which is engaged in the making of boxes or parts thereof, made wholly or partially of paper, cardboard, chip or similar material: and to

(b) all Female Workers in Great Britain who:—

- (i) Are engaged in manufacturing processes upon boxes or parts thereof made wholly or partially of paper, cardboard, chip or similar material, and, generally, to all workers directly connected with such processes; or
- (ii) Are engaged in transferring material from the store-room to the factory or workshop, and to workers engaged in transferring finished boxes from the factory or workshop to the warehouse, if such workers are also to any considerable extent engaged in connection with the work of distributing the material among, or collection of the finished boxes from, the workers engaged in the processes of box-making.

They shall not apply to Female Workers who:—

- (i) Are wholly or mainly engaged in occupations in a store-room which involve no change in, or treatment of, the material necessary to its being made into boxes; or
- (ii) Are wholly or mainly engaged in a warehouse on occupations directly connected with the storage or despatch of finished boxes which involve no examination or change in the form of such boxes; or
- (iii) Are wholly or mainly engaged in transferring material *in bulk* from the store-room to the factory or workshop; or
- (iv) Are wholly or mainly engaged in transferring finished boxes from the factory or workshop to the warehouse, or from the warehouse for despatch to customers; or
- (v) Wherever employed are engaged as clerks, telephone attendants, and others whose work stands in a relationship to the trade similar to that of such workers.

PART VI.

The above Proposed Minimum Rates of Wages shall be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments or deductions authorised by any Act to be made from wages in respect of contributions to any super-annuation or other provident fund.

The Trade Board will consider any Objections to the above Proposal to Vary which may be lodged with them within two months from 5th August 1921. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address) and should be sent to the Secretary of the Paper Box Trade Board (Great Britain), 7-11 Old Bailey, London, E.C. 4.
