The Civil Service Commissioners hereby give notice that an Open Competitive Examination of candidates for entry as Boy Mechanics in the Royal Air Force will be held at London, Edinburgh, Dublin, Birmingham, Chatham, Plymouth and Portsmouth, on the 25th November 1921.

No person will be admitted to compete from whom the Secretary of the Civil Service Commission has not received, on or before the 13th October, an application, in the handwriting of the candidate, on a prescribed form, which may be obtained from the Secretary at once.

Notice is hereby given that the Scottish Board of Health, in pursuance of the powers competent to them under Sections 32 and 33 of the National Insurance Act, 1913, and of all other powers enabling them in that behalf, have made Regulations dated 22nd July 1921.

These Regulations may be cited as the National Health Insurance (Panel and Pharmaceutical Committees) Regulations (Scotland), 1921, and determine the number of members of the Panel and Pharmaceutical Committees for each area and the quorums thereof, the date on which the members of the existing Committees

shall go out of office, and that the members of the Committees elected under the Regulations shall hold office from the day on which the members of the immediately preceding Committee go out of office until the 31st May of the third calendar year after election and prescribe the procedure to be adopted at the first and subsequent elections of the said Committees.

UNEMPLOYMENT INSURANCE ACT, 1920.

Decisions under Section 10 (1) of the Act.

On the 30th June, the Minister referred to the High Court for decision the question whether two servants who are employed by a firm of Retail Drapers to act—

1. as housemaid in a hostel provided by the firm for their shop assistants to live in;
2. as waitress in the staff restaurant on the firm's business premises, where all the assistants, whether living in or living out, take their dinner and tea,

were or were not employed persons within the meaning of the Act. The Judge decided that the employment of the two servants in question was such an employment as to make them employed persons within the meaning of the said Act.
