The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 5th day of August 1921 (C.W. 11069/21), in the words following, viz. :—

“Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted *inter alia*, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council :

“And whereas Your Majesty was graciously pleased by Your Order in Council bearing date the 7th day of February 1921, to approve of Sub-Lieutenants (including Acting Lieutenants) on the Retired and Emergency Lists of the Royal Navy being eligible, at our discretion, for promotion to the rank of Lieutenant on completion of two years' service after being called out, including service prior to retirement or resignation, or on attaining three years' seniority, whichever is the earlier date.

“And whereas we consider that corresponding provision should be made for the promotion

of Mates or Acting Lieutenants (ex Mates) and Mates (E) or Acting Engineer Lieutenants (ex Mates (E)) on both the Retired and Emergency Lists of the Royal Navy :

“We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council to approve the Regulations contained in the attached Schedule.

“The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals.”

“SCHEDULE.

“ADVANCEMENT OF OFFICERS OF THE ROYAL NAVY ON THE RETIRED AND EMERGENCY LISTS.

“(I.) Mates and Acting Lieutenants (ex Mates) on the Retired or Emergency List to be eligible to be advanced to the rank of Lieutenant (confirmed) as from the dates on which they would have been due normally for that advancement on the Active List (*i.e.*, on attaining seniority as Mate varying between 2 years and 3 years, or somewhat over—according to the results of their examinations, service, &c.) and, in the case of Acting Lieutenants, who have not completed their courses for the rank of Lieutenant with their acting seniority, provided that, to be eligible for promotion before attaining three years' seniority as Mate, Officers must have

(a) served not less than two years as Mate on the Active List.

(b) obtained a Watchkeeping Certificate,  
(c) been recommended for promotion before retirement.

“(II.) Mates (E) on the Retired or Emergency List who were promoted under the normal Regulations to be eligible for promotion to the rank of Engineer Lieutenant as from the dates on which they would have been due normally for that advancement on the Active List (*i.e.*, on attaining between two and three years' seniority as Mate (E), provided that, to be eligible for this promotion before attaining three years' seniority as Mate (E), Officers must have

(a) Served not less than two years as Mate (E) on the Active List,

(b) been recommended for promotion before retirement.

“(III.) Acting Engineer Lieutenants promoted to that rank from Mate (E) under the special War regulations laid down in King's Regulations and Admiralty Instructions, Appendix X., Part V., Section I., and placed on the Retired or Emergency List as Acting Engineer Lieutenants, to be eligible to be confirmed in the rank of Engineer Lieutenant, with their acting seniority, on completing one year's seniority in the rank of Acting Engineer Lieutenant.”

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

“Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council :

“And whereas by His late Majesty's Order in Council bearing date the 28th March 1903, and subsequent Orders in Council, it is provided that certain Commissioned Warrant Officers, now styled Commissioned Officers from Warrant Rank, and Warrant Officers shall be eligible for promotion to the rank or corresponding rank, of Lieutenant as a reward for long and zealous service, and that these Officers should be granted the rank or corresponding rank of Lieutenant-Commander on attaining eight years' seniority in the rank or corresponding rank of Lieutenant :

“And whereas we are of opinion that similar advancement should be open to Commissioned Wardmasters and Warrant Wardmasters, and that the establishment of Commissioned Wardmasters authorised by Your Majesty's Order in Council bearing date the 7th September 1916, should be increased :

“We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction the arrangements shown in the annexed Schedule :

“The Lords Commissioners of Your Majesty's Treasury have signified their concurrence therein.”

“ SCHEDULE.

“ Commissioned Wardmasters to be eligible for promotion to the relative rank of Lieutenant with the title of Wardmaster Lieutenant.

“ Wardmaster Lieutenants on attaining eight years' seniority as such to have the relative rank of Lieutenant-Commander with the title of Wardmaster Lieutenant-Commander.

“ Pay.

“ Pay of Wardmaster Lieutenants and Wardmaster Lieutenant-Commanders to be on the scales authorised for Lieutenants and Lieutenant-Commanders promoted from Warrant Rank (Non-Mechanical Branch).

“ Retired Pay, &c.

“ Retired Pay, Widows' Pensions and Compassionate Allowances for children to be on the scales and payable under the conditions authorised for Lieutenants and Lieutenant-Commanders promoted from Warrant Rank.

“ Numbers.

“ The establishment of Officers of the Sick Berth Branch to be as follows :—

1 Wardmaster Lieutenant.

4 Commissioned Wardmasters.

15 Warrant Wardmasters.

“ The above number of Commissioned Wardmasters to be temporary pending the operation of the rule under which deserving Warrant Officers are promoted to Commissioned Officer from Warrant Rank after ten years' service as Warrant Officer.”

#### TENDERS FOR LOANS ON TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England on Friday, the 26th August 1921, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877; the National Debt Act, 1889; and the War Loan Acts, 1914 to 1919, to the amount of £50,000,000.

2. The Bills will be in amounts of £5000 or £10,000. They will be dated at the option of the Tenderer on any date from Monday, the 29th August to Saturday, the 3rd September inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than two o'clock (Saturday twelve o'clock) on the day on which the relative Bills are dated.

7. In virtue of the provisions of Section 26 of the Finance Act, 1915, Members of the House of Commons are not precluded from tendering for these Bills.

8. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

Whereas the expression "British Patent" when hereinafter used means Letters Patent which have been granted in and for the United Kingdom of Great Britain and Ireland and the Isle of Man :

And whereas prior to the Order of the Board of Trade of the 30th October 1918, hereinafter recited divers British Patents which had been granted to or for the benefit of Hungarian Nationals (as defined by the Treaty of Peace (Hungary) Order, 1921), the shares and interests of Hungarian Nationals in divers other British Patents and also the benefit so far as the same belonged to Hungarian Nationals of or in divers applications which had been made by or on behalf or for the benefit of Hungarian Nationals either alone or jointly with other parties for grants of such patents were by or by virtue of Orders which were made by the High Court of Justice or the Board of Trade under the Trading with the Enemy Acts, 1914-1918, or some or one of such Acts duly vested in the Public Trustee, the Custodian for England and Wales under the Trading with Enemy Amendment Act, 1914 (c) (hereinafter called "the Custodian") :

And whereas by an Order dated the 30th October 1918, and so made by the Board of Trade as aforesaid after reciting that the expression "hostile person" when thereinafter used meant and included (a) a person, firm, body or company being an enemy or enemy subject within the meaning of the Trading with the Enemy Amendment Acts, 1916 and 1918 ; (d) ; (b) a Company with respect to which an Order had been made under Section 1 of the Trading with the Enemy Amendment Act, 1916, or Section 3 of the Trading with the Enemy Amendment Act, 1918, and (c) a Company being an enemy controlled corporation within the meaning of the Trading with the Enemy Amendment Act, 1918, it was amongst other things ordered that (1) all and every the interest share and right of every hostile person in, of, or to any British patent, and (2) the benefit of every application which had been made by, or, on behalf or for the benefit of any hostile person for any British patent should, except in so far as the same should already have been vested by any Order made under the Trading with the Enemy Amendment Acts, or any of them vest in the Custodian :

And whereas as regards certain of the said applications patents have in pursuance of the

Trading with the Enemy Amendment Act, 1916, been duly granted to the Custodian :

And whereas the expression "vested patent" as hereinafter used means such interest, share, rights or title in of or to a British patent as may by reason or on account of the late war between the United Kingdom and Hungary have been so vested in or granted to the Custodian as aforesaid, and the expression "vested application" as hereinafter used means such benefit and rights of or in respect of any application for the grant of a British patent as may by reason or on account of the late war have been so vested in the Custodian as aforesaid :

And whereas it is expedient that such Order or Orders and directions as are hereinafter contained shall be made and given in regard to vested patents and vested applications :

Now, therefore, the Board of Trade in exercise of the powers conferred upon them by Section 5 (1) of the Trading with the Enemy Amendment Act, 1914, and/or the Treaty of Peace (Hungary) Order, 1921, and of all other powers (if any) them hereunto enabling do hereby order and direct as follows :—

1. (i) Subject to the provisions hereinafter contained the Custodian shall forthwith divest himself of the vested patents and of the vested applications in favour, as the case may be, of the respective persons who were at the commencement of the late war between the United Kingdom and Hungary or would but for such war and the relative Vesting Orders now be entitled thereto.

Provided always that if by any Order made under the Trading with the Enemy Amendment Acts or any of them which may affect any vested patent or vested application, any condition was imposed upon the Custodian which might operate so as to prohibit him from dealing with such patent or application the prohibiting condition shall be and stand discharged upon the Board of Trade certifying to that effect but so nevertheless that such divesting as aforesaid shall not take effect as regards such patent or application unless and until the Board of Trade shall so certify :

(ii) In the subsequent provisions of this Order the following expressions shall mean and be construed as follows, that is to say : "restored patent" shall mean and include any vested patent of which the Custodian shall have divested himself under the directions in the preceding sub-clause contained and also such interest, share, rights or title in of or to any British patent as may be or may have been granted upon or in pursuance or by virtue of a restored application : "restored application" shall mean and include any vested application of which the Custodian shall have divested himself as aforesaid and also to the extent to which the same may be or may have been revived as next hereinafter mentioned any application for the grant of a British patent which may be or may have been revived under the provisions of the Treaty of Peace between the United Kingdom and Hungary (hereinafter referred to as the "Treaty of Peace") and any other application by a Hungarian National for the grant of a British patent which when granted will bear date prior to the 26th day of July 1921. "Patentee" shall mean and include the person for the time being entitled to the benefit of a restored patent : "licensee" shall in

relation to a licence mean and include any person for the time being entitled to the benefit of the licence.

2. Subject to the provisions of this Order dealings in regard to a restored patent are permitted between British Nationals and Hungarian Nationals (as respectively defined by the said Treaty of Peace Order).

3. An assignment or assurance *inter vivos* of a restored patent or a restored application shall not be made nor shall any licence be granted under a restored patent except after notice to and with the consent of the Board of Trade and any such purporting assignment or assurance *inter vivos* or any such purporting licence which may be made or granted except after such notice and with such consent shall be void and of no effect. And any devolution of a restored patent or of a restored application otherwise than by an assignment or assurance *inter vivos* shall not be operative unless and until assented to by the Board of Trade.

4. A restored patent shall remain and be subject to any licence under or in respect thereof which may have been granted by the Board of Trade under the Patents, Designs and Trade Marks (Temporary Rules) Acts, 1914, (a) or by the Custodian under Section 5 (1) of the Trading with the Enemy Amendment Act, 1914, and any such licence shall with the additional rights, powers and privileges next hereinafter conferred upon the Licensee be and remain as valid and effectual as if this Order had not been made :

Provided always that in addition to any other rights, privileges or powers to which he may be entitled the Licensee exclusive or otherwise, as the case may be, shall be deemed to have and shall have all the rights, privileges and powers of such a Licensee under the provisions of Section 1 of the Patents and Designs Act, 1919 (b) :

Provided further that all powers which by or under any such licence as aforesaid may have been given to or vested in the Board of Trade or the Custodian shall as regards any powers given to or vested in the Custodian be and be deemed to have been transferred to the Board of Trade and as to all such powers whether given to or vested in the Board of Trade or given to or vested in the Custodian shall be and remain exercisable by the Board of Trade.

5. The Board of Trade have and shall continue to have power upon the application of any person to grant to or in favour of the applicant a compulsory licence under any restored patent upon such terms as to Royalty or otherwise as may be thought fit (a) if in the opinion of the Board of Trade it is in the public interest that such licence shall be granted, or (b) if the Patentee shall refuse to grant to the applicant a licence upon reasonable terms. And for the purpose of and in connection with the exercise of such power the Board of Trade shall have all the powers of the Comptroller of Patents Trade Marks and Designs (hereinafter called the Comptroller) under the Patents and Designs Act, 1919, in a case in which abuse of the monopoly rights has been established.

6. The Board of Trade shall as regards any licence which has been or may be granted under any restored patent whether the licence is granted as mentioned in Clause 4 hereof or as mentioned in Clause 5 hereof, have power upon the application of the Licensee or of the Patentee

to make much revisions or amendments in the licence as may be thought fit whether as regards the Royalty payable thereunder or otherwise, and any such revision or amendment may consist of or include a provision which will preclude the Patentee (a) from importing into the United Kingdom any goods the importation of which would if effected by a person other than the Patentee be an infringement of the patent, and/or (b) from working or using the patented invention in the United Kingdom.

7. Notwithstanding anything herein contained the Board of Trade shall as regards any restored patent or restored application have power either without or upon the application of any person interested to expropriate, take over or sell any such patent or the patent rights under any such application on such terms as to indemnity purchase, consideration or otherwise as may be determined by a special Tribunal to be nominated by the Lord Chancellor for the time being but so that the President or Chairman of such Tribunal shall be a high judicial officer or a barrister of not less than ten years' standing, and in such cases the Board of Trade shall be deemed to have all the powers of the patentee or proprietor and may make a good title to any transfer, licence or other assurance provided always that the power hereby conferred shall not be exercised unless in the opinion of the Board of Trade the exercise thereof is necessary for the National Defence or in the public interest or for securing the due fulfilment of all the obligations undertaken by Hungary in the Treaty of Peace.

8. All Royalties and/or other monies which but for this provision would by virtue of anything done under or in pursuance of any provision contained in this Order be payable to a Hungarian National shall be divided and paid as follows, namely:—

(a) in the case of voluntary dealings—75 per cent. of such Royalties and/or other monies shall be paid to the Administrator under the Treaty of Peace (Hungary) Order, 1921, for the purposes of the Office of such Administrator and the remaining 25 per cent. thereof shall be paid to the other party or parties who may be concerned:

(b) in every other case the whole of such Royalties and/or other monies shall be paid to the Administrator under the Treaty of Peace (Hungary) Order, 1921, for the purposes of the Office of such Administrator.

Provided always that any Royalties under any such licence as is mentioned in Clause 4 hereof which have accrued prior to the date upon which the patent shall have become a restored patent or which may thereafter accrue shall be retained by or paid to the Custodian, as the case may be.

9. The conditions imposed by and other provisions contained in Clauses 3 to 8 of this Order upon or in regard to restored patents and restored applications shall not, except as hereafter mentioned, apply as regards vested patents or vested applications of which the Custodian shall have divested himself under the directions

contained in Clause 1 (1) hereof in favour of persons who, by or by virtue or in pursuance of the Treaty of Peace have ceased to be Hungarian Nationals: Provided nevertheless that as regards such patents as last mentioned:—

(i) The patents shall remain and be subject to any licence under or in respect thereof which may have been granted by the Board of Trade under the Patents, Designs and Trade Marks (Temporary Rules) Acts, 1914, or by the Custodian under Section 5 (1) of the Trading with the Enemy Amendment Act, 1914, and any such licence shall be and remain as valid and effectual as if this Order had not been made.

(ii) The Board of Trade shall as regards any licence which has been granted as aforesaid under the patent have power upon the application of the Licensee or of the patentee to make such revisions or amendments in the Licence as may be thought fit whether as regards the Royalty payable thereunder or otherwise.

10. Any application to be made under any provision herein contained shall be made to the Comptroller.

11. The Board of Trade may from time to time make such rules as may be necessary or expedient for the purpose of carrying out the provisions of this Order, and by any such rules may regulate the procedure to be followed and may prescribe the payment of fees and fix the amount thereof, and any such rules whilst in force shall be of the same effect as if the same were contained in this Order.

12. This Order shall not nor shall anything herein contained apply to any patent or application for the grant of a patent which has been effectually dealt with in or for the purpose of the liquidation of any business or company as regards which a Winding-up Order has been made under or in pursuance of the Trading with the Enemy Acts, 1914 to 1918, or any of them.

13. The Board of Trade may at any time revoke or vary this Order and any provisions herein contained as well as any rules made under Clause 11 hereof.

Whereas the expression "British copyright" when hereinafter used means copyright as defined by the Copyright Act, 1911 (d) and/or Orders in Council thereunder within the United Kingdom of Great Britain and Ireland and the Isle of Man:

And whereas all the interests, rights, titles or shares of Hungarian nationals (as defined by the Treaty of Peace (Hungary) Order, 1921), in, of, or to divers British copyrights were by or by virtue of Orders which were made by the Board of Trade under the Trading with the Enemy Acts, 1914-1918, or some or one of such Acts duly vested in the Public Trustee, the Custodian for England and Wales under the Trading with the Enemy Amendment Act, 1914 (hereinafter called "the Custodian"):

And whereas by the Trading with the Enemy (Copyright) Act, 1916, it was provided that copyright in all works first published or made in an enemy country during the present war therein referred to, the copyright wherein would, had a state of war not existed, have vested in any person as the owner thereof by virtue of the application to an enemy country of any Order in Council made under the Copyright Act, 1911, should be deemed to vest or to have vested in the Custodian.

And whereas the expression "vested copyright" as hereinafter used means such interest, share, rights or title in, of, or to a British copyright as may by reason or on account of the late war between the United Kingdom and Hungary have been so vested in the Custodian as aforesaid:

And whereas by Article 241 of the Treaty of Peace with Hungary (hereinafter referred to as the Treaty of Peace) it is provided that rights of literary and artistic property, as such property is defined by the International Conventions in the Treaty mentioned, shall be re-established or restored in the territories of the High Contracting Parties in favour of the persons who were respectively entitled to the benefit of them at the moment when the state of war commenced, or their legal representatives, and that rights which except for the war would have been acquired during the war in consequence of the publication of a literary or artistic work shall be recognised and established in favour of those persons who would have been entitled thereto, subject nevertheless to the right (thereby reserved) of each of the Allied and Associated Powers to impose limitations, conditions or restrictions as therein mentioned on rights of literary or artistic property acquired before or during or after the war as therein referred to by Hungarian nationals:

And whereas by Article I (XXVI.) of the Treaty of Peace (Hungary Order, 1921, the Board of Trade is empowered to prescribe such limitations, conditions and restrictions on rights of literary or artistic property acquired before

or during the late war by Hungarian nationals as are mentioned in the Treaty of Peace:

And whereas it is expedient that such Order or Orders and Directions as are hereinafter contained shall be made and given in regard to vested copyrights and all other British copyrights re-established or restored by virtue of the Treaty of Peace:

Now, therefore, the Board of Trade, in exercise of the powers conferred upon them by Section 5 (i) of the Trading with the Enemy Amendment Act, 1914, and/or the Treaty of Peace (Hungary) Order, 1921, and of all other powers (if any) them hereunto enabling, do hereby Order and Direct as follows:—

1. (i) Subject to the provisions hereinafter contained the Custodian shall forthwith divest himself of the vested copyrights in favour, as the case may be, of the respective persons who were at the commencement of the late war, or would but for such war and the relative Vesting Orders and or the Trading with the Enemy (Copyright) Act, 1916, now be entitled thereto:

Provided always that if by any Order made under the Trading with the Enemy Amendment Acts or any of them which may affect any vested copyright any condition was imposed upon the Custodian which might operate so as to prohibit him from dealing with such copyright, the prohibiting condition shall be and stand discharged upon the Board of Trade certifying to that effect, but so nevertheless that such divesting as aforesaid shall not take effect as regards such copyrights unless and until the Board of Trade shall so certify.

(ii) In the subsequent provisions of this Order, the following expressions shall mean and be construed as follows, that is to say:—

An assignment or assurance *inter vivos* of a restored copyright shall not be made nor shall any licence be granted under a restored copyright except after notice to and with the consent of the Board of Trade, and any such purporting assignment or assurance *inter vivos* or any such purporting licences which may be made or granted except after such notice and with such consent shall be void and of no effect, and any devolution of a restored copyright otherwise than by an assignment or assurance *inter vivos* shall not be operative unless and until assented to by the Board of Trade:

4. A restored copyright shall remain and be subject to any licence under or in respect thereof



which may have been granted by the Custodian under the Trading with the Enemy Amendment Act, 1914, and any such licence shall with the additional rights, powers and privileges next hereafter conferred upon the Licensee be and remain as valid and effectual as if this Order had not been made.

Provided always that in addition to any other rights, privileges or powers to which he may be entitled any such Licensee as aforesaid shall be entitled to call upon the owner of the copyright to take proceedings to prevent infringement thereof, and if within two months after being so called upon such owner fails to take the required proceedings the Licensee may institute the same in his own name as though he himself were the owner of the copyright, making the actual owner thereof a defendant, but so nevertheless that such Owner when so added as defendant, shall not be liable for any costs unless he enters an appearance and takes part in the proceedings.

Provided further that all powers which by or under any such licence as aforesaid may have been given to or vested in the Board of Trade or the Custodian shall as regards any powers given to or vested in the Custodian be and be deemed to have been transferred to the Board of Trade, and as all such powers whether given to or vested in the Board of Trade or given to or vested in the Custodian shall be and remain exercisable by the Board of Trade.

5. The Board of Trade have and shall continue to have power upon the application of any person to grant to or in favour of the applicant a compulsory licence under any restored copyright upon such terms as to Royalty or otherwise as may be thought fit (a) if in the opinion of the Board of Trade it is in the public interest that such licence shall be granted, or (b) if the owner of the copyright shall have refused to grant to the applicant a licence upon reasonable terms.

6. The Board of Trade shall, as regards any licence which has been or may be granted under any restored copyright whether the licence is granted as mentioned in Clause 4 hereof or as mentioned in Clause 5 hereof, have power upon the application of the Licensee or of the owner of the copyright to make such revisions or amendments in the licence as may be thought fit whether as regards the Royalty payable thereunder or otherwise, and any such revision or amendment may consist of or include a provision which will preclude the owner of the copyright (a) from importing into the United Kingdom any reproductions the importation of which would if effected by a person other than the owner of the copyright be an infringement of the copyright, and/or (b) from exercising the copyright or any part thereof in the United Kingdom.

7. Notwithstanding anything herein contained the Board of Trade shall, as regards any restored copyright, have power either without or upon the application of any person interested to expropriate, take over or sell any such copyright on such terms as to indemnity, purchase consideration, or otherwise as may be determined by a special Tribunal to be nominated by the Lord Chancellor for the time being, but so that the President or Chairman of such Tribunal shall be a high judicial officer or a

barrister of not less than ten years' standing, and in such case the Board of Trade shall be deemed to have all the powers of the owner of the copyright and may make a good title to any transfer licence or other assurance provided always that the power hereby conferred shall not be exercised unless in the opinion of the Board of Trade the exercise thereof is necessary for the National Defence or in the public interest or for securing the due fulfilment of all the obligations undertaken by Hungary in the Treaty of Peace.

8. All Royalties and/or other monies which but for this provision would by virtue of anything done under or in pursuance of any provision contained in this Order be payable to a Hungarian national shall be divided and paid as follows, namely:—

- (a) in the case of voluntary dealings, 75 per cent. of such Royalties and/or other monies shall be paid to the Administrator under the Treaty of Peace (Hungary) Order, 1921, for the purposes of the Office of such Administrator, and the remaining 25 per cent. thereof shall be paid to the other party or parties who may be concerned. Provided always that any Royalties under any such licence as is mentioned in Clause 4 hereof which have accrued prior to the date upon which the British copyright shall have become a restored copyright or which may thereafter accrue shall be retained by or paid to the Custodian, as the case may be.

9. The conditions imposed by and other provisions contained in Clauses 3 to 8 to this Order upon or in regard to restored copyrights shall not, except as hereafter mentioned, apply as regards vested copyrights of which the Custodian shall have divested himself under the directions contained in Clause 1 (i) hereof in favour of persons who by or by virtue or in pursuance of the Treaty of Peace have ceased to be Hungarian nationals.

Provided nevertheless that as regards such copyrights as last mentioned:—

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 31st October 1918, the Trade Board established under the Trade Boards Act, 1918, in Great Britain for the branches of trade specified in the Trade Boards (Brush and Broom) Order, 1919, hereby give notice, as required by Section 3 (5) of the Trade Boards Act, 1918, that they Propose to Vary the General Minimum Time-Rates, Piece-Work Basis Time-Rates and Overtime Rates at present fixed and set out in the Schedule to their Notice, dated 28th May 1920, and effective under Orders of the Minister of Labour dated 29th December 1919, and 26th May 1920, in respect of certain classes of Female Workers, and that they Propose to Fix General Minimum Piece-Rates and Overtime Rates for certain classes of Male and Female Workers, the proposed Minimum rates of wages being as shown in the Schedule set out below.

PART IV.

PROPOSED GENERAL MINIMUM PIECE-RATES FOR MALE PAN HANDS (SETTING ONLY).

PART V.

(10) issued by the Trade Board and dated 28th May 1920, shall apply in substitution for the rates set out in Parts I., II., III. and IV. of this Schedule in respect of all hours worked in excess of the number of hours declared by the Trade Board in the Schedule to their Notice M. (10) dated 28th May 1920, to be the normal number of hours of work in the trade.

PART VI.—DEFINITIONS.

(a) Female Pan Hands.

For the purpose of the application of the minimum rates specified in Parts I., II., III. and V. of this Schedule, a Female Pan Hand shall be defined as a Female Worker of any age who performs the operation of pan-setting with or without the operations of boring and/or trimming.

(b) Female Pan-Setting Learners :—

For the purpose of the application of the Minimum Rates set out in Section II. of Part III. of this Schedule, a pan-setting learner is defined as being a female worker of (any age) who :—

- (a) is employed during the whole of her time in accordance with the provisions of this Schedule under an Agreement for a period of two years in the form prescribed by the Trade Board as set out in Part VII. of this Schedule. Provided that no worker shall be permitted to serve more than one period of two years as a pan-setting learner at the minimum rates fixed by the Trade Board and in accordance with the conditions laid down by the Trade Board from time to time.
- (b) has been registered with the Trade Board in accordance with Rules from time to time laid down by the Trade Board, or has made application for such registration which has been duly acknowledged and is still under consideration.

Provided that :—

- (i) The Registration may be cancelled if the other conditions of learnership are not complied with.
- (ii) An employer may employ a worker at the special rates and under the special conditions for pan-setting learners without registration for a probation period not exceeding four weeks ; but in the event of the worker being continued thereafter at her employment as a pan-setting learner the probation period shall be included in her period of learnership.

PART VII.

FORM OF AGREEMENT PRESCRIBED BY THE TRADE BOARD FOR FEMALE PAN-SETTING LEARNERS.

For the purpose of the application of the Minimum Rates set out in Part III. of this Schedule a female pan-setting learner shall be employed under an agreement in the following form :—

Memorandum of Agreement made this day of \_\_\_\_\_ between \_\_\_\_\_ (hereinafter referred to as " the Employers ") of the one part and \_\_\_\_\_ (hereinafter referred to as " the Learner ") of the other part.

Whereas the Learner is desirous of being trained in the branch of the Brush and Broom Trade known as the operation of " Pan-Setting " and the Employers being engaged in the said trade are willing to give her such training.

Now it is hereby mutually agreed as follows :—

1. The Learner will enter and continue in the service of the Employers and they will receive and retain her in their service as a Learner for the period of two years from the date of this Agreement subject nevertheless to the provisions for earlier determination contained in Clause 5 hereof.
2. During the said term of service the Learner will apply herself diligently to learn the said operation and will faithfully serve the Employers and obey their lawful commands and they on their part will cause her to be well and sufficiently instructed in the said operation.
3. The Employers will pay to the Learner wages in accordance with the current rates of wages applicable to female learners employed as " Pan-Setters " as fixed from time to time by the Brush and Broom Trade Board (Great Britain) subject however to this proviso that if the Learner shall at any time be absent from her duties (whether by reason of sickness or any other cause whatsoever) without the consent of the Employers the Learner shall not be deemed to be employed for the period of such absence and shall not be entitled to any wages for such period. The wages payable to the Learner under this agreement shall be deemed to accrue from hour to hour.
4. Subject to the Provisions of this Agreement the working hours and conditions of the said service shall be those applying to the women operatives at the factory of the Employers for the time being.
5. If the Learner wilfully disobeys any lawful order of the Employers or otherwise wilfully misconducts herself towards the Employers or those in their employment it shall be lawful for the Employers to discharge the Learner from their service and absolutely determine this Agreement.
6. If either of the parties hereto desires for any reason to determine this Agreement before the expiration of the said period of two years or in the event of any dispute arising involving allegations of unsuitability or of failure to apply herself diligently to learn the said operation on the part of the Learner or of failure on the part of the Employers to cause her to be well and sufficiently instructed in the said operation or of wrongful exercise by the Employers of their power to dismiss the Learner under Clause 5 hereof which cannot be settled between the parties hereto the Employers and the Learner hereby mutually agree that the matters in dispute shall stand referred to in the first instance to the Brush and Broom Trade Board (Great Britain) with a view to effecting a settlement thereof.
7. On the due completion of the said term of service this Agreement shall be given by the Employers to the Learner with a Certificate endorsed thereon and signed by or on behalf of the Employers that the said term of service has been duly served.

PART VIII.

SECTION I.—The respective Minimum Rates set out in this Schedule shall apply, subject to the provisions of the Trade Boards Acts, to all workers (including Home-workers) of the classes specified in this Schedule in respect of any time during which they are employed in Great Britain in any branch of the trade specified in the Trade Boards (Brush and Broom) Order, 1919, that is to say, the manufacture of brushes (other than feather brushes) or brooms :

*Including* the following operations, where all or any of them are carried on in association with or in conjunction with the manufacture of such brushes or brooms :—

- (a) The drafting, dressing, or mixing of bass, whisk, or similar fibres, or animal bristles or hair, and the working of wood, bone, ivory, or celluloid ;
- (b) All finishing, warehousing, packing, or other operations incidental to or appertaining to the manufacture of such brushes or brooms ;

*But Excluding* the following operations :—

The sawing and turning of wood as a preliminary operation to the manufacture of such brushes or brooms, the making of metal parts, and the mounting of brushes with metal or tortoiseshell backs.

Provided that nothing in this Schedule shall apply to female apprentices or female learners employed under an Indenture or Written Agreement respectively entered into prior to 31st January 1921, and providing for the proper instruction of the apprentice or learner in the operation or branch of work known as pan-setting.

SECTION II.—The proposed Minimum Rates set out in this Schedule shall be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any superannuation or other provident fund.

SECTION III.—The Proposed Minimum Rates set out in this Schedule are without prejudice to workers who are earning higher rates of wages.

## PART IX.

The Trade Board further give notice that the proposals contained in this Schedule are in substitution for the proposals contained in the Schedule to the Notice M. (21) issued by the Trade Board and dated 10th June 1921, which is hereby withdrawn.

The Trade Board will consider any Objections to the above Proposals which may be lodged with them within two months from 20th August, 1921. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary of the Brush and Broom Trade Board (Great Britain), 7-11 Old Bailey, London, E.C.4. It is desirable that the Objections should state precisely, and so far as possible with reasons, what is objected to.
