TENDERS FOR LOANS ON TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England, on Friday, the 9th September 1921, at 1 o'clock, for Treasury Bills, to be issued under the Treasury Bills Act, 1877; the National Debt Act, 1889, and the War Loan Act, 1919, to the amount of £50,000,000.

2. The Bills will be in amounts of £5000 or £10,000. They will be dated at the option of the Tenderer on any date from Monday, the 12th September, to Saturday, the 17th September, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the

Bank of England.

4. Each Tender must be for an amount not l

less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny), which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than two o'clock (Saturday twelve o'clock) on the day on which the relative Bills are dated.
7. In virtue of the provisions of Section 26

of the Finance Act, 1915, Members of the House of Commons are not precluded from tendering for these Bills.

8. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

The Civil Service Commissioners hereby give notice that the following Regulations have been approved by the Lords Commissioners of His Majesty's Treasury, viz.:—

REGULATIONS RESPECTING OPEN COMPETITIVE EXAMINATIONS FOR SITUATIONS IN THE GENERAL POST OFFICE AS MALE ASSISTANT SUPERINTENDENT OF TRAFFIC (CLASS III.) IN THE LONDON TELEPHONE SERVICE AND MALE ASSISTANT TRAFFIC SUPERINTENDENT (TELEPHONES) IN THE PROVINCES.

N.B.—These Regulations are liable to alteration from time to time.

1. The limits of age for this Examination are 18 and 22. In reckoning age, candidates

who have served in the Navy, Army or Air Force between 4th August 1914 and 11th November 1918, may beduct from their actual age any period of service between 4th August 1914 and 31st December 1919. Candidates must be of the prescribed age on the first day of the Examination.

- 2. A candidate must be a natural-born British subject and the son of a father also a natural-born British subject; provided that exception may be made in the case of candidates serving in a civil situation to which they were admitted with the certificate of the Civil Service Commissioners, and provided that exception as to the father may be made in the case of candidates who served in His Majesty's Armed Forces during the Great War.
- 3. (i) The following persons are ineligible, viz. :-

Members of the Royal Irish Constabulary of less than five years' service.

- (ii) The following classes of persons are eligible under certain conditions only, that is to say :-
 - (a) Persons actually serving in the Army;
 - (b) Persons actually serving in the Navy
 - (c) Persons holding situtations in the Civil Service :
 - (d) Members of the Royal Irish Con-
 - stabulary of more than five years' service;
 (e) Apprentices in His Majesty's Dockyards;
 - (f) Persons who have entered upon or completed a course of education or training for the occupation of teacher, on account of which grants are payable from the Exchequer.

No person actually serving in the Army will be eligible unless he produces to the Civil Service Commissioners, when called upon to do so, the permission of his Commanding Officer to attend the Examination, dated before the commencement of the competition and given in accordance with such orders as may from time to time be issued by or under the authority of the Army

No person actually serving in the Navy will be eligible unless he produces to the Civil Service Commissioners, when called upon to do so, the permission of his Commanding Officer to attend the Examination, dated before the commencement of the competition and given in accordance with such orders as may from time to time be issued by or under the authority of the Lords Commissioners of the Admiralty.

Persons comprised in the classes (c), (d), (e) must obtain the permission of the authorities of their Department to attend the Examination before the commencement of the competition.

Persons comprised in class (f) will not be qualified to receive appointments until the consent of the Board of Education in England, the Committee of Council on Education for Scotland, or the Commissioners of National Education, Ireland, as the case may be, given in conformity with rules sanctioned by the Lords of the Treasury, has been notified to the Civil Service Commissioners.

4. Candidates will be required to satisfy the Civil Service Commissioners that they are duly qualified in respect of health and character.

- 5. The Examination will be in the following subjects, viz. :-
 - 1. English.
 - 2. General Knowledge.
 - 3. Mathematics.
 - 4. Electricity.
 - Telegraphy and Telephony. 5.
 - 6. Personal Qualities.

The Examination may be held in one part or in two parts, at the discretion of the Civil Service Commissioners. In the latter case the first part of the Examination will be used to reduce the number of competitors to be admitted to the second part. Of those who obtain the highest aggregate marks on the first part, a certain number, to be determined by the Civil Service Commissioners, will be admitted to the second part of the Examination. The successful list will consist of those candidates who obtain the highest aggregate marks on the whole Examination.

- 6. Applications for permission to attend an Examination must be made at such time and in such manner as the Civil Service Commissioners may appoint.
- 7. A fee of £3 will be required from every candidate.

The Civil Service Commissioners further give notice, that an Open Competitive Examination will be held in London, Edinburgh, Dublin, Bristol and Leeds under the foregoing Regulations, commencing on the 1st December 1921.

The number of situations to be filled will be the number vacant at the time of declaring the result of the Examination.

No person will be admitted to Examination from whom the Secretary of the Civil Service Commission has not received, on or before the 20th October, an application, in the Candidate's own handwriting, on a prescribed form, which may be obtained from the Secretary at once.
