H IS MAJESTY was this day pleased to declare His Consent to a Contract of Matrimony between His Most Dearly Beloved Daughter Her Royal Highness Princess Victoria Alexandra Alice Mary and Henry George Charles Lascelles, commonly called Viscount Lascelles, which Consent His Majesty has caused to be signified under the Great Seal and to be entered in the Books of the Privy Council.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by Section 91 of the Patent and Designs Act, 1907 (7 Edw. 7, c. 29) as amended by the Patents and Designs Act, 1914 (4 & 5 Geo. 5, c. 18), and the Patents and Designs Act, 1919 (9 & 10 Geo. 5, c. 80), it is

enacted as follows :--

"91. (1) If His Majesty is pleased to make any arrangement with the Government of any Foreign State for mutual protection of inventions, or designs, or trade marks, then any person who has applied for protection for any invention, design or trade mark in that State, or his legal representative or assignee, shall be entitled to a patent for his invention or to registration of his design or trade mark under this Act or the Trade Marks Act, 1905, in priority to other applicants; and the patent or registration shall have the same date as the date of the application in the Foreign State.

" Provided that-

"(a) The application is made in the case of a patent within 12 months, and in the case of a design or trade mark within 4 months, from the application for protection in the Foreign State; and

"(b) Nothing in this Section shall entitle
the patentee or proprietor of the
design or trade mark to recover
damages for infringements happen!
ing prior to the actual date on
which his complete specification is
accepted, or his design or trade
mark is registered, in this country.

"(2) The patent granted for the invention or the registration of a design or trade mark shall not be invalidated:—

"(a) In the case of a patent, by reason only of the publication of a de-

- "(b) In the case of a design, by reason only of the exhibition or use of, or the publication of a description or representation of, the design;
- "(c) In the case of a trade mark, by reason only of the use of the trade mark:

in the United Kingdom or the Isle of Man during the period specified in this Section as that within which the application may be

"(3) The application for the grant of a patent, or the registration of a design, or the registration of a trade mark under this Section, must be made in the same manner as an ordinary application under this Act or the Trade Marks Act, 1905: -

" Provided that-

"(a) In the case of patents the application shall be accompanied by a complete specification, which, if it is not accepted within the 12 months from the application for protection in the Foreign State, shall with the drawings (if any) be open to public inspection at the expiration of that period; and

"(b) In the case of trade marks, any trade mark the registration of which has been duly applied for in the country of origin may be registered under the Trade Marks

Act, 1905.

"(4) The provisions of this Section shall apply only in the case of those Foreign States with respect to which His Majesty by Order in Council declares them to be applicable, and so long only in the case of each State as the Order in Council continues in force with

respect to that State.
"(5) Where it is made to appear to His Majesty that the Legislature of any British Possession has made satisfactory provision for the protection of inventions, designs, or trade marks, patented or registered in this country, it shall be lawful for His Majesty, by Order in Council, to apply the provisions of this Section to that Possession, with such variations or additions, if any, as may be stated in the Order."

And whereas by Section 103 of the Patents, Designs, and Trade Marks Act, 1883, as amended by Section 6 of the Patents, Designs, and Trade Marks Act (Amendment) Act, 1885, and by Section 1 of the Patents Act, 1901, and since repealed by Section 98 of the said Patents and Designs Act, 1907, provisions were made to the same or like effect as those above set forth as contained in Section 91 of the last-mentioned Act, and by the said Section 98 it was provided that "this repeal shall not affect any Convention, Order in Council, Rule, or Table of Fees having effect under any enactment so repealed, but any such Convention, Order in Council, Rules, or Table of Fees in force at the commencement of this Act shall continue in force, and may be repealed, altered or amended, as if it had been made under this Act ":

And whereas it pleased Her late Majesty Queen Victoria to make an arrangement of the

And whereas by a Convention signed at Washington on the 2nd June 1911, His Majesty and the Heads of the Foreign States named therein agreed to make certain modifications in and additions to the said Convention dated 20th March 1883, as revised at Brussels on the 14th December 1900, the ratification of which Convention was duly effected by Great Britain and certain other States:

And whereas by various Orders in Council Her late Majesty Queen Victoria and His late Majesty King Edward VII. and His present Majesty have been pleased to declare that the hereinbefore mentioned provisions of the said Patents, Designs, and Trade Marks Act, 1883 (as amended), should apply to the several Foreign Countries named in the said Orders parties to the said Convention and Protocol:

And whereas the Free City of Danzig has acceded to the said International Convention, Protocol and Additional Act as revised at

Washington on 2nd June 1911:

Now, therefore, His Majesty, in pursuance of the powers in Him vested by the above-recited provisions, and by and with the advice of His Privy Council, doth declare, and it is hereby declared, as follows:

1. The provisions of Section 91 of the Patents and Designs Act, 1907 as amended by the Patents and Designs Act, 1914, and the Patents and Designs Act, 1919, shall apply to the Free City of Danzig.

2. This Order shall take effect from the 21st

For most conspicuous bravery and devotion to duty on the 10th April 1921, near Haidari Kach (Waziristan). When the convoy protection troops were attacked, this Sepoy was No. 1 of a Lewis Gun Section. Early in the action he received a very severe gunshot wound in the che t, and fell be ide his Lewis gun. Hand to-hand fighting having commenced, the Brit'sh officer, Indian officer, and all the Hwldns of his company were either killed or wound d, and his Lewis gun was seized by the enemy.

Cill g up two other men, he got up, charge til enemy, recovered the Lewigun, and, allo ghe ble ding profuctly, again got the gun into a ion.

When I's I madar arrived he took the gun from Spy I har Sinh and odd red him to go back and lave Is wound des d. Instead of dig this the Spoy want to the milital officer and was of galas' ance in pining out wire the word I were, and in carying walr to them. He mide innumerable jurnys to he were and back for this purpose. On one occasion when the enemy fire wis very heavy, he took the rifle of a wounded man and helped to keep down the fire. On ano her of a ion he stood in front of the mideal officer who was dresing a wounded man, thus shilling him with his body. It was over three hours before he finally submitted to be evacuated, bing then too weak from loss of blood to object.

His gallantry and devotion to duty were beyond praise. His conduct inspired all who saw him.

TENDERS FOR LOANS ON TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England on Friday, the 2nd December 1921, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877; the National Debt Act, 1889; and the War Loan Acts, 1914 to 1919, to the amount of £50,000,000.

2. The Bills will be in amounts of £5000 or £10,000. They will be dated at the option of

the Tenderer on any date from Monday, the 5th December, to Saturday, the 10th December inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the

Bank of England.

- 4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than two o'clock (Saturday twelve o'clock) on the day on which the relative Bills are dated.

7. In virtue of the provisions of Section 26 of the Finance Act, 1915, Members of the House of Commons are not precluded from tendering

for these Bills.

8. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

UNEMPLOYMENT INSURANCE ACTS. 1920-1921.

DECISIONS OF THE HIGH COURT ON REFERENCES MADE UNDER SECTION 10 (1) OF THE 1920 Act.

Contributions not Payable.

On the 22nd November the Minister referred to the High Court for decision the questions whether persons employed as-

- 1. Porter, to clean a hospital, deliver messages and to answer calls;
 - 2. River-keeper on a private estate;
- 3. Attendant at a museum to open and close the galleries, and to dust and keep tidy the objects exhibited;
 4. Trainer of greyhounds, by the owner
- of a private kennel of greyhounds;
 - 5. Game-keeper on a private estate;
- 6. Huntsman, first whip, second whip and stableman, and kennelman, all employed by the Master of a Hunt on behalf of the Hunt Committee;
- 7. Porter, to take charge of the entrance lodge at a Hospital and to record the names of all visitors to the patients;
- 8. Stores porter at a Hospital, to supervise the issue and receipt of all stores and the cutting up of all meat;
- 9. Stoker in an engine house, by the Governors of a college, to provide hot water, lighting and heating for the residential build, ings;

10. Dairymaid on the home farm of a large private estate;

11. Green-keeper of a members' golf club; were or were not employed persons within the meaning of the Act of 1920.

The Judge held that the first nine persons employed as indicated above were excepted from liability to insurance as being employed in domestic service within the meaning of paragraph (b) of Part II. of the First Schedule to the Act of 1920, and that the employment of the green-keeper was excepted as being employment in horticulture within the meaning of paragraph (a) of Part II. of the First Schedule to the Act of 1920. The employment of the dairymaid was held by the Judge to be employment in domestic service and in agriculture and therefore excepted under both paragraphs (a) and (b) referred to above.

Consequently no contributions under the Act are payable in respect of any of the persons so employed.

Contributions Payable.

On the same date the Minister also referred for decision the question whether persons employed as—

12. Driver of a motor lorry, by a farmer and market gardener, to carry vegetables from the market garden to stalls and to convey town manure to the farm and market gardens on the return journey;

13. Private secretary, by the owner of a

large private estate;

14. Painter, by a college, in the upkeep and repair of the inside and outside of the residential buildings;

15. Cobbler, by the Governors of an Orphan Home and School, to repair the boots of the boy and girl inmates,

were or were not employed persons within the meaning of the Act of 1920.

The Judge held that the employment of the motor lorry driver was not employment in agriculture, and was therefore not excepted under paragraph (a) of Part II. of the First Schedule to the Act of 1920; and that the employment of the secretary, painter, and cobbler was not employment in domestic service, and was therefore not excepted under paragraph (b) of Part II. of the First Schedule to the Act of 1920.

Consequently contributions under the Act are payable in respect of the persons so employed.
