5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than two o'clock (Saturday twelve o'clock) on the day on which the relative Bills are dated.

7. In virtue of the provisions of Section 26 of the Finance Act, 1915, Members of the House of Commons are not precluded from tendering for these Bills.

8. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

The weekly Rates set out in this Section are based on a week of 48 hours and are subject to a proportionate adjustment according as the number of hours of employment in any week is less than 48.

PART III.

PIECE-WORK BASIS TIME-RATES FOR MALE AND FEMALE WORKERS.

The Piece-Work Basis Time-Rate for each of the classes of workers specified in Parts I. and II. of this Schedule shall be 10 per cent. above the appropriate General Minimum Time-Rate set out therein.

In the case of all workers employed on piece-work, each piece-rate paid shall be such as would yield, in the circumstances of the case, to an ordinary worker (*i.e.*, a worker of ordinary skill and experience in the class of work in question) not less than the Piece-Work Basis Time-Rate applicable.

PART IV.

OVERTIME RATES-MALE AND FEMALE WORKERS (ALL AGES).

SECTION I.—In accordance with Section 3 (1) (c) of the Trade Boards Act, 1918, the Trade Board have declared the normal number of hours of work in any week to be 48.

Provided that all hours worked on Sundays and the holidays as defined hereafter shall be regarded as Overtime to which Overtime Rates shall apply.

SECTION II.—The Minimum Rates for Overtime to apply in respect of hours worked by a worker in excess of the declared normal number of hours of work in the trade shall be as follows, clear of all deductions :—

(a) Workers employed on Time-Work.

- (1) For the first ten hours' Overtime in any week the Overtime Rate shall be one-and-a quarter times the General Minimum Time-Rate otherwise applicable, *i.e.*, TIME-AND-A-QUARTER.
- (2) For Overtime after the first ten hours of Overtime in any week the Overtime Rate shall be one-and-a-half times the General Minimum Time-Rate otherwise applicable, *i.e.*, TIME-AND-A-HALF.

Provided that for all time worked on Sundays, on Christmas Day as respects England and Wales, on New Year's Day as respects Scotland, and on Statutory Bank Holidays (but not including Good Friday when Easter Monday is not worked, and not including Easter Monday when Good Friday is not worked) the Overtime Rate shall be twice the General Minimum Time-Rate otherwise applicable, *i.e.*, DOUBLE-TIME.

(b) Workers employed on Piece-Work.

- Workers employed on piece-work shall receive in respect of each hour of Overtime worked piece-rates each of which would yield, in the circumstances of the case to an ordinary worker at least the equivalent of the appropriate Piece-Work Basis Time-Rate, with the addition of :---
 - (1) as respects each of the first ten hours of Overtime in any week, a sum equivalent to one-quarter of the General Minimum Time-Rate which would be applicable if the worker were employed on time-work;
 - (2) as respects each hour in excess of ten hours of Overtime in any week, a sum equivalent to one-half of the General Minimum Time-Rate which would be applicable if the worker were employed on time-work;
 - (3) as respects each hour of employment on Sundays, on Christmas Day as respects England and Wales, on New Year's Day as respects Scotland, and on Statutory Bank Holidays (but not including Good Friday when Easter Monday is not worked, and not including Easter Monday when Good Friday is not worked) a sum equivalent to the General Minimum

Time-Rate which would be applicable if the worker were employed on time-work.

NOTE.—The hours which female workers, young persons and children are allowed to work are subject to the provisions of the Factory and Workshop Acts and of the Employment of Women, Young Persons and Children Act, 1920.

PART V.

SECTION I.-Subject to the provisions of the Trade Boards Acts the respective Minimum Rates of Wages set out in this Schedule apply to all male and female workers in respect of all time during which they are employed in Great Britain in any branch of the trade specified in the Regulations made by the Minister of Labour, dated 20th October 1919, and as set out below :-The trade as specified in the above-mentioned Regulations is as follows :-

SECTION II.—The manufacture wherever carried on of Perambulators, Invalid Carriages (including Spinal Carriages), or Folding Push Cars :

including :

- (a) the manufacture of fittings or accessories where made in association with or in conjunction with perambulators, invalid carriages, folding push cars or wheels intended for use on these articles;
- (b) the manufacture of wheels, excluding cycle wheels, intended for use on perambulators, invalid carriages or folding push cars; (c) the manufacture of motor cycle side car bodies where made in association with or in
- conjunction with perambulators, invalid carriages or folding push cars;
- (d) the repair of perambulators, invalid carriages or folding push cars when carried on in association with or in conjunction with the manufacture thereof;
- (e) the manufacture of toy perambulators, toy wheel barrows, toy scooters, nursery yachts, toy cycles, toy carts, toy horses, dolls' houses or other similar toys, when carried on as a subsidiary branch of work in association with or in conjunction with the manufacture of perambulators, invalid carriages or folding push cars, so as to form a common or interchangeable form of employment for the workers;
- (f) packing, warehousing, or despatching, or other similar operations incidental to the manufacture of any of the above-named articles;

but excluding :

 \cdots (g) the manufacture of motor scooters;

(h) the manufacture of wicker or cane bodies for perambulators, invalid carriages or folding push cars, when such manufacture is carried on in association with or in conjunction with the manufacture of other wicker or cane articles so as to form a common or interchangeable form of employment for the workers.

PART VI.

SECTION I.-The above Minimum Rates of Wages are to be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any Superannuation or other Provident Fund.

SECTION II .-- The above Minimum Rates of Wages are without prejudice to workers who are earning higher rates of wages or to agreements made or that may be made between employers and workers for the payment of wages in excess of the Minimum Rates.

SECTION I.—In accordance with Section 3 (1) (c) of the Trade Boards Act, 1918, the Trade Board hereby declare the Normal Number of Hours of Work in the Trade to be as follows :—

Provided that all hours worked by a worker on Sunday and on Customary Public and Statutory Holidays shall be regarded as Overtime to which the Overtime Rates shall apply.

SECTION II.—The Minimum Rates for Overtime in respect of hours worked by a worker in excess of the declared normal number of hours of work shall be as follows :—

(A) For Workers Employed on Time-Work :

- (1) For the first two hours of Overtime on any day, except Sunday and Customary Public and Statutory Holidays, the Overtime Rate shall be One-and-a-Quarter times the General Minimum Time-Rate otherwise applicable, *i.e.*, Time-and-a-Quarter.
 - 2

Per hour.

- (2) For Overtime after the first two hours of Overtime on any day, except Sunday and Customary Public and Statutory Holidays, the Overtime Rate shall be One-and-a-Half times the General Minimum Time-Rate otherwise applicable, *i.e.*, Time-and-a-Half.
- (3) For all time worked on Sunday and Customary Public and Statutory Holidays, the Overtime Rate shall be Twice the General Minimum Time-Rate otherwise applicable, *i.e.*, Double-Time.
- (4) For all hours worked in any week in excess of 48 the Overtime Rate shall be One-and-a-Quarter times the General Minimum Time-Rate otherwise applicable, *i.e.*, Time-and-a-Quarter, except in so far as higher Overtime Rates are payable under the provisions of paragraphs (2) and (3) of Sub-Section (A) of this Section.

The Overtime Rates shall be payable where on any day (not being a Sunday or a Customary Public or Statutory Holiday) the number of hours worked exceeds nine, or, in the case of Saturday, exceeds five, notwithstanding that the number of hours worked in the week does not exceed 48.

Provided that where it is or may become the established practice of an employer to require attendance only on five days a week, the Overtime Rates shall only be payable on such days after $9\frac{1}{2}$ hours have been worked.

(B) For Workers Employed on Piece-Work :

Workers employed on Piece-Work shall receive in respect of each hour of Overtime worked, in addition to Piece-Rates, each of which would yield, in the circumstances of the case, to an Ordinary Worker, not less than the Piece-Work Basis Time-Rate applicable, a sum equivalent to One-Quarter of the appropriate Piece-Work Basis Time-Rate, One-Half of the appropriate Piece-Work Basis Time-Rate or the appropriate Piece-Work Basis Time-Rate, according as the Overtime Rate which would have been payable under the provisions of Sub-Section (A) of this Section if the worker had been employed on Time-Work were Time-and-a-Quarter, Time-and-a-Half or Double-Time, respectively.

NOTE.—The hours which Female Workers, Young Persons and Children are allowed to work are subject to the provisions of the Factory and Workshop Acts and to the Employment of Women, Young Persons and Children Act, 1920.

PART IV.

SECTION I.—Subject to the provisions of the Trade Boards Acts, the respective Minimum Rates of Wages set out in this Schedule shall apply to all Female and Male Workers in Great Britain in respect of all time during which they are employed in any branch of the Trade specified in the Trade Boards (Made-Up Textiles) Order, 1920, and set out in Section II. below.

SECTION II.—The Made-Up Textiles Trade as specified in the Trade Boards (Made-Up Textiles) Order, 1920, is as follows :—

- (1) The making from woven fabrics of any of the following articles, or the repairing thereof : tarpaulins; tents; marquees; rick, cart or wagon covers; nose-bags; oil-skin clothing or headgear or linings therefor; flags made of more than one piece; baths, basins, buckets, beds, cots, hammocks, ground-sheets or similar articles; girths and articles known in the trade as horse-clothing.
- (2) The making of any of the following articles from fabrics of the kind specified in paragraph I. above, or the repairing thereof, when carried on in association with or in conjunction with the making or repairing of any of the articles mentioned in the said paragraph :---

rope-bound coal and coke sacks; haversacks or knapsacks; outside and inside blinds or awnings; flags made of one piece; bunting decorations;

including :---

- (A) The following operations when carried on in association with or in conjunction with the operations specified in paragraphs 1 and 2 above, viz., operations known in the trade as—
 - (i) the dyeing, oiling, tarring, chemically treating, or otherwise proofing of the fabrics mentioned in paragraph 1 and the preparation of dressings therefor ;
 - (ii) cutting, sewing, finishing, stencilling or branding by hand or machine;
- (B) The following or similar operations performed by hand or machine when incidental to and carried on in association with or in conjunction with the operations specified in paragraphs 1 and 2 above :—
 - (i) the splicing or braiding of rope, cord or twine;
 - (ii) the making of fittings of leather or webbing, including the assembling of metal or other parts;
 - - (b) leather, webbing or metal or fittings made thereof;
- (C) the warehousing of, the packing of, and similar operations in regard to any of the articles mentioned in paragraphs 1 and 2 above, when carried on in association with or in conjunction with the operations specified in the said paragraphs;
- (D) the warehousing of, the packing of, and similar operations in regard to any other articles when carried on in or in association with or in conjunction with any business, establishment,

branch or department mainly engaged in any of the operations mentioned in sub-paragraph (C) above;

but excluding :-

- (i) the making of haversacks and knapsacks when made in association with or in conjunction with the making of and as part of military web equipment;
- (ii) The making of folding or deck chairs ;
- (iii) The making or repairing of horse-clothing, girths and nose-bags when carried on in association with or in conjunction with the making or repairing of leather saddlery or harness ;
- (iv) the making or repairing of rubberised articles;
- (v) the making or repairing of tarpaulins or of rope-bound coal and coke sacks in an establishment, business, branch or department in which the making of sails is the main or principal business of the establishment, business, branch or department;
- (vi) the printing by hand or machine of flags or parts thereof; (vii) the operations mentioned in sub-paragraph (C) above, when carried on in or in association with or in conjunction with any business, establishment, branch or department mainly engaged in the warehousing of, the packing of, and similar operations in regard to corn sacks, flour sacks, coal sacks, sugar sacks, cement bags, sand bags, nail bags, potato bags, seed bags, and similar sacks or bags;
- (viii) operations performed by workers directly employed by railway companies;
- (ix) operations included in the Trade Boards (Hat, Cap and Millinery) Order, 1919;
- (x) operations included in the Trade Boards (Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods) Order, 1920;
- (xi) operations included in the Trade Boards (Rope, Twine and Net) Order, 1919, but not specifically mentioned in this Order.

PART V.

SECTION I.-The above Minimum Rates of Wages shall be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments or deductions authorised by any Act to be made from wages in respect of contributions to any Superannuation or other Provident Fund.

SECTION II.-The above Minimum Rates of Wages are without prejudice to workers who are earning higher rates of wages, or to agreements made, or that may be made, between employers and workers for the payment of wages in excess of these Minimum Rates of Wages.
