The KING's Most Excellent Majesty in Council.

HEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 7th day of February 1922 (GH), in the words following, viz.:—

"Whereas by Section 20 of the Greenwich Hospital Act, 1865, it is enacted, inter alia, that the Admiralty shall from time to time continue or appoint such Officers, Clerks, and Servants for the purposes of the Hospital and Schools as seem fit, and may (subject to the approval of Your Majesty in Council) fix the salaries of such Officers and Clerks:

"And whereas by Section 8 of the Greenwich Hospital Act, 1872, it is enacted that the provisions of Section 20 of the Greenwich Hospital Act, 1865, so far as the same relate to salaries, shall extend to pensions and pecuniary benefits of any kind:

"And whereas Mr. L. Stacey, Assistant to the Clerk in Charge of the Greenwich Hospital Department of the Admiralty, retired on the 8th January 1922 from the service of Greenwich Hospital on account of age:

"We her leave handle."

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to authorise the grant from the funds of Greenwich Hospital to Mr. Stacey of a pension at the rate of Three hundred and sixty-six pounds, four shillings and ten pence (£366, 4s. 10d.) a year as from the date of his retirement, and a gratuity of One thousand one hundred and forty-six pounds, four shillings and four pence (£1146, 4s. 4d.):

"And whereas by an Order in Council of His late Majesty, dated the 28th July 1906, it is provided, inter alia, that the appointment of the Receiver and Agent for the Greenwich Estate will not confer any claim to pension or gratuity:

"And whereas we are now of opinion that such appointment should be regarded as a pensionable one under conditions similar to those laid down by the Superannuation Act, 1909.:

"And whereas Captain W. Warburton, R.E., a former Receiver and Agent for the Greenwich Estate, retired on the 15th August 1921 from the service of Greenwich Hospital on account of age:

Your Majesty may be graciously pleased, by Your Order in Council, to authorise the grant to Captain Warburton from the funds of Greenwich Hospital of a pension at the rate of One hundred and fifteen pounds, eight shillings and two pence (£115, 8s. 2d.) a year as from the date of his retirement, and a gratuity of Three hundred and thirteen pounds, eighteen shillings and three pence (£313, 18s. 3d.):"

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

(a) that, under the law in force in any of His Majesty's possessions, excess profits duty is chargeable in respect of any profits in respect of which excess profits duty is also payable in the United Kingdom; and

(b) that arrangements have been made with the Government of any such possession whereby, in respect of any profits, only the duty which is higher in amount is to be payable, and the amount of such duty is to be apportioned between the respective Exchequers in proportion to the amount of duty which would otherwise have been payable in the United Kingdom, and in that possession respectively.

And whereas by virtue of the provisions of the Tax Ordinance, 1918, of the Colony of British Guiana and of the Tax on Excess Profits Ordinance, 1918, of the said Colony, it was provided that there should be levied, collected and paid in respect of the profits for any accounting period as therein described ending within or on the 31st December of the year 1917 of the businesses therein mentioned a tax therein described as Excess Profits Tax of ten per cent. on all profits earned in the said Colony in excess of ten per cent. on the capital employed in earning such profits or in the case of certain businesses therein mentioned or two per cent. on the amount of the sales purchases and commissions of such businesses:

And whereas by virtue of the provisions of the Tax Ordinance, 1919, of the said Colony and of the Tax on Excess Profits Ordinance, 1919, of the said Colony it was provided that there should be levied collected and paid in respect of the profits for any accounting period as therein described ending within or on the 31st December of the year 1918 of the businesses therein mentioned, a tax therein referred to as Excess Profits Tax at the rates therein prescribed on all profits earned in the said Colony of the above Act, entitled the Government

And whereas British Guiana is one of His

Majesty's possessions:

Now, therefore, His Majesty, by virtue and in exercise of the powers in this behalf by the Finance Act, 1917, or otherwise in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered and declared, that under the law in force in the Colony of British Guiana excess profits duty was chargeable for any accounting period which ended within the years 1917, 1918, 1919, and 1920, or which ended on the 31st day of December 1917, 1918, 1919, and 1920, in respect of profits in respect of which excess profits duty was also payable in the United Kingdom, and that arrangements have been made with the Government of British Guiana whereby in respect of any such profits only the duty which is higher in amount is to be payable and that the amount of such duty is to be apportioned between the respective Exchequers in proportion to the amount of duty which would otherwise have been payable in the United Kingdom and in the Colony of British Guiana respectively.

And the Right Honourable Winston Spencer Churchill, His Majesty's Principal Secretary of State for the Colonies, is to give the necessary directions herein accordingly.

#### PRESENT,

HEREAS by treaty, grant, usage, sufferance or other lawful means, His Majesty The King has jurisdiction in Abyssinia:

Now, therefore, His Majesty, by virtue and in exercise of the powers in this behalf by the Foreign Jurisdiction Act, 1890, or otherwise in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:

- 1. This Order may be cited as "The Abyssinia (Amendment) Order in Council, 1921," and shall be read as one with the Abyssinia Order in Council, 1913, hereinafter called "the Principal Order.
- 2. The following provisions are substituted for articles 131 to 142 inclusive of the Principal
  - (1) A register of British subjects shall be kept in the office of every Consulate in Abys-
  - (2) Every. British subject resident Abyssinia shall, in the month of January of each year, be registered at the Consulate of the Consular District within which he resides, provided that if some other Consulate is more easy of access, he may, with the assent of the Consular Officer, be registered there. A British subject arriving in Abyssinia must apply for registration within one month after his arrival; provided that a person who fails to apply for or to obtain registration within the time limited by this article may be registered at any time if he excuses his failure to the satisfaction of the Consular Officer.

(3) Where a person is in possession of a valid British passport, the Consular Officer shall, on the first registration of any such person,

than that provided for in sub-article (6) hereunder a certificate of registration in such form as may be prescribed by the Secretary of State. Where any such person applies for the renewal of the registration and produces his passport, the renewal of the registration shall without further fee than that provided for in sub-article (6) hereunder be endorsed thereon.

(4) Every person who has not previously been registered applying to be registered under this Order shall, unless excused by the Consular Officer, attend personally for that purpose at the Consulate, but any person applying for the renewal of his registration need not attend personally unless directed by the Consular Officer so to do, provided that the registration of the wife or wives of a man who is registered under this Order may, if living with him, be effected without their personal attendance being required, and provided also that the registration of minors being his relatives in whatever degree, living with the head of a family who is registered under this Order, may be effected without their personal attendance being required.

(5) A person registered in any register of British subjects established in Abyssinia previously to the making of this Order shall be registered under the provisions of this Order, unless the Consular Officer is satisfied after inquiry that the previous registration was erroneous or that such person is not entitled to registration under the provisions of this

Order.

(6) Every person shall, on every registration of himself, and on every renewal of the registration, pay a fee of two shillings and sixpence, or such other fee as the Secretary of State from time to time appoints. The amount of the fee may be uniform for all persons, or may vary according to the position and circumstances of different classes, if the Secretary of State from time to time so directs, but may not in any case exceed five

shillings.

(7) Where any person applies to be registed. The shall be entitled, without a fee, to the assistance of the Consular Officer in the preparation of any affidavit that may be

required.

(8) The Consular Officer may require the production of such evidence that an applicant for registration is entitled to the status of a British subject as he may see fit, but subject to such directions as may be issued by

the Secretary of State.

- (9) If any British subject neglects to obtain registration under the provisions of this Order, he shall not be entitled to be recognised or protected as a British subject in Abyssinia, and shall be liable to a fine not exceeding two pounds for each instance of such failure, but he shall, although not registered, be subject to the jurisdiction of His Majesty's Courts in Abyssinia.
- 3. From and after the commencement of this Order, articles 131 to 142 inclusive of the Principal Order are hereby repealed, but such repeal shall not prejudice any rights, obligations or liabilities accrued thereunder.
- 4.—(1) This Order shall take effect as soon as it is first exhibited in the public office of the endorse on the passport without further fee Court of the Consul General, and that date is

in this Order referred to as the commencement of the Order.

- (2) For that purpose the Consul General shall, on the receipt by him of a certified printed copy of the Order, cause the same to be affixed and exhibited conspicuously in that office. He shall also keep the same so affixed and exhibited during one month from that first exhibition.
- (3) Proof shall not in any proceeding or matter be required that the provisions of this article have been complied with, nor shall any act or proceeding be invalidated by any failure to comply with any such provisions.

# TENDERS FOR LOANS ON TREASURY BILLS.

1. 4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London

Banker. Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the

Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than two o'clock (Saturday twelve o'clock) on the day on which the relative Bills are dated.

7. In virtue of the provisions of Section 26 of the Finance Act, 1915, Members of the House of Commons are not precluded from tendering

for these Bills.

Should this date not correspond with the beginning of the period for which wages are paid by an employer who pays wages at intervals not exceeding seven days the rates become effective as from the beginning of the next full day period, but in any case not later than 9th March 1922.

Note.—This Notice supersedes the Notice U. (6) in so far as Minimum Rates for Female Workers are concerned.

#### PART II.

#### PIECE-WORK BASIS TIME-RATES FOR FEMALE WORKERS.

THE COFFIN FURNITURE SECTION OF THE TRADE.

SECTION I .- The Piece-Work Basis Time-Rates for Female Piece-Workers of 18 years of age and

over in the Coffin Furniture Section of the Trade shall be 15 per cent. above the appropriate General Minimum Time-Rate as set out in Sections I., II. and III. of Part I. of this Notice.

#### THE CEREMENT MAKING SECTION OF THE TRADE.

The Picce-Work Basis Time-Rates for Female Piece-Workers of 18 years of age and over in the Cerement-Making Section of the Trade shall be 1d. per hour higher than the appropriate General Time-Rate as set out in Sections V., VI. and VII. of Part I. of this Notice.

Section II.—In cases where a worker is employed on Piece-Work each Piece-Rate paid must be such as would yield, in the circumstances of the case, to an ordinary worker not less than the appropriate Piece-Work Basis Time-Rate or, in the case of female workers under 18 years of age, not less than the appropriate General Minimum Time-Rate.

#### PART III.

#### OVERTIME RATES FOR FEMALE WORKERS (ALL AGES).

Section I.—In accordance with Section 3 (1) (c) of the Trade Boards Act, 1918, the Trade Board have declared the normal number of hours of work in the trade to be as follows:—

Provided that all hours worked on Sundays and on Customary Public and Statutory Holidays shall be regarded as Overtime to which the Overtime Rates shall apply.

Section II.—The Overtime Rates in respect of hours worked by a worker in excess of the declared normal number of hours of work in the trade shall, in the case of workers employed on Time-work, be as follows:—

- (a) For all time worked on Customary Public and Statutory Holidays, the Overtime Rate shall be one-and-a-half times the General Minimum Time-Rate otherwise applicable, i.e., Time-and-a-Half, and
- (b) For all time worked on Sundays, the Overtime Rate shall be twice the General Minimum Time-Rate otherwise applicable, i.e., Double-Time.
- (c) For all other Overtime worked, one-and-a-fifth times the General Minimum Time-Rate otherwise applicable, i.e., Time-and-a-Fifth.

The Overtime Rates shall be payable in respect of all hours worked in excess of 5 on a Saturday and in respect of all hours worked in excess of 9 on any other day (not being a Sunday or Customary Public or Statutory Holiday) notwithstanding that the total number of hours worked in the week does not exceed 47.

Section III.—The minimum rates for overtime in respect of each hour of overtime as defined above, worked by workers employed on Piece-Work shall be:—

- (a) For all time worked on Sundays, Piece-Rates each of which would yield, in the circumstances of the case, to an ordinary worker at least the Piece-work Basis Time-Rate applicable, or where no Piece-Work Basis Time-Rate has been fixed the General Minimum Time-Rate applicable, with the addition of the General Minimum Time-Rate applicable as set out above.
- (b) For all time worked on Customary Public and Statutory Holidays, Piece-Rates each of which would yield, in the circumstances of the case, to an ordinary worker at least the Piece-Work Basis Time-Rate applicable, or where no Piece-Work Basis Time-Rate has been fixed the General Minimum Time-Rate applicable, with the addition of one-half of the General Minimum Time-Rate applicable as set out above.
- (c) For all other overtime worked, Piece-Rates each of which would yield, in the circumstances of the case, to an ordinary worker at least the Piece-Work Basis Time-Rate applicable, or where no Piece-Work Basis Time-Rate has been fixed the General Minimum Time-Rate applicable, with the addition of one-fifth of the General Minimum Time-Rate applicable as set out above.
- N.B.—The hours which Female Workers, young persons and children are allowed to work are subject to the provisions of the Factory and Workshop Acts, and of the Employment of Women, Young Persons and Children Act, 1920.

# PART IV.

The respective Minimum Rates of Wages for Female Workers set out in Parts I., II, and III of. this Notice shall apply, subject to the provisions of the Trade Boards Acts, to all workers in Great Britain in respect of all time during which they are employed in any branch of the trade specified in the Trade Boards (Coffin Furniture and Cerement-Making) Order, 1919, that is to say:—

- (a) The manufacture, wherever carried on, of Coffin Furniture from any metal by any process.
  (b) The manufacture of Cerements, including shrouds, face curtains, face cloths, sidecloths,
- (b) The manufacture of Cerements, including shrouds, face curtains, face cloths, sideclot winding sheets, pillow covers, coffin pads, sleeves or frilling.

# Including-

(c) The operations of folding, packing, warehousing, despatching or other operations incidental to or appertaining to the manufacture of any of the above-mentioned articles.

#### PART V.

Section I.—The above Minimum Rates of Wages are to be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any Superannuation or other Provident Fund.

Section II.—The above Minimum Rates of Wages are without prejudice to workers who are earning higher rates of wages or to agreements made or that may be made between employers and workers for the payment of wages in excess of the Minimum Rates.

PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR CERTAIN CLASSES OF MALE AND FEMALE IN-DENTURED APPRENTICES AND WORKERS UNDER 21 YEARS OF AGE WHO HAVE COMPLETED AN INDENTURED APPRENTICESHIP.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 31st October 1918, the Trade Board established in Great Britain under the Trade Boards Act, 1918, for the Perumbulator and Invalid Carriage Trade as specified in the Trade Boards (Perumbulator and Invalid Carriage) Order, 1919, hereby give notice, as required by Section 3 (5) of the Trade Boards Act, 1918, that they propose to vary the Minimum Rates at present fixed and set out in their Notice I. (8) dated 2nd February 1922, in their application to certain classes of Male and Female Workers under 21 years of age including Indentured Apprentices, so that in lieu of such rates, the Minimum Rates for the classes of Male and Female Workers specified in the Schedule set out below shall be as shown in such Schedule.

The Minister of Labour has given his consent to the Notice of Proposal to vary being given.

#### SECTION IV.

#### OVERTIME RATES.

Overtime Rates, calculated on the appropriate proposed minimum rates set out in this Schedule in the manner specified in Part IV. of the Schedule to the Trade Boards' Notice I. (8) dated 2nd February 1922, shall apply in substitution for the appropriate proposed minimum rates set out in Sections II. and III. of this Part of this Schedule, in respect of all hours of employment in excess of the number of hours declared by the Trade Board in Section I. of Part IV. of the above-mentioned Notice I. (8) to be the normal number of hours of work in the trade.

Note.—Workers of the classes specified in this Schedule shall, on the attainment of the age of 21 years, be entitled to the minimum rates proposed by the Trade Board for workers of 21 years of age and over as set out in Part I. of the above-mentioned Notice I. (9).

#### PART II.

# FORM OF INDENTURE OF APPRENTICESHIP.

The form of Indenture of Apprenticeship referred to in Section I. of Part I. of this notice is as follows:—

PERAMBULATOR AND INVALID CARRIAGE TRADE BOARD (GREAT BRITAIN).

Indenture of Apprenticeship prescribed by the above Trade Board.

This Indenture made the day of between a minor of the age of years (hereinafter called the "Apprentice") of the first part, of the Parent or Guardian of the Apprentice (hereinafter called the "Guardian") of the second part and of (hereinafter called the "Employer") of the third part:

Witnesseth as follows, that is to say :-

- 1. The Apprentice of his own free will and with the consent of the Guardian hereby binds himself or herself to serve the Employer as his Apprentice in his trade of the term of \* years from the date of these presents.
- 2. In consideration of the covenants and agreements entered into by the Guardian and the Apprentice, the Employer hereby covenants with the Guardian and the Apprentice and with each of them severally, as follows:—
  - (a) That he will keep the Apprentice as his Apprentice during the said term and to the best of his power, skill and knowledge instruct the Apprentice or cause him to be instructed in the section or sections of the Perambulator and Invalid Carriage Trade known as
  - (b) That he will keep the Apprentice under his own supervision or place him or her under a fully qualified Journeyman (or Journeymen).
  - (c) That he will pay to the Apprentice every week during the said term wages in accordance with the appropriate scale of wages as fixed and as varied from time to time for Male or Female Apprentices by the Trade Board.
  - (d) That if the Employer shall die or become permanently incapacitated through illness or injury (to be certified by a duly qualified Medical Practitioner) or cease to carry on the said trade of before the expiration of the said term of apprenticeship, then, and in any such case, the Employer or his Executors or his Administrators as the case may be, shall, subject to the consent and approval of the Guardian and of the said Apprentice being obtained, find another suitable Employer for the Apprentice to take over this Indenture.
  - (e) That he will not hold the Apprentice liable to make good the value of any work which he or she may spoil whilst learning his or her trade, except in the case of wilful or malicious damage.
  - (f) That he will cause the Apprentice to attend during the term of this Indenture such approved technical classes as may be agreed upon by the parties concerned in the Indenture, the Apprentice to suffer no loss of wages by reason of attendance at any Technical Classes either as aforesaid or under the provisions of the Education Act, 1918, and the time so spent to be reckoned as an equivalent part of the usual working hours and not extra thereto.

- (g) That he will supply the Apprentice forthwith, upon its execution, with a true copy of this Indenture.
- \* Insert "two" in the case of apprenticed as:
  - (a) Upholsterers and Hood Coverers.
  - (b) Cutters.
  - (c) Sewing Machinists.

Insert "four" in all other cases.

- 3. In consideration of the premises, the Guardian and the Apprentice respectively severally covenant with the Employer as follows:—
  - (a) That the Apprentice shall truly and faithfully during the said term serve the Employer as his Apprentice and his secrets keep and shall diligently attend to the said trade and at all times willingly obey the lawful and reasonable commands of the Employer, and shall not absent himself or herself from the Employer's service without leave.
  - (b) That the Apprentice shall not do any damage or knowingly suffer any damage to be done to the goods, moneys or other property of the Employer.
  - (c) That the Apprentice shall willingly perform all such shop duties as are usually done by Apprentices.
  - (d) That the Apprentice shall attend such continuation classes between the hours of 9 a.m. and 7 p.m. as the Employer desires provided that the Apprentice suffer no loss of wages by reason of such attendance.
  - (e) That in case the Apprentice shall at any time during the said term be wilfully dis obedient to lawful orders or commands of such Employer, or be slothful or negligent; or shall otherwise grossly misbehave himself or herself towards the Employer, it shall be lawful to discharge the said Apprentice, who shall be entitled to the right of appeal to the Trade Board.
- 4. In consideration of the Covenants and Agreements entered into by the Guardian and the Apprentice with the Employer, it shall be mutually agreed that:
  - If either of the parties hereto desires for any reason to determine this Agreement before the expiration of the said period of two or four years or in the event of any dispute arising involving allegations of unsuitability or of failure to apply himself or herself diligently to learn the said operation on the part of the Apprentice or of failure on the part of the Employer to cause him or her to be well and sufficiently instructed in the said operation or of wrongful exercise by the Employer of his power to dismiss the Apprentice under Clause 3(e) hereof which cannot be settled between the parties hereto the Employer and the Apprentice hereby mutually agree that the matters in dispute shall stand referred in the first instance to the Perambulator and Invalid Carriage Trade Board (Great Britain) with a view to effecting a settlement thereof.

The proposed Minimum Rates of Wages set out in this Schedule shall apply subject to the provisions of the Trade Boards Acts to all Workers of the Classes specified in Section I. of Part 1. of this Schedule in respect of all time during which they are employed in Great Britain in any branch of the Trade specified in the Trade Boards (Perambulator and Invalid Carriage) Order, 1919, as set out in Part V. of the Trade Board's Notice I. (8).

The Trade Board will consider any Objections to the above Proposals which may be lodged with them within two months from the 3rd day of March 1922. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary of the Perambulator and Invalid Carriage Trade Board (Great Britain), 7-11 Old Bailey, London, E.C. 4.

It is desirable that the Objections should state precisely, and, so far as possible, with reasons, what is objected to.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October 1918, the Trade Board established in Great Britain under the Trade Boards Act, 1918, for the Perambulator and Invalid Carriage Trade, as specified in the Trade Boards (Perambulator and Invalid Carriage) Order, 1919, hereby give Notice, as required by Section 3 (5) of the Trade Boards Act, 1918, that they propose to vary the General Minimum Time-Rates, Piece-Work Basis T me-Rates and Overtime Rates for Male and Female Workers, at present effective and set out in their Notice I. (8) dated 2nd February 1922, the Variations proposed being as shown in the Schedule set out below.

The Minister of Labour has given his consent to this Notice of Proposal to Vary being issued.

In lieu of the Piece-Work Basis Time-Rates at present fixed, the Piece-Work Basis Time-Rate for each of the classes of workers specified in Parts I. and II. of this Schedule shall be 10 per cent. above the appropriate General Minimum Time Rate proposed as set out in Parts I. and II. of this Schedule.

#### PART IV.

#### PROPOSED VARIATION OF OVERTIME RATES.

Overtime Rates calculated on the appropriate proposed minimum rates set out in Parts I., II. and III. of this Schedule, in the manner specified in Part IV. of the Schedule to the Notice I. (8) issued by the Trade Board and dated 2nd February 1922, shall apply in substitution for the appropriate proposed rates set out in Parts I., II. and III. of this Schedule, in respect of all hours worked in excess of the number of hours declared by the Trade Board in the Schedule to the above-mentioned Notice I. (8) to be the normal number of hours of work in the trade.

#### PART V.

The above proposed Minimum Rates of Wages shall apply, subject to the provisions of the Trade Boards Acts, to all Male and Female Workers other than the classes of workers specified in the Schedule to the Trade Boards Notice I. (10) dated 2nd March 1922, in respect of all time during which they are employed in Great Britain in any branch of the trade specified in the Trade Boards (Perambulator and Invalid Carriage) Order, 1919, as set out in Part V. of the Schedule to the abovementioned Notice I. (8).

# PART VI.

# GENERAL.

SECTION I.—The average percentage Increase in the Cost of Living Figure referred to in this Notice refers to the Average Percentage Increases since July 1914, in Retail Prices in the United Kingdom (all items) as published each month by the Ministry of Labour in the Labour Gazette.

Section II.—Except as regards the date from which the proposed minimum rates may first be made effective by an Order of the Minister of Labour the proposed minimum rates applicable during each of the periods referred to above shall become payable from the first pay day in the month following the publication of the Cost of Living Figure referred to in Section I. above.

The Trade Board will consider any Objections to the above proposal to vary which may be lodged with them within two months from 3rd March 1922. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary of the Perambulator and Invalid Carriage Trade Board (Great Britain), 7-11 Old Bailey, London, E.C. 4.

It is desirable that the Objections should state precisely, and, so far as possible, with reasons, what is objected to.

# ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 1ST MARCH 1922.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:-

Authorisation of Show and Sale at Yeovil.

1. Notwithstanding anything contained in the Foot-and-Mouth Disease (Control of Movement) Order of 1920, or in the Foot-and-Mouth Disease (Great Britain) Order of 1922, the holding of a Show and Sale by Messrs. W. Palmer & Company, at the Repository in the borough of Yeovil, on the third day of March nineteen hundred and twenty-two, is hereby authorised, subject to the conditions hereinafter specified.

Movement of Animals to Show and Sale.

2.—(1) No animal shall be moved to the Show and Sale except from premises situated within the counties (including any boroughs geographically situated therein) of Dorset, Somerset, and Wiltshire.

(2) No animal shall be moved to the Show and Sale unless it is accompanied by a licence authorising such movement granted by the Local Authority of the administrative county of Somerset or by some person authorised by that Local Authority to issue such licences.

# Removal of Animals from Show and Sale.

3. Animals shall not be removed from the Show and Sale unless they are accompanied by a movement licence granted by an Inspector of the Local Authority of the district in which the premises to which the animals are intended to be moved are situate, which licence the Local Authority are hereby empowered to grant in respect of movement to any premises in their district, notwithstanding the provisions of the Orders referred to in Article 1. No such licence shall be granted for the movement of an animal to any premises situated in the area described in the Second Schedule to the Footand-Mouth Disease (Great Britain) Order of 1922, No. 8, or in any area which is for the time being a Prohibited Area for the purposes of the Foot-and-Mouth Disease (Control of Movement) Order of 1920.

# Conditions of Movements.

4. Except as provided in this Order the provisions of the Orders referred to in Article 1, relating to animals moved with a licence under those Orders, shall apply to animals moved with a licence under this Order.

# Prohibition of Landing at Manchester Irish Animals Landing Place.

1. Cattle, sheep, goats or swine shipped from Ireland shall not, unless and until it is otherwise ordered by the Minister, be landed a Ifte noon on the third day of March nineteen hundred and twenty-two, at the landing place defined by Order of the Minister as a landing place for Irish animals at Manchester.

# Local Authority to Enforce Order.

2. The provisions of this Order shall be executed and enforced by the Local Authority.

# Offences.

3. If any animal shall be landed in contravention of this Order, the owner thereof and the owner and the lessee and the occupier of the place of landing, and the person causing, directing or permitting the landing, and the owner and the charterer, and the master of the vessel from which the same is landed, as the case may be, shall, each according to and in respect of his own acts or defaults, be deemed guilty of an offence against the Diseases of Animals Act, 1894.

# ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 1ST MARCH 1922.)

FOOT-AND-MOUTH DISEASE (GREAT BRITAIN) ORDER OF 1922 (No. 9).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

# Application of Order to Scheduled Districts.

1. Parts I., III. and IV. of the Foot-and-Mouth Disease (Control of Movement) Order of 1920, hereinafter referred to as "the Principal Order," are hereby applied, subject to the modifications, hereinafter appearing, to the several districts described in the First Schedule hereto, each of which shall be a Scheduled District for the purposes of that Order.

#### Movement into Scheduled Districts.

2. Notwithstanding anything contained in the Principal Order, animals may be moved by road or rail into any Scheduled District described in the First Schedule hereto from premises in either of the areas described in the Third Schedule hereto for any purpose, if accompanied throughout the movement by a licence granted under this Order. Prohibition of Movement out of certain Areas Specified in Second Schedule.

3. Notwithstanding anything contained in the Principal Order, or this Order, no cattle, sheep, goats or swine shall be moved out of any of the areas described in the Second Schedule hereto, except direct to a slaughterhouse situated within any Scheduled District described in the First Schedule hereto, and then only if accompanied by a Movement Licence granted under this Order.

Movement from one Scheduled District to another for Immediate Slaughter.

4. Notwithstanding anything contained in the Principal Order, an animal may be moved from any premises situate within any Scheduled District described in the First Schedule hereto to any slaughterhouse in another such Scheduled District, if accompanied by a Movement Licence granted under this Order.

Slaughter within 48 hours of Animals moved with a Licence to a Slaughterhouse.

5. Where animals are moved with a licence under the Principal Order or this Order authorising their movement to a slaughterhouse, the animals on arrival at the slaughterhouse shall be detained therein until slaughtered, and shall be slaughtered therein within forty-eight hours of their arrival thereat.

Modification of Principal Order as regards Granting of Movement Licences.

6.—(1) A Movement Licence granted under the Principal Order or this Order shall be granted only by an Inspector of the Local Authority of the District in which the premises to which the animals are to be moved are situate. Except as provided in Article 8 of this Order a licence so granted shall not be available unless and until it is countersigned by an Inspector of the Local Authority of the District from which the animals are to be moved, who shall in every case endorse upon the licence the route by which the animals are to be moved and the date and time of the countersignature. No licence shall be granted or countersigned by an Inspector of any Local Authority if in his opinion it is undesirable to grant or countersign it.

(2) A movement licence granted under this Order shall be available for three days from the time it is countersigned, and no longer.

(3) In the case of every movement of animals authorised by a licence under this Order, the licence shall accompany the animals throughout the movement.

# Holding of Farm Sales.

7. Notwithstanding anything contained in the principal Order, no sale of cattle, sheep, goats or swine shall be held on any farm premises in any Scheduled District described in the First Schedule hereto unless it is authorised by the Local Authority under this Atticle, which authority the Local Authority are hereby empowered to grant: Provided that no such sale shall be authorised to be held on any premises situated within any area described in the Second Schedule hereto.

Movement direct to a Slaughterhouse of Animals landed from Ireland.

8. Animals landed at an Irish Animals'

Landing Place shall not be moved therefrom except direct to a slaughterhouse, and then only if accompanied by a licence granted by an Inspector of the Local Authority of the District in which the slaughterhouse is situate. The licence shall in such cases be countersigned by an Inspector of the Ministry before the animals leave the landing place.

Movement of Animals into any part of Great Britain not within any Scheduled District.

9. No cattle, sheep, goats or swine shall be moved by rail or otherwise into either of the areas described in the Third Schedule hereto from any Scheduled District described in the First Schedule or from the other area described in the Third Schedule hereto.

#### Offences.

10. If anything is done or omitted to be done in contravention of this Order, the owner and the person for the time being in charge of the animal in respect of which, as the case may be, the same is done or omitted to be done and the occupier of the premises concerned shall, each according to and in respect of his own acts or omissions, be deemed guilty of an offence against the Act of 1894.

Altering the number and qualifications of the Directors of the said High School of Dundee and providing as to elections to that office.
