HAIR, BASS AND FIBRE TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR MALE AND FEMALE WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October 1918, the Trade Board established under the Trade Boards Act, 1918, in Great Britain for the branches of Trade specified in the Trade Boards (Hair, Bass and Fibre) Order, 1919, hereby give notice as required by Section 3 (5) of the Trade Boards Act, 1918, that they propose to vary the General Minimum Time-Rates, Piece-Work Basis Time-Rates and Overtime Rates at present fixed and set out in the Schedule to their Notice H.B. (6), dated 15th October 1921, for Male and Female Workers, the proposed variations being as shown in the Schedule set out below.

The Minister of Labour has given his consent to the issue of this Notice.

Provided that in the case of any female worker who enters the trade for the first time at or over the age of 16 years, and who is employed on Time-work, the General Minimum Time-Rates payable during the worker's first 12 months' employment shall be the Minimum Rates set out in Section III. above applicable to a worker in the immediately junior age group in lieu of the General Minimum Time-Rates otherwise applicable.

Overtime Rates calculated on the appropriate proposed Minimum Rates set out in Parts I. and II. of this Schedule, in the manner set out in Part V. of the Schedule to the Notice H.B. (6) issued by the Trade Board and dated 15th October 1921, shall apply in substitution for the appropriate rates set out in Parts I. and II. of this Schedule in respect of hours worked in excess of the number of hours declared by the Trade Board in the Schedule to their Notice H.B. (6) to be the normal number of hours of work in the trade.

PART IV.

The respective proposed Minimum Rates set out in this Schedule apply, subject to the provisions of the Trade Boards Acts, to all workers in Great Britain of the classes specified in this Schedule in respect of all time during which they are employed in any branch of the trade specified in the Trade Boards (Hair, Bass and Fibre) Order, 1919, and set out in Part IX. of the Schedule to the Trade Board's Notice H.B. (6) dated 15th October 1921.

The Trade Board will consider any Objections to the above Proposals which may be lodged with them within two months from the 28th March 1922. Such Objections should be in writing and signed

by the person making the same (adding his or her full name and address), and should be sent to The Secretary of the Hair, Bass and Fibre Trade Board (Great Britain), 7-11 Old Bailey, London, E.C.4.

It is desirable that the Objections should state precisely, and so far as possible with reasons, what is objected to.

TRADE BOARDS ACTS, 1909 AND 1918.

HAIR, BASS AND FIBRE TRADE BOARD (GREAT BRITAIN).

MINIMUM RATES AS VARIED FOR WORKERS EMPLOYED ON HAND-LOOM WEAVING (OTHER THAN DAMASK SEATING HAND-LOOM WEAVING), EFFECTIVE AS FROM 28TH MARCH 1922.

Should this date not correspond with the beginning of the period for which wages are paid by an employer who pays wages at intervals not exceeding seven days, the rates shall become effective as from the beginning of the next full pay period, but in no case later than 3rd April 1922.

This Notice sets all out the minimum rates of wages which have been fixed by the Trade Board and are effective under the Trade Boards Acts for workers employed on Hand-Loom Weaving (other than Damask Seating Hand-Loom Weaving), and takes the place of Parts VI. and VII. of the Notice H.B. (6) issued by the Trade Board and dated 15th October 1921.

SCHEDULE.

PART I.

GENERAL MINIMUM PIECE-RATES FOR WORKERS EMPLOYED ON HAND-LOOM WEAVING (OTHER THAN DAMASK SEATING HAND-LOOM WEAVING).

The General Minimum Piece-Rates for Hair Cloths and Plain Hair Seating are the rates set out in the following lists less 10 per cent. :—

Haircloths.

Single Hairs, per inch—18 inches and under, 35, 3½d. ; 40, 3½d. ; 50, 4d. ; 60, 4½d. ; 70, 5½d. ; 80, 6½d. ; 90, 7d. ; 100, 8d. per yard.

Over 18 inches wide, 35, 3½d. ; 40, 3¾d. ; 50, 4½d. ; 60, 5d. ; 70, 5¾d. ; 80, 6½d. ; 90, 7½d. ; 100, 8½d. per yard.

Double Hairs, 33⅓ per cent. less.

The above rates to include tying in but not beaming or drawing up harness and reeds.

PART II.

OVERTIME RATES FOR WORKERS EMPLOYED ON HAND-LOOM WEAVING (OTHER THAN DAMASK SEATING HAND-LOOM WEAVERS AND HOME-WORKERS).

SECTION I.—In accordance with Section 3 (1) (c) of the Trade Boards Act, 1918, the Trade Board have declared the normal number of hours of work in the Trade in any week to be 48.

Provided that all hours worked on Sundays and Customary Public and Statutory Holidays shall be regarded as Overtime to which the Overtime Rates shall apply.

SECTION II.—Hand-loom Weavers (other than Home-Workers) employed on Piece-work to which the General Minimum Piece-Rates set out in Part I. of this Schedule are applicable shall receive, in respect of hours worked in excess of the number of hours declared by the Trade Board, in Section I. of this Part, to be the normal number of hours of work in the trade, in addition to payment at not less than the appropriate General Minimum Piece-Rates :—

- (i) As respects each of the first four hours of Overtime in any week, 2d. per hour ;
- (ii) As respects each hour in excess of four hours of Overtime in any week, 4d. per hour ;
- (iii) As respects each hour of employment on Sundays or on Customary Public and Statutory Holidays, 8d. per hour.

PART III.

For the purpose of this Notice the expression "Home-worker" means a worker who works in his or her own home, or in any other place not under the control or management of the employer.

PART IV.

SECTION I.—The Minimum Rates set out in this Schedule apply, subject to the provisions of the Trade Boards Acts to all workers employed in Great Britain in Hand-Loom Weaving (other than Damask Seating Hand-Loom Weavers) in respect of all time during which they are employed on piece-work to which the General Minimum Piece-Rates set out in Part I. of this Schedule are applicable in any branch of the Trade specified in the Trade Boards (Hair, Bass and Fibre) Order, 1919; that is to say:—

The drafting, dressing or mixing of bass, whisk or similar fibres or horse hair or other hairs and the curling or weaving of hair or fibre, or of mixed hair and fibre, and all preparatory, finishing, warehousing or packing operations incidental to or appertaining to all or any of the above processes, but excluding any of the above operations or processes where they are carried on in association with or in conjunction with the manufacture of brushes or brooms, and excluding also the dressing of animal skins.

SECTION II.—The above Minimum Rates of Wages must be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments or deductions authorised by any Act to be made from wages in respect of contributions to any Superannuation or other Provident Fund.

SECTION III.—The above Minimum Rates of Wages are without prejudice to workers who are earning higher rates of wages or to agreements made or that may be made between employers and workers for the payment of wages in excess of the Minimum Rates.

Signed by order of the Trade Board and in pursuance of an Order of the Minister of Labour confirming the minimum rates as varied by the Trade Board and set out above, and specifying the 28th day of March 1922 as the date from which they should become effective.

 PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR WORKERS OTHER THAN LEARNERS.

In accordance with the Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 31st October 1918, the Lace Finishing Trade Board established under that Act for certain branches of the Machine-Made Lace and Net Finishing Trade as defined in the Regulations made by the Board of Trade and dated 16th March 1914, hereby give notice, as required by Section 3 (5) of the Trade Boards Act, 1918, that they Propose to Vary the General Minimum Piece-Rates, and also the General Minimum Time-Rates for Workers other than Learners at present effective and set out in the Schedule to their Notice L. (8), dated 12th October 1921, the proposed variations being as shown in the Schedule set out below.

This Proposal is issued with the consent of the Minister of Labour.

PROPOSED VARIATION OF OVERTIME RATES FOR MALE AND FEMALE WORKERS

Overtime Rates calculated on the proposed minimum rates of wages set out in Parts I. and II. of this Schedule in the manner specified in Section II. of Part III. of the Schedule to the Trade Board's Notice M.T. (3), dated 3rd February 1922, shall apply in substitution for the proposed minimum rates in respect of all hours worked in excess of the number declared by the Trade Board in Section I. of Part III. of their Notice M.T. and is provided by the employer with reasonable facilities for such learning.

(b) Has received a certificate or has made an application for such certificate in accordance with the rules laid down by the Trade Board. Provided that in granting or withholding such certificate the Trade Board may take into consideration whether in view of the number of learners and adults employed in a factory or workshop, the learner proposed to be certificated has a reasonable prospect of receiving due instruction. Provided also that any certificate may be withdrawn if the Trade Board consider that the conditions of employment are not being complied with.

Provided that an employer may employ a learner on his or her first employment on one of the processes specified above without a certificate for a probation period not exceeding four weeks, but in the event of such learner being continued thereafter at his or her employment, the probation period shall be included in his or her period of learnership.

PART V.

APPLICABILITY OF PROPOSED MINIMUM RATES OF WAGES.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 29TH MARCH 1922.)

FOOT-AND-MOUTH DISEASE (GREAT BRITAIN) ORDER OF 1922 (No. 16).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

Movement of Wintering Sheep.

1. Notwithstanding the provisions of the Foot-and-Mouth Disease (Control of Movement) Order of 1920 (hereinafter referred to as "the Principal Order"), or of the Foot-and Mouth

Disease (Great Britain) Order of 1922 (No. 15) (hereinafter referred to as "Order No. 15"), sheep may be moved from wintering quarters situate in any scheduled district described in the First Schedule to Order No. 15, but not situate in the county of Berwick or within any Infected Area which is for the time being included in the Third Schedule to Order No. 15, to any other premises in Great Britain subject to and in accordance with the following provisions of this Order, but not otherwise.

2. The sheep shall be required to be accompanied by a licence granted by an Inspector of the Local Authority of the District in which the premises to which the sheep are to be moved are situate.

3. Before such licence is available it shall be countersigned by an Inspector of the Local Authority of the District from which the sheep are to be moved.

4. The sheep shall be moved as far as practicable

able by railway or by vessel. The Inspector countersigning the licence and the Inspector granting the licence shall respectively specify the routes by which the sheep are to be moved to the railway station for the purpose of entraining and from the railway station or landing place, as the case may be, nearest to the place of destination.

5. No licence shall be granted for the movement of sheep under this Order from or to any premises situate within a radius of two miles from any place which is for the time being declared to be a place infected with Foot-and-Mouth Disease, and the route to be specified by the Inspectors as aforesaid shall be such that at no point shall the sheep be moved by road within a radius of two miles of any place which is for the time being declared to be a place infected with Foot-and-Mouth Disease.

6. Before any licence is countersigned under this Order the sheep to be moved shall be individually examined by a Veterinary Inspector of the Local Authority of the District in which the sheep are within forty-eight hours before the movement commences, and no licence shall be countersigned unless the sheep have been certified by the Inspector to be free from any suspicion of Foot-and-Mouth Disease.

7. On arrival of the sheep at the railway station or landing place nearest to the place of destination, the sheep shall, before being dispersed to their intended destination for summer grazing and before being brought into contact with any other animals, be examined again by a Veterinary Inspector of the Local Authority.

Disinfection of Railway Trucks and Vessels.

8.—(1) Every railway truck or other railway vehicle in which sheep are to be placed for the purpose of movement with a licence under this Order shall, not more than twenty-four hours before the sheep are placed therein, be thoroughly sprayed or soured with liquid disinfectant under the supervision, and to the satisfaction, of an Inspector of the Local Authority.

(2) All parts of a vessel used for carrying sheep moved with a licence under this Order, and all fittings, pens, hurdles, or utensils used for or about the animals, shall, not more than twenty-four hours before the sheep are placed therein, be thoroughly sprayed or soured with liquid disinfectant under the supervision, and to the satisfaction, of an Inspector of the Local Authority.

(3) The liquid disinfectant used for the purposes of this Article shall be—

(a) a 1 per cent. (minimum) solution of chloride of lime (containing not less than 30 per cent. of available chlorine); or

(b) a 5 per cent. (minimum) solution of carbolic acid (containing not less than 95 per cent. of actual carbolic acid); or

(c) a disinfectant equal in disinfective efficiency to the above-mentioned solution of carbolic acid.

(4) Nothing in this Article shall interfere with the operation of the provisions of the Animals (Transit and General) Order of 1912 as to the cleansing and disinfection of railway trucks or other railway vehicles, or of vessels or parts thereof, used for the conveyance of animals on a railway or by water.

Offences.

9. If any sheep is moved, or anything is done, or omitted to be done, in contravention of this Order, the owner and the person for the time being in charge of the animal in respect of which the same is done, or omitted to be done, or in respect of Article 8, the railway company or shipping company carrying the sheep, as the case may be, shall each according to and in respect of his or their own acts or omissions, be deemed guilty of an offence against the Diseases of Animals Act, 1894.

Commencement.

10. This Order shall come into operation on the fifth day of April nineteen hundred and twenty-two.

Short Title.

11. This Order may be cited as the FOOT-AND-MOUTH DISEASE (GREAT BRITAIN) ORDER OF 1922 (No. 16).
