TRADE BOARDS ACTS, 1909 AND 1918.

STAMPED OR PRESSED METAL WARES TRADE BOARD (GREAT BRITAIN).

MINIMUM RATES OF WAGES (AS VARIED) FOR FEMALE WORKERS.

Effective as from 10th June 1922.*

* NOTE.—Should this date not correspond with the beginning of the period for which wages are paid by an employer who pays wages at intervals not exceeding seven days, the rates shall become effective as from the beginning of the next full pay period, but in no case later than 16th June 1922.

GENERAL MINIMUM TIME-RATES:

Female Workers of 18 years of age and over employed as Polishers or as Drop Stämpers:

- 8½d., 9½d. or 10½d. per hour. Operative only from 10th June 1922, up to and including 14th July 1922.
- 8d., 9d. or 10d. per hour. Operative as from 15th July 1922, according to length of experience.

Female Workers of 18 years of age and over employed as Hand-Brush-Japanners who are capable of finishing all classes of work, Hand-Brush-Lacquerers who are capable of finishing all classes of work, Blow-Pipe-Braziers, or Solderers using ordinary Hand-Iron or Blow-Pipe with bar solder:

- 7½d., 8½d. or 9½d. per hour. Operative only from 10th June 1922, up to and including 14th July 1922.
- 7d., 8d. or 9d. per hour. Operative as from 15th July 1922, according to length of experience.

All other Female Workers of 18 years and over:

- 7½d. per hour. Operative only from 10th June 1922, up to and including 14th July 1922.
- 7d. per hour. Operative as from 15th July 1922.

All other Female Workers under 18 years of age:

According to age and occupation. (See Part I. of the Schedule below.)

PIECE-WORK BASIS TIME-RATES :

All Female Workers employed as Polishers or as Drop Stampers :

11½d. per hour. Operative only from 10th June 1922, up to and including 14th July 1922.

11d. per hour. Operative as from 15th July 1922.

All Female Workers employed as Hand-Brush Japanners who are capable of finishing all classes of work, Hand-Brush-Lacquerers who are capable of finishing all classes of work, Blow-Pipe-Braziers, or Solderers using ordinary Hand-Iron or Blow-Pipe with bar solder :

10½d. per hour. Operative only from 10th June 1922, up to and including 14th July 1922.

10d. per hour. Operative as from 15th July 1922.

All other Female Workers of 18 years of age or over :

8½d. per hour. Operative only from 10th June 1922, up to and including 14th July 1922.

8d. per hour. Operative as from 15th July 1922.

All other Female Workers under 18 years of age :

According to age. (See Section III. of Part II. of the Schedule below.)

NOTE.—In the case of all Workers employed on Piece-Work, each Piece-Rate paid must be such as would yield, in the circumstances of the case, not less than the equivalent of the appropriate Piece-Work Basis Time-Rate to an Ordinary worker, *i.e.*, a worker of ordinary skill and experience in the class of work in question.

PART III.

OVERTIME RATES (AS VARIED).

SECTION I.—In accordance with Section 3 (i) (c) of the Trade Boards Act, 1918, the Trade Board have declared the normal number of hours of work in the trade to be as follows :—

In any week	47
On Saturday	4½

Provided that all hours worked on Sundays and on Statutory Holidays shall be regarded as Overtime to which the Overtime Rates shall apply.

SECTION II.—The Minimum Rates for Overtime in respect of hours worked by a worker, whether employed on time-work or on piece-work in excess of the declared normal number of hours shall be as follows :—

- For all hours worked on Sundays and Statutory Holidays the Overtime Rate shall be twice the Minimum Rate otherwise applicable, *i.e.*, Double-Time.
- For all hours worked in excess of four-and-a-half on Saturday, the Overtime Rate shall be One-and-a-Half times the Minimum Rate otherwise applicable, *i.e.*, Time-and-a-Half, notwithstanding that the total number of hours worked in the week does not exceed 47.
- For all hours worked in excess of 47 in any week, the Overtime Rate shall be equivalent to Time-and-a-Quarter for the first two hours and Time-and-a-Half thereafter, except in so far as higher Overtime Rates are payable under the provisions of Sub-Sections (a) and (b) of this Section.

NOTE.—The hours which female workers, young persons and children are allowed to work are subject to the provisions of the Factory and Workshop Acts, and of the Employment of Women, Young Persons and Children Act, 1920.

PART IV.

SECTION I.—The above Minimum Rates of Wages apply, subject to the provisions of the Trade Boards Acts, to all Female Workers in Great Britain in respect of all time during which they are employed in any branch of the trade specified in the Trade Boards (Stamped or Pressed Metal Wares) Order, 1919.

SECTION II.—The Trade as specified in the above-mentioned Order is as follows :—

The manufacture from metals (other than precious metals) by the processes of cold stamping or

cold pressing (including cutting or piercing) of cabinet fittings, window fittings, curtain accessories, stationers' sundries, drapers' sundries, fittings for gas or electric light, fittings for suit-cases or hand-bags or purses, buckles, eyelets, ferrules, labels, collar studs, tie-clips, thimbles, photograph frames, stamped chains, bells, fancy nails (excluding the shanks), parts of safety razors (excluding the blades), parts of braces or suspenders, corset steels or busks, whistles, tin-openers, medals or any similar articles or metal parts of such articles ;

Including :—

- (a) The operations of annealing, hardening, barrelling, polishing, bronzing, nickelling, lacquering, japanning, non-vitreous enamelling, tinning or assembling, where these operations are carried on in association with or in conjunction with the manufacture of such stamped or pressed metal articles ;
- (b) The operations of carding, boxing, packeting, labelling, weighing, packing, warehousing or despatching, where these operations are incidental to or appertaining to the manufacture of such stamped or pressed metal articles ;

But Excluding :—

- (a) The operations specified in the Trade Boards (Hollow-ware) Order, 1913 ;
- (b) The making of buttons or any operations incidental thereto ;
- (c) The making of coffin furniture or any operations incidental thereto ;
- (d) The making of pins, hairpins, hooks and eyes, hair-curlers, snap fasteners or safety pins or any operations incidental thereto ;
- (e) The making of steel pens and the making of stationers' metal sundries or other similar metal articles when carried on as a subsidiary branch of work in association with or in conjunction with the making of steel pens, so as to provide a common or interchangeable form of employment for the workers ;
- (f) The minting of coinage of the realm ;
- (g) The process of hand-embossing.

PART V.

SECTION I.—The above Minimum Rates of Wages must be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments or deductions authorised by any Act to be made from wages in respect of contributions to any Super-annuation or other Provident Fund.

SECTION II.—The above Minimum Rates of Wages are without prejudice to workers who are earning higher rates of wages or to agreements made or that may be made between employers and workers for the payment of wages in excess of these minimum rates of wages.

Signed by Order of the Trade Board and in pursuance of an Order of the Minister of Labour confirming the Minimum Rates as varied by the Trade Board and set out above and specifying the 10th day of June 1922 as the date from which they should become effective.

SOUTH-EASTERN COUNTIES OF SCOTLAND SANATORIUM BOARD ORDER, 1922, dated 8th June 1922, made by the Scottish Board of Health under Section 64 (3) of the National Insurance Act, 1911.

Whereas, by Order dated 12th December 1913 (hereinafter referred to as "the principal Order") made by the Local Government Board for Scotland under Sub-Section (3) of Section 64 (as applied to Scotland by Section 60) of the National Insurance Act, 1911, which Order was amended by the Order dated 10th June 1921, made by the Scottish Board of Health, it is provided that the County Councils of the Counties of Berwick, Haddington (East Lothian), Linlithgow, Midlothian, Peebles, Roxburgh and Selkirk, shall be combined for the purposes of (1) providing, furnishing, managing and maintaining a central institution or sanatorium, such institution to include a sanatorium proper, hospital and clearing-house or observation wards, and (2) making such other provision as may, subject to the approval of the said Board, be deemed necessary by the Joint Board constituted in terms of the said Order to be made at or in connection with the said central institution or sanatorium for the treatment, isolation and observation primarily of persons in these Counties suffering from or suspected of tuberculosis, and that the provision of such central institution or sanatorium, and the furnishing, management and maintenance thereof, shall be undertaken by a Joint Board to be called the South-Eastern Counties of Scotland Joint Sanatorium Board:

And whereas the Scottish Board of Health have, after consultation with the South-Eastern Counties of Scotland Joint Sanatorium Board, resolved to amend the principal Order as hereinafter contained:

Therefore, We, the Scottish Board of Health, by virtue of the powers competent to Us under the enactment before referred to, and of all other powers enabling us in that behalf, do hereby Order as follows:—

1. This Order may be cited as the South-Eastern Counties of Scotland Joint Sanatorium Board Order, 1922, and shall be read as one with the principal Order.

2. The Joint Board shall consist of fifty members instead of forty-seven members, and of the said fifty members six shall be appointed by the County Council of the County of East Lothian, and Article 2 of the principal Order shall have effect accordingly.

3. Article 9 of the principal Order shall have effect, and shall be deemed always to have had effect, as if the following paragraph were substituted for paragraph (1) thereof, and such financial adjustments as may be necessary to give effect to this substitution shall be made accordingly:—

"(1) The charges in respect of capital expenditure incurred for the purposes of this Order (including the initial cost of the acquisition of the site of the Sanatorium) shall be defrayed by the Combining Authorities in proportion to the number of beds provided for each, such number to be as follows:—
Berwick, 16; East Lothian, 32; West

Lothian, 56; Midlothian, 57; Peebles, 10; Roxburgh, 15; Selkirk, 13. The Combining Authorities shall have a right preferential as against any persons or bodies other than the Combining Authorities to acquire additional beds in the future out of the excess accommodation which may exist at the Sanatorium from time to time, and that on terms to be arranged. In the event of extensions to the Sanatorium being at any time required involving the provision of additional beds, the cost thereof shall be defrayed by the Combining Authorities in proportion to the number of additional beds provided for each in such extensions."
