FACTORY AND WORKSHOP ACT, 1901.

MERCHANT SHIPPING (SHIPS' NAMES) AMENDMENT REGULATION, 1922.

REGULATION DATED 23RD JUNE 1922, MADE BY THE BOARD OF TRADE, IN CONJUNCTION WITH THE COMMISSIONERS OF CUSTOMS AND EXCISE, UNDER SECTION 50 OF THE MERCHANT SHIPPING ACT, 1906 (6 EDW. 7, CH. 48).

Under the provisions of Section 50 of the Merchant Shipping Act, 1906 (6 Edw. 7, Ch.

48), the Board of Trade, in conjunction with the Commissioners of Customs and Excise, hereby make the following Regulations.

(1) There shall be substituted for paragraph (a) of Regulation 6 of the Board of Trade Regulations, dated 28th August 1907 (Statutory Rules and Orders, 1907, No. 740), the following paragraph:—

"(a) If they are satisfied that the ship is intended to replace another of the same name which within 10 years of the date of the application belonged to the same owner when her British registry was closed, or which, within 10 years of the date of the application, was sold by the same owner on condition that her name should be changed, and her name has been changed."

(2) This Regulation shall come into force on the 1st day of July 1922, and may be cited as the Merchant Shipping (Ships' Names) Amendment Regulation, 1922, and shall be construed as one with those contained in Statutory Rules and Orders, 1907, No. 740, and those Regulations and this Regulation may be cited together as the Merchant Shipping (Ships' Names) Regulations, 1907 to 1922.

JUTE TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO FIX GENERAL MINIMUM PIECE RATES AND TO VARY OVERTIME RATES FOR CERTAIN CLASSES OF FEMALE WEAVERS IN THE MUNICIPAL BURGH OF ABERDEEN AND THE COUNTY BOROUGH OF BARROW-IN-FURNESS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October 1918, the Trade Board established in Great Britain under the Trade Boards Act, 1918, for the Jute Trade, as specified in the Trade Boards (Jute) Order, 1919, hereby give notice as required by Section 3 (5) of the Trade Boards Act, 1918, that they Propose to Fix General Minimum Piece Rates for Certain Classes of Female Weavers employed in the Municipal Burgh of Aberdeen and the County Burgh of Barrow-in-Furness, and to Vary the Overtime Rates at present fixed and set out in the Trade Board's Notice J (19), dated 8th March 1922, in their application to such workers.

Information with regard to the above mentioned proposed minimum rates may be obtained from the Secretary of the Trade Board at the address given below.

The Trade Board will consider any Objections to their Proposals to Fix and Vary which may be lodged with them within two months from the 15th July 1922. Such Objections should be in writing, and signed by the person making the

same (adding his or her full name and address), and should be sent to the Secretary of the Jute Trade Board (Great Britain), 7-11 Old Bailey, London, E.C. 4

It is desirable that the Objections should state precisely, and so far as possible, with reasons, what is objected to.

JUTE TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO FIX A PIECE-WORK BASIS TIME-RATE AND TO VARY THE OVERTIME RATES FOR ALL FEMALE WEAVERS EMPLOYED ON PIECE-WORK IN GREAT BRITAIN OUTSIDE THE AREAS OF ABERDEEN, BARROW-IN-FURNESS, CARNOUSTIE, DUNDEE, AND TAYPORT.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October 1918, the Trade Board established in Great Britain under the Trade Boards Act, 1918, for the Jute Trade, as specified in the Trade Boards (Jute) Order, 1919, hereby give notice as required by Section 3 (5) of the Trade Boards Act, 1918, that they Propose to fix a Piece-Work Basis Time-Rate for all Female Weavers employed in Great Britain outside the areas of Aberdeen, Barrow-in-Furness, Carnoustie, Dundee, and Tayport (as defined in Part III. of the Schedule to this Notice), and to Vary the Overtime Rates at present fixed and set out in the Trade Board's Notice J. (19), dated 8th March 1922, in their application to such workers employed on piece-work, the proposed Minimum Rates being as shown in the Schedule set out below.

The Minister of Labour has given his consent to the issue of this Notice.

SCHEDULE.

PART I.

PROPOSED PIECE-WORK BASIS TIME-RATE FOR ALL FEMALE WEAVERS EMPLOYED IN GREAT BRITAIN OUTSIDE THE AREAS OF ABERDEEN, BARROW-IN-FURNESS, CARNOUSTIE, DUNDEE, AND TAYPORT (as defined in Part III. of this Schedule).

Proposed Piece-Work
Basis Time-Rate.

SECTION I.—For all Female Weavers of the classes specified in Part III. of this Schedule 7½d.

SECTION II.—In cases where a Female Weaver is employed on piece-work each piece-rate paid must be such as would yield, in the circumstances of the case, not less than 7½d. per hour to an ordinary worker, i.e., a worker of ordinary skill and experience in the class of work in question.

PART II.

PROPOSED VARIATION OF OVERTIME RATES FOR THE CLASSES OF FEMALE WEAVERS SPECIFIED IN PART III. OF THIS SCHEDULE.

The Trade Board Propose to Vary the Overtime Rates for Female Workers employed on Piece-Work at present fixed and set out in the Trade Board's Notice J (19), dated 8th March 1922, in their application to all Female Weavers of the classes specified in Part III. of this Schedule so that such workers shall receive in respect of each hour of overtime worked in addition to piece-rates each of which would yield, in the circumstances of the case, not less than 7½d. per hour to an ordinary worker, an amount equal to one-half of or the full amount of the General Minimum Time-Rate which would have been applicable to the worker if she had been employed on Time Work, according as the Overtime Rate which would have been payable if the worker had been employed on Time Work were Time-and-a-half or Double Time.

PART III.

SECTION I.—The above Proposed Minimum Rates shall apply, subject to the provisions of the Trade Boards Acts, to all Female Weavers in respect of all time during which they are employed on Piece-Work in Great Britain outside the areas of Aberdeen, Barrow-in-Furness, Carnoustie, Dundee, and Tayport (as defined in Section II. of this Part) in any branch of the trade specified in the Trade Boards (Jute) Order, 1919, and set out in Part VI. of the Schedule to the Trade Board's Notice J. (18), dated 7th February 1922.

SECTION II.—The areas referred to in Section I. of this Part are as follows:—

- The Municipal Burgh of Aberdeen;
- The County Borough of Barrow-in-Furness;
- The Burgh of Carnoustie and the Parish of Barry and the Parish of Panbride;
- The Municipal Burgh of Dundee and the Parish of Liff and Benzie, the Parish of Mains and Strathmartine, the Parish of Dundee and that part of the Parish of Monifieth which lies South and West of Dighty Water; and
- The Burgh of Tayport and the Parish of Ferry-Port-on-Craig.

The Trade Board will consider any Objections to the above Proposals to Fix and to Vary which may be lodged with them within two months from the 15th day of July 1922. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary of the Jute Trade Board (Great Britain), 7-11 Old Bailey, London, E.C. 4.
