TENDERS FOR TREASURY BILLS AND TREASURY BONDS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 4th August 1922, at 1 o'clock, for

(a) Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914-1919; and

(b) £4 10s. per cent. Treasury Bonds, repayable at par on the 15th April 1932.

2. The maximum amount of Treasury Bills and Treasury Bonds to be issued will be £50,000,000. The amount of Treasury Bonds issued will not exceed £10,000,000, but subject to that limit the total amount issued will be divided between Bills and Bonds in such proportions as Their Lordships may determine.

TREASURY BILLS.

3. The Bills will be in amounts of £5,000 or £10,000. They will be dated at the option of the Tenderer on any business day from Tuesday, the 8th August 1922, to Saturday, the 12th August 1922, inclusive, and will be payable at three months after date.

4. The Bills will be issued and paid at the Bank of England.

5. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated,

and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

£4 10s. PER CENT. TREASURY BONDS, 1932.

6. The Bonds will be in denominations of £50, £100, £200, £500, £1,000, and £5,000. They will be exempt from Corporation Profits Tax, and will in all respects rank *pari passu* with those issued under the Prospectus of the 21st April 1922. They will be dated at the option of the Tenderer on any business day from Tuesday, the 8th August 1922, to Saturday, the 12th August 1922, inclusive; the first dividend, payable on the 15th October 1922, will represent in the case of each Bond interest to that date from the date of the Bond.

7. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bonds required are to be dated, and the net amount per cent. (being an even multiple of one shilling) which will be given for the amount applied for. Separate Tenders must be lodged for Bonds of different dates.

8. Tenders must be made through a London Banker, Discount House or Broker.

9. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made

to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills or Bonds are to be dated.

10. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills and Bonds.

11. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

12. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

TRADE BOARDS ACTS, 1909 AND 1918.

GENERAL WASTE MATERIALS RECLAMATION TRADE BOARD (GREAT BRITAIN).

MINIMUM RATES OF WAGES (AS VARIED) FOR MALE WORKERS OF 21 YEARS OF AGE AND OVER AND FOR FEMALE WORKERS, AND CANCELLATION OF GUARANTEED TIME-RATES FOR FEMALE PIECE-WORKERS, EFFECTIVE FROM 31ST JULY 1922.*

* Should this date not correspond with the beginning of the period for which wages are paid by an employer who pays wages at intervals not exceeding seven days, the Minimum Rates become effective as from the beginning of the next full pay period, but in any case not later than 6th August 1922.

FEMALE WORKERS.

GENERAL MINIMUM TIME-RATES.

- (a) Female Workers (as specified in Section I. of Part I. of the Schedule below) in the Woollen Rag and Woollen and Worsted Waste Section of the Trade.
Workers of 18 years of age or over, 7½d. per hour.
Workers under 18 years of age and learners. See Section I. of Part I. of the Schedule below.
- (b) All other Female Workers.
Workers of 18 years of age or over, 6½d. per hour.
Workers under 18 years of age and learners. See Section II. of Part I. of the Schedule below.

PIECE-WORK BASIS TIME-RATES.

- (a) Female Workers (as specified in Section I. of Part I. of the Schedule below) in the Woollen Rag and Woollen and Worsted Waste Section of the Trade.
Workers of all ages, 8¼d. per hour.
- (b) All other Female Workers.
Workers of all ages, 7½d. per hour.

MALE WORKERS.

GENERAL MINIMUM TIME-RATES.

- (a) Scrap Iron and Scrap Metal Section of the Trade.
Workers of 21 years of age or over, 1s. per hour.
- (b) All other Sections of the Trade.
Workers of 21 years of age or over, 11¼d. per hour.

No Minimum Rates have been fixed for Male Workers under 21 years of age. The Minimum Rates are not applicable to Male Workers engaged in loading or discharging water-borne craft.

OVERTIME RATES. See Part III. of the Schedule below.

The Rates in full as legally enforceable are set out in detail in the Schedule below.

SCHEDULE.

PART I.

GENERAL MINIMUM TIME-RATES AND PIECE-WORK BASIS TIME-RATES FOR ALL FEMALE WORKERS.

SECTION I.—Female Workers employed wholly or mainly in the sorting, grading or stripping of Woollen Rags and/or Woollen and Worsted Waste Materials to shade and/or quality; and

Female Workers employed in the operations of receiving, packing, compressing, teagling, craning, despatching or warehousing when carried on in or in association with or in conjunction with any establishment or department in which the sorting, grading or stripping of Woollen Rags and/or Woollen and Worsted Waste Materials to shade and/or quality constitutes the sole or main work of the establishment or department.

Provided that any worker to whom this Section applies who has had less than three months' experience in the operations of sorting or grading or stripping to shade and/or quality Woollen Rag or Woollen and Worsted Waste Materials, and who is employed during the whole or a substantial part of her time in learning such operations by an employer who provides the learner with reasonable facilities for such learning, the General Minimum Time-Rate payable to her during the period required to complete such first three months of experience shall be 1d. per hour less than that otherwise applicable to her under the foregoing provisions.

SECTION II.—All Female Workers employed in the trade specified in Part IV. of this Schedule other than those specified in Section I. above :—

Provided that in the case of a worker who has had less than three months' experience in the operations of sorting or grading of Waste Paper or Paper Stock Materials, and who :—

- (a) Is employed during the whole or a substantial part of her time in learning such operations by an employer who provides the learner with reasonable facilities for such learning; and
- (b) Has received a certificate or has been registered in accordance with rules from time to time laid down by the Trade Board or has made application for such certificate or registration which has been duly acknowledged and is still under consideration, the General Minimum Time-Rate payable to her during the period required to complete such first three months of experience shall be 1d. per hour less than that otherwise applicable to her under the foregoing provisions.

PAYMENT OF HALF-YEARLY INCREASES.

SECTION III.—In the case of workers of 14½ years of age and under 18 years of age the rate applicable to a worker of any particular age specified in Sections I. and II. shall only become payable on the first pay day in January or July, as the case may be, which corresponds with or immediately follows the date on which the worker attains such age. Until such time the rate payable shall be that applicable to a worker of the next lower age group.

APPLICATION OF PIECE-WORK BASIS TIME-RATES.

SECTION IV.—In the case of Female Workers employed on piece-work, each piece-rate paid must be such as would yield, in the circumstances of the case, at least the equivalent of the appropriate Piece-Work Basis Time-Rate, to an Ordinary Worker, *i.e.*, a worker of ordinary skill and experience in the class of work in question.

PART II.

GENERAL MINIMUM TIME-RATES FOR MALE WORKERS OF 21 YEARS OF AGE OR OVER.

SECTION I.—(a) Male Workers of 21 years of age or over employed in that branch of the trade specified in Part IV. of this Schedule which is engaged in the collecting, sorting, grading or breaking of scrap iron or other scrap metal where the collecting, sorting or grading of other waste materials is not carried out to a substantial extent in connection therewith, 48s. per week of 48 hours, *i.e.* 1s. per hour.

(b) Male Workers of 21 years of age or over employed in any other branch of the trade specified in Part IV. of this Schedule, 45s. per week of 48 hours, *i.e.* 11¼d. per hour.

SECTION II.—In the case of Male Workers of 21 years of age and over employed on piece-work, each piece-rate paid must be such as would yield, in the circumstances of the case, at least the equivalent of the appropriate General Minimum Time-Rate, to an Ordinary Worker, *i.e.*, a worker of ordinary skill and experience in the class of work in question.

PART III.

OVERTIME RATES FOR MALE WORKERS OF 21 YEARS OF AGE OR OVER AND FOR ALL FEMALE WORKERS.

SECTION I.—In accordance with Section 3 (1) (c) of the Trade Boards Act, 1918, the Trade Board hereby declare the normal number of hours of work in the trade to be as follows :—

In any week	48
On any day (other than Saturday)	8 $\frac{3}{4}$
On Saturday	4 $\frac{3}{4}$

Provided that all hours worked by a worker on Sundays and Customary Public Holidays, or on Statutory Holidays, shall be regarded as Overtime to which the Overtime Rates shall apply.

SECTION II.—The Minimum Rates for Overtime in respect of hours worked by a Male Worker of 21 years of age or over or by a Female Worker (whether employed on time-work or on piece-work), in excess of the declared normal number of hours shall be as follows :—

1. On any day other than Sundays, Customary Public Holidays and Statutory Holidays :—
 - (a) For the first two hours of Overtime, One-and-a-Quarter times the minimum rate otherwise applicable, *i.e.*, Time-and-a-Quarter.
 - (b) For Overtime after the first two hours of Overtime, One-and-a-Half times the minimum rate otherwise applicable, *i.e.*, Time-and-a-Half.
2. On Sundays, on Customary Public Holidays, and on Statutory Holidays :—For all hours worked, Twice the minimum rate otherwise applicable, *i.e.*, Double-Time.
3. In any week :—For all hours worked in any week in excess of 48, One-and-a-Quarter times the minimum rate otherwise applicable, *i.e.*, Time-and-a-Quarter, except in so far as higher Overtime Rates are payable under the provisions of Sub-Sections 1 (b) and 2 of this Section.
4. The Overtime Rates set out in Sub-Sections 1 and 2 of this Section are payable in respect of all hours of Overtime worked on any day, notwithstanding that the number of hours worked in the week does not exceed 48.

Provided that where it is the established practice of an employer to require attendance only on Monday, Tuesday, Wednesday, Thursday and Friday, the Overtime Rate shall only be payable on such days after 9 $\frac{1}{2}$ hours have been worked.

NOTE.—The hours which Female Workers, Young Persons and Children are allowed to work are subject to the provisions of the Factory and Workshop Acts and of the Employment of Women, Young Persons and Children Act, 1920.

PART IV.

The above respective Minimum Rates of Wages apply, subject to the provisions of the Trade Boards Acts, to all Male Workers of 21 years of age or over and to all Female Workers in Great Britain in respect of all time during which they are employed in the General Waste Branch of the Waste Materials Reclamation Trade, as defined in the Regulations made by the Minister of Labour, dated 27th August 1920, that is to say :—

- (1) The collecting, sorting or grading of the following materials :—

Rags, waste paper, paper stock, woollen, worsted, cotton, jute, flax, hemp or other textile waste, textile clippings or cuttings, used bags, sacks or sacking, scrap rubber, scrap iron or other scrap metal, fur cuttings, rabbit skins, bones or fat, used tins, broken glass or earthenware.
- (2) The collecting, sorting or grading of the following articles when collected, sorted or graded in association with or in conjunction with the collecting, sorting or grading of the waste materials specified above :—

Discarded clothing (including head-gear or foot-gear), discarded textile articles, old ropes, used bottles or used jars.
- (3) The following operations when carried on in association with or in conjunction with the collecting, sorting or grading of any or all of the waste materials specified in 1 above :—

The ripping of worn clothes for rags, the picking of old ropes, the trimming of paper salvage, the washing of used bottles or used jars, the washing of used tins, the breaking of scrap metal, the drying of rabbit skins, the making or repairing of sacks or bags, the willowing, pulling, scouring, carbonising or putting down mixings of textile waste.
- (4) The operations of receiving, packing, compressing, teagling, craning, despatching, or warehousing when carried on in association with or in conjunction with any of the above-mentioned operations.

But excluding—

- (a) Any of the above-mentioned operations when carried on in the establishment in which the waste materials are produced or in which they are used as raw materials for further manufacture.
- (b) The making or repairing of sacks or bags when carried on in a factory or workshop engaged solely or mainly in the making or repairing of sacks or bags.
- (c) The collecting, sorting, grading or drying of rabbit skins when carried on in an establishment in which such operations are the main or principal business, or when carried on in association with or in conjunction with any business, establishment, branch or department engaged in the manufacture of hatters' furs.
- (d)—(i) The collecting, sorting, or grading of cotton waste when carried on in an establishment in which such operations are the main or principal business.
- (ii) Any of the operations included in paragraphs (1), (2), (3) and (4) above (other than the operations specified in paragraph (d)—(i) above) when carried on in or in association with or in conjunction with any establishment of the kind specified in sub-paragraph (1) above.

Provided that notwithstanding anything contained in this Notice the above Minimum Rates shall not apply to Male Workers who are engaged in the loading or discharging of water-borne craft in any Section of the Trade.

PART V.

GENERAL PROVISIONS.

SECTION I.—The Minimum Rates of Wages must be paid clear of all deductions, other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any super-annuation or other provident fund.

SECTION II.—The above Minimum Rates of Wages are without prejudice to workers who are earning higher rates of wages or to agreements made or that may be made for the payment of wages in excess of the Minimum Rates.

PART VI.

CANCELLATION OF GUARANTEED TIME-RATES FOR FEMALE PIECE WORKERS.

The Guaranteed Time-Rates for Female Piece-Workers fixed by the Trade Board and set out in the Schedule to their Notice D. B(3), dated 15th February 1922, which became effective as from 1st March 1922, are cancelled as from 31st July 1922.

Signed by order of the Trade Board and in pursuance of an Order of the Minister of Labour confirming the variation and cancellation of Minimum Rates of Wages made by the Trade Board and set out above, and specifying the 31st day of July 1922 as the date from which such variation and cancellation should become effective.

The Trade Boards Acts provide amongst other things that :—

(1) *Exemption from Rates.*—Where a time-worker is affected by infirmity or physical injury which renders him incapable of earning the General Minimum Time-Rate or Overtime Rate and the Trade Board are of opinion that the case cannot suitably be met by employing the worker on piece-work, the Board may, on such conditions as they think fit, grant a certificate exempting the worker from payment at the minimum rate. All applications for such Permits of Exemption should be made on forms to be obtained from the Secretary of the Trade Board.

(2) *Workers Employed on Piece-Work.*—(a) Where no General Minimum Piece-Rates are effective and no special piece-rates have been fixed by the Board for the particular firm, but a *Piece-Work Basis Time-Rate* is effective, an employer must pay workers employed on piece-work piece-rates each of which will yield, in the circumstances of the case to an ordinary worker, at least the same amount of money as the *Piece-Work Basis Time-Rate*.

(b) Where no General or Special Minimum Piece-Rates or Piece-Work Basis Time-Rates are effective, an employer must pay workers engaged on piece-work piece-rates each of which will yield, in the circumstances of case to an ordinary worker, at least the same amount of money as the *General Minimum Time-Rate*.

(3) *Waiting Time to be Paid For.*—A worker must be paid at the General Minimum Time-Rate appropriate to him in respect of all time during which he is present on the premises of the employer, unless the employer can show (a) that the worker was present without the employer's consent, express or implied, or (b) that the worker was present for some purpose unconnected with his work and other than waiting for work; or unless the worker was present (c) only by reason of the fact that he was resident on the premises, or (d) during normal meal times in a room or place where no work is being done.

A worker employed on piece-work is deemed during his waiting time to have been employed at the General Minimum Time-Rate.

(4) *Duty of Employer to Keep Wages and Time Records.*—Every employer must keep such records of wages as are necessary to show that the minimum rates are being paid and the other provisions of the Acts complied with. Failure to do this renders the employer liable to a fine not exceeding £2 for each offence and to a fine not exceeding £1 for every day during which the offence continues after conviction.

(5) *Premiums not Allowed except in Certain Cases.*—An employer may not receive directly or indirectly any premium from an Apprentice or Learner to whom a minimum rate is applicable, unless it be a premium paid in pursuance of an instrument of Apprenticeship, not later than four weeks after the commencement of employment.

(6) *Penalties for Paying Less than the Minimum Rates.*—(a) The penalty for paying wages at less than the minimum rates (clear of all deductions as set out in Section I. of Part V. above), is a fine not exceeding £20 for each offence and a fine not exceeding £5 for each day on which the offence is continued after conviction.

(b) On conviction for failure to pay the minimum rate, the Court may order the employer convicted to pay arrears of wages due.

(c) *Onus of Proof on Employer.*—On a charge of failing to pay wages at not less than the minimum rate, the onus rests upon the employer of proving that there has been no such failure.

(d) *Agreements Void.*—Any agreement for payment of wages at less than the minimum rate is void.

(7) *Liability of Agents.*—An Agent of an Employer or any other person who commits any offence for which an employer is liable to a fine, is liable to the same penalty as the employer.

The above notes are explanatory only, and must not be regarded as a full or authoritative interpretation of the Trade Boards Acts, 1909 and 1918. These Acts can be obtained from H.M. Stationery Office, Imperial House, Kingsway, London, W.C. 2.

TRADE BOARDS ACTS, 1909 AND 1918.

SACK AND BAG TRADE BOARD (GREAT BRITAIN).

MINIMUM RATES OF WAGES AS VARIED FOR FEMALE AND MALE WORKERS. EFFECTIVE AS FROM 1ST SEPTEMBER 1922.

Should this date not correspond with the beginning of the period for which wages are paid by an employer who pays wages at intervals not exceeding seven days, the rates shall become effective as from the beginning of the next full pay period, but in any case not later than 17th September 1922.

GENERAL MINIMUM TIME-RATES.

A. FEMALE WORKERS.

- I. Certain Special Classes of Workers of 18 years of age and over (*see* Section I. (A) of Part I. of the Schedule below), 7½d. per hour.
- II. All other Workers of 18 years of age and over, 6½d. per hour.
- III. Workers under 18 years of age. *See* Section I. (B) of Part I. of the Schedule below.

B. MALE WORKERS.

- I. Certain Special Classes of Workers of 21 years of age and over (*see* Section II. (A) of Part I. of the Schedule below), 1s. 3¼d. per hour.
- II. All other Workers of 21 years of age and over, 1s. 0¼d. per hour.

(A) For Workers Employed on Time-Work.

- (1) For the first two hours of Overtime on any day, except Sunday and Customary Public and Statutory Holidays, the Overtime Rate shall be One-and-a-Quarter times the General Minimum Time-Rate otherwise applicable, *i.e.*, Time-and-a-Quarter.
- (2) For Overtime after the first two hours of Overtime on any day, except Sunday and Customary Public and Statutory Holidays, the Overtime Rate shall be One-and-a-Half times the General Minimum Time-Rate otherwise applicable, *i.e.*, Time-and-a-Half.
- (3) For all time worked on Sunday and Customary Public and Statutory Holidays, the Overtime Rate shall be Twice the General Minimum Time-Rate otherwise applicable, *i.e.*, Double-Time.
- (4) For all hours worked in any week in excess of 48 the Overtime Rate shall be One-and-a-Quarter times the General Minimum Time-Rate otherwise applicable, *i.e.*, Time-and-a-Quarter, except in so far as higher Overtime Rates are payable under the provisions of paragraphs (2) and (3) of Sub-Section (A) of this Section.

The Overtime Rates shall be payable where on any day (not being a Sunday or a Customary Public or Statutory Holiday) the number of hours worked exceeds nine, or, in the case of Saturday, exceeds five, notwithstanding that the number of hours worked in the week does not exceed 48.

Provided that where it is or may become the established practice of an employer to require attendance only on five days a week, the Overtime Rates shall only be payable on such days after 9½ hours have been worked.

B.—For Female Workers employed on Piece-work :—

- (i) All Female Workers employed on Piece-Work shall receive in respect of each hour of overtime worked, in addition to Piece-Rates, each of which would yield, in the circumstances of the case, to an Ordinary worker, not less than the Piece-Work Basis Time-Rate applicable :—
 - (a) An amount equal to one-quarter of the appropriate Piece-Work Basis Time-Rate.
 - (b) An amount equal to one-half of the appropriate Piece-Work Basis Time-rate, or
 - (c) An amount equal to the full amount of the appropriate Piece-Work Basis Time-Rate, according as the Overtime Rate which would have been payable under the provisions of paragraph (A) of this Section, if the worker had been employed on Time-Work, were—
 - (a) Time-and-a-Quarter,
 - (b) Time-and-a-Half, or
 - (c) Double-Time, respectively.

NOTE.—The hours which Female Workers, Young Persons and Children are allowed to work are subject to the provisions of the Factory and Workshop Acts, and of the Employment of Women, Young Persons and Children Act, 1920.

PART IV.

Subject to the provisions of the Trade Boards Acts, the respective Minimum Rates of Wages set out in this Schedule apply to all Male and Female Workers in Great Britain in respect of all time during which they are employed in any branch of the Trade specified in the Trade Boards (Sack and Bag) Order, 1920, that is to say :—

The making from woven fabrics of corn sacks, flour sacks, coal sacks, sugar sacks, cement bags, sand bags, nail bags, potato bags, seed bags and similar sacks or bags, or the repairing thereof :

 - (i) folding (or hooking), cutting, machining, turning ;
 - (ii) brushing, selecting, mending ;
 - (iii) branding, tarring, bundling ;
- (B) The warehousing of, the packing of, and similar operations in regard to sacks or bags of the kind mentioned above when carried on in association with or in conjunction with the making or repairing thereof ;
- (C) The warehousing of, the packing of, and similar operations in regard to any other articles when carried on in or in association with or in conjunction with any business, establishment, branch or department mainly engaged in any of the operations mentioned in paragraph (B) above ;

but excluding :—

- (i) any of the operations mentioned above when carried on in association with or in conjunction with the weaving of jute, flax or hemp, or the dyeing, bleaching or finishing of jute, flax or hemp yarn or cloth ;
- (ii) any of the operations mentioned above when carried on in or in association with or in conjunction with any business, establishment, branch or department mainly engaged in a business in which the sacks or bags are used as containers for other articles the production or sale of which forms part of the business ;
- (iii) the making of rope-bound coal or coke sacks when carried on in association with or in conjunction with any business, establishment, branch or department engaged in the

making of made-up textile articles other than sacks or bags whether rope-bound or not, of the kind mentioned ;

- (iv) any of the operations mentioned in paragraph (B) above when carried on in or in association with or in conjunction with any business, establishment, branch or department mainly engaged in the warehousing of, the packing of, and similar operations in regard to made-up textile articles other than sacks or bags, whether rope-bound or not, of the kind mentioned ;
- (v) operations included in the Trade Boards (Waste Materials Reclamation) Order, 1920.

PART V.

The above Minimum Rates of Wages must be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments, or deductions authorised by any Act to be made from wages in respect of contributions to any Supcrannation or other Provident Fund.

REGULATIONS FOR THE COMPETITIVE SELECTION
OF GEOLOGISTS ON THE GEOLOGICAL SURVEY.

(Under the Committee of the Privy Council for Scientific and Industrial Research.)

N.B.—These Regulations are liable to alteration from time to time.

1. *Age*.—Candidate must have attained the age of 21 and must not have attained the age of 30 on the 1st April of the year in which the competition is held.

2. *Nationality*.—No person will be eligible for appointment to the Civil Service who is not a natural-born British subject and the child of

a father also a natural-born British subject; provided that exception may be made in the case of candidates serving in a civil situation to which they were admitted with the certificate of the Civil Service Commissioners, and provided that exception may be made as regards the father in the case of candidates who have served in His Majesty's Armed Forces in the Great War.

3. *Military Service.*—Until further order preference will be given to candidates who have served in His Majesty's Forces in the Great War.

4. *Publicity.*—The Committee of the Privy Council will take such steps as they think most appropriate to make known the existence of any vacancy or vacancies which they desire to fill on any one occasion, and the Civil Service Commissioners will satisfy themselves that the steps taken have been such as to secure all desirable publicity.

5. *Application.*—Application shall be made in the first instance to the Director of the Survey and Museum, who, after examining the candidates' credentials and a personal interview or such other means as the Director considers suitable, will submit the names of such candidates as appear to have the requisite qualifications for any of the existing or prospective vacancies to the Lord President of the Council for nomination. Candidates thus nominated shall be submitted to the Civil Service Commissioners, who, if dissatisfied with the number or quality of candidates for any vacancy, may require further search to be made for qualified candidates.

6. *Education.*—Candidates must satisfy the Civil Service Commissioners that they have received such systematic education, general or technical, or general and technical together, as in their opinion fits them for the post. Candidates thus recommended and approved may, at the discretion of the Civil Service Commissioners, be submitted to a qualifying examination in English, Arithmetic and General Knowledge.

7. *Health and Character.*—Candidates must satisfy the Civil Service Commissioners as to their health and character.

Until further order, and other things being equal, preference will be given by the Selection Board to candidates whose choice of occupation is limited by a physical impairment due to the War, but not of such a nature as to interfere with the discharge of any of the duties of the post.

8. *Competitions.*—Candidates who have been approved by the Civil Service Commissioners and who, if required to take the qualifying examination, have passed that examination, will be summoned to an interview before a Selection Board, who will recommend for the vacancies existing those candidates who appear to them to possess the highest qualifications, and their decision will be final. The Selection Board shall be nominated by the Commissioners in consultation with the authorities of the Department, who shall be represented on the Selection Board, and one of the Commissioners shall be the Chairman. The Selection Board will take into consideration the candidate's record of experience and education, any recommendations that they may receive from persons named by

any candidate as having direct knowledge of his work in the past, and the personal qualities of the candidate as shown at his interview; and on their estimation of all the above evidence they will frame their decisions.

9. *Warning.*—Any attempt on the part of a candidate to enlist support for his application through Members of Parliament or other influential persons will disqualify him for appointment. The Selection Board will disregard spontaneous recommendations from persons who are not personally acquainted with the candidate's work, whether at school, at the University, in the Forces, or otherwise.

10. *Fee.*—If a qualifying examination is held, each candidate admitted thereto will be required to pay a fee of £3. A Selected Candidate will be required to pay a fee of £8, towards which the fee paid at the qualifying examination (if any) will count, before the issue of the certificate of qualification for appointment.
