William Windham; the Right Hon. Charles Gray, (commonly called Viscount Howick,) his Majesty's three Principal Secretaries of State; the Right Hon. William Windham, Baron Grenville, First Commissioner of his Majesty's Treasury; the Right Hon. Henry Petty, (commonly called Lord Henry Petty,) Chancellor and Under Treasurer of his Majesty's Exchequer; the Right Hon. George Howard, (commonly called Viscount Morpeth;) the Right Hon.
