PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 5th day of August, 1922 (N. 9376/22), in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions or other allowances in the nature thereof payable in respect of services in your Majesty's Naval or Marine Force to a person being, or having been, an Officer, Seaman, or Marine therein shall be paid in such manner and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council:

"And whereas by an Order in Council of Her late Majesty bearing date 22nd November 1890, it was enacted that the Royal Marine rank carrying out the duties of Barber in such of the Flag Ships as are also Depot Ships, Naval Barracks, and Steam Reserve Depot Ships at the Home Ports should receive an allowance of 2d. a day:

"And whereas we consider that provision is necessary for a Barber in Your Majesty's Hospital Ship 'Maine' wherein Royal Marine ranks are not usually borne:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by

Your Order in Council, to sanction payment of an allowance of 2d. a day as from 27th July 1922, to the Naval Rating or Marine carrying out the duties of Barber in Your Majesty's Hospital Ship 'Maine.'

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

TENDERS FOR TREASURY BILLS AND TREASURY BONDS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 25th August 1922, at 1 o'clock, for

- (a) Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914-
- (b) £4 10s. per cent. Treasury Bonds, repayable at par on the 15th April 1932.
- 2. The maximum amount of Treasury Bills and Treasury Bonds to be issued will be £45,000,000. The amount of Treasury Bonds issued will not exceed £5,000,000, but subject to that limit the total amount issued will be divided between Bills and Bonds in such proportions as Their Lordships may determine.

TREASURY BILLS.

- 3. The Bills will be in amounts of £5,000 or £10,000. They will be dated at the option of the Tenderer on any business day from Monday, the 28th August 1922, to Saturday the 2nd September 1922, inclusive, and will be payable at three months after date.
- 4. The Bills will be issued and paid at the Bank of England.
- 5. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

£4 10s. PER CENT. TREASURY BONDS, 1932.

- 6. The Bonds will be in denominations of £50, £100, £200, £500, £1,000, and £5,000. They will be exempt from Corporation Profits Tax, and will in all respects rank pari passu with those issued under the Prospectus of the 21st April 1922. They will be dated at the option of the Tenderer on any business day from Monday, the 28th August 1922, to Saturday, the 2nd September 1922, inclusive; the first dividend, payable on the 15th October 1922, will represent in the case of each Bond interest to that date from the date of the Bond.
- 7. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bonds required are to be dated, and the net amount per cent. (being an even multiple of one shilling) which will be given for the amount applied for. Separate Tenders must be lodged for Bonds of different dates.
- 8. Tenders must be made through a London Banker, Discount House or Broker.
- 9. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills or Bonds are to be dated.
- 10. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills and Bonds.

- 11. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 12. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.
