DANGEROUS DRUGS ACT, 1920.

(10 & 11 GEO. 5, c. 46).

Notice is hereby given under the Rules Publication Act, 1893, that the Secretary of State for the Home Department proposes, after the expiration of forty days from this date, to make Regulations under Sections 3 and 7 of the Dangerous Drugs Act, 1920 (10 & 11 Geo. 5, c. 46), amending the Raw Opium Regulations, 1921 (S.R. & O. 1921, No. 864), and the Dangerous Drugs Regulations, 1921 and 1923 (S.R. & O. 1921, No. 865 and S.R. & O., 1923, No. 312).

The effect of the new Regulations is to prohibit the diversion of consignments of raw opium and 'dangerous drugs passing through ports in Great Britain to destinations different from those to which the consignments were licensed from the country of export; and to modify in the case of prescriptions issued on National Health Insurance forms the requirements to be observed before a prescription for dangerous drugs is dispensed.

NOTICE OF INTENTION TO MAKE A SPECIAL ORDER TO BE CITED AS THE TRADE BOARDS (ROPE, TWINE, AND NET AND DRIFT NETS) ORDER, 1924.

The Minister of Labour hereby gives notice that, with a view to varying the description of the Rope, Twine, and Net Trade contained in the Trade Boards (Rope, Twine, and Net) Order, 1919, he intends, pursuant to the powers conferred upon him by Section 1 and Section 2 of the Trade Boards Act, 1918, to make a Special Order varying the Trade Boards (Rope, Twine, and Net) Order, 1919, in the manner shown in the Draft Special Order contained in the Appendix hereto. Further copies of the Draft Special Order may be obtained on application in writing to the Secretary, Ministry of Labour, Montagu House, Whitehall, London, S.W.1.

Objections to the Draft Special Order must be sent to the Minister of Labour at the above address within 42 days from the 16th day of October 1924. Every objection must be in writing and must state—

(a) the specific grounds of objection; and

(b) the omissions, additions or modifications asked for.

If necessary, the Minister will direct a Public Enquiry to be held in accordance with the provisions of the First Schedule to the Trade Boards Act, 1918.

TRADE BOARDS (ROPE, TWINE, AND NET AND DRIFT NETS) ORDER, 1924.

DRAFT OF A SPECIAL ORDER TO BE MADE BY THE MINISTER OF LABOUR UNDER THE TRADE BOARDS ACT, 1918, VARYING THE SPECIAL ORDER FOR THE ROPE, TWINE, AND NET TRADE MADE BY THE MINISTER OF LABOUR UNDER SECTION 1 OF THE TRADE BOARDS ACT, 1918, DATED 11TH JULY 1919:

Whereas the Minister of Labour (hereinafter referred to as the Minister) by a Special Order called the Trade Boards (Rope, Twine, and Net) Order, 1919, dated the 11th day of July 1919, applied the Trade Boards Acts, 1909 and 1918, to the trade specified in the Appendix to the said Special Order.

And whereas it is provided by sub-Section 1 of Section 2 of the Trade Boards Act, 1918, that every Special Order may be varied or revoked by a subsequent Special Order.

And whereas the Minister is of opinion that it is desirable to vary the said Special Order by altering the description of the trade specified in the Appendix thereto.

Now, therefore, the Minister by virtue of the powers conferred on him by the Trade Boards Acts, 1909 and 1918, and of any other powers enabling him in that behalf hereby makes a Special Order varying the said Special Order:—

1. The following new paragraph shall be inserted in the Appendix to the Trade Boards (Rope, Twine, and Net) Order, 1919, after paragraph 4 and immediately preceding paragraph 5, that is to say,

"4(a) The mending, refitting and reconditioning of drift, seine or similar nets, including all processes (whether similar to the foregoing or not) incidental thereto."

2. This Order may be cited as the TRADE BOARDS (ROPE, TWINE, AND NET AND DRIFT NETS) ORDER, 1924.
