Now, therefore, His Royal Highness The Prince Henry, His Grace the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and the Prime Minister and First Lord of the Treasury, being authorised thereto by His Majesty's said Commission in pursuance of the said section, and of all other powers enabling them in that behalf, and by and with the advice of His Majesty's Privy Council on His Majesty's behalf are pleased to order, and it is hereby ordered, that the operations of Sections 1, 2, and 5 of the German Reparation (Recovery) Act, 1921, shall be suspended on and after the tenth day of April, nineteen hundred and twenty-five, until His Majesty shall be pleased to revoke this Order.

PROPOSAL TO VARY MINIMUM RATES OF WAGES  
FOR MACHINE TACKLERS.

In accordance with the Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 31st October 1918 and 1st August 1922, respectively, the Trade Board established under the Trade Boards Acts, 1909 and 1918, in Great Britain for the trade specified in the Trade Boards (Paper Bag) Order, 1919, HEREBY GIVE NOTICE as required by Section 3 (5) of the Trade Boards Act, 1918, that they PROPOSE TO VARY (the Minister of Labour having given his consent to the issue of this Notice of Proposal) the General Minimum Time Rates and Overtime Rates for male workers set out in the Schedule to the Trade Board's Notice P. 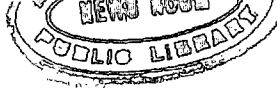
