Our Will and Pleasure therefore is that you, Edmund Bernard Viscount FitzAlan of Derwent, Deputy to Our said Earl Marshal, to whom the cognizance of matters of this nature doth properly belong, do require and command that this Our grant and prescription be recorded in Our College of Arms to the end that Our Officers of Arms and all others upon occasion may take full notice and have know-

PERAMBULATOR AND INVALID CARRIAGE TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO VARY AND FIX MINIMUM RATES OF WAGES FOR PERIODS DEPENDENT UPON THE COST-OF-LIVING INDEX FIGURE FOR MALE AND FEMALE WORKERS AND TO CANCEL MINIMUM RATES OF WAGES FOR CERTAIN CLASSES OF INDENTURED APPREN-

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 31st October, 1918, 1st August, 1922, and 1st April, 1926, respectively, the Trade Board established under the Trade Boards Acts, 1909 and 1918, in Great Britain for the Perambulator and Invalid Carriage Trade, as specified in the Appendix to the Trade Boards (Perambulator and Invalid Carriage) Order, 1926, HEREBY GIVE NOTICE:

- (1) That they PROPOSE TO VARY the minimum rates of wages for male and female workers set out in their Notice I. (14) dated 22nd December, 1922, for cost-of-living periods therein by amending the definitions of certain of the classes of workers as specified in that notice;
- (2) That they PROPOSE TO CANCEL the minimum rates of wages for certain classes of indentured apprentices and other workers as specified in their Notice I. (15) dated 22nd December, 1922; and
- (3) That they PROPOSE TO FIX minimum

workers employed in those branches of trade included in the trade specified in the Appendix to the Trade Boards (Perambulator and Invalid Carriage) Order, 1926, and not included in the trade specified in the Trade Boards (Perambulator and Invalid Carriage) Order, 1919.

Particulars of the minimum rates proposed to be varied, cancelled and fixed, are available for inspection at the address shown below, or may be obtained on application to the Secretary of the Trade Board.

Pursuant to Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will consider any objections to the above proposal to vary, fix and cancel, which may be lodged with them within two months from 30th April, 1926. Such objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary, Perambulator and Invalid Carriage Trade Board (Great Britain), 1, Whitehall Gardens, London, S.W.1.

PROPOSAL TO VARY OVERTIME RATES OF WAGES FOR MALE AND FEMALE WORKERS EMPLOYED ON TIME WORK.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October 1918, 1st August 1922, and 1st April 1926, the Trade Board established under that Act for the Laundry Trade in Great Britain HEREBY GIVE NOTICE that THEY PROPOSE TO VARY the Overtime Rates for Male and Female Workers employed on time work, set out in Trade Board Notices W. (11), W. (13) and W. (15), dated respectively, the 4th March 1922, 16th June 1922, and 10th May 1923, by substituting the following rates and provisions for those set out in the above-mentioned Notices:

## PART I.

PROPOSED DECLARATION OF THE NORMAL NUM-BER OF HOURS OF WORK IN THE TRADE.

The Trade Board propose to declare, in accordance with Section 3 (1) (c) of the Trade Boards Act, 1918, that the normal number of hours of work in the trade is as follows:

#### PART II.

PROPOSED OVERTIME RATES FOR FEMALE WORKERS ESPECIALLY EMPLOYED FOR EMERGENCY WORK OR WHOSE EMPLOYMENT IS OF A CASUAL NATURE.

SECTION I.—Overtime Rate in respect of the weekly short day.

For all hours worked in excess of 5 on the weekly short day (irrespective of the total number of hours worked during the week) the overtime rate shall be

TIME-AND-A-QUARTER.

Section II.—Weekly Overtime Rate.

For all hours worked in any week in excess of the number of hours declared in Part I. of this Notice to be the normal number of hours for that week the Overtime Rate shall be:—

- (a) For the first two hours of Overtime TIME-AND-A-QUARTER,
- (b) For all time after the first two hours of Overtime... ... TIME-AND-A-HALF.

## PART III.

PROPOSED OVERTIME RATES FOR (a) ALL FEMALE WORKERS (ALL AGES) OTHER THAN THE FEMALE WORKERS SPECIFIED IN PART II. OF THIS NOTICE AND (b) ALL MALE WORKERS UNDER 18 YEARS OF AGE.

Section I.—Overtime rate in respect of the weekly short day.

For all hours worked in excess of 5 on the weekly short day (irrespective of the total

number of hours worked during the week) the overtime rate shall be:—

- (a) For the first two hours of Overtime TIME-AND-A-QUARTER,
- (b) For all time after the first two hours of Overtime ...... TIME-AND-A-HALF, except in so far as higher overtime rates are payable under the provisions of Section II. of this Part of this Notice.

SECTION II.—Weekly Overtime Rate.

For all hours worked in any week in excess of the number of hours declared in Part I. of this Notice to be the normal number of hours for that week the Overtime Rate shall be:—

- (a) For the first two hours of Overtime TIME-AND-A-QUARTER.
- (b) For all time after the first two hours of Overtime ..... TIME-AND-A-HALF.

## PART IV.

Proposed Overtime Rates for Male Workers of 18 years of age and over.

Section I.—Overtime Rate in respect of the weekly short day.

For all hours worked in excess of 5 on the weekly short day (irrespective of the total number of hours worked during the week) the Overtime Rate shall be:—

- (a) For the first four hours of Overtime TIME-AND-A-QUARTER,
- (b) For all time after the first four hours of Overtime .... TIME-AND-A-HALF, except in so far as higher overtime rates are payable under the provision of Section III. of this Part of this Notice.

SECTION II.—Overtime Rate in respect of (a) the weekly day of rest and (b) trade holidays.

For (1) all hours worked on the weekly day of rest and for (2) all hours worked on Trade Holidays in excess of the number declared in in Sections V. and VI. of Part I. of this Notice (irrespective of the total number of hours worked during the week), the Overtime Rate shall be ... ... DOUBLE-TIME.

SECTION III.—Weekly Overtime Rate.

For all hours worked in any week in excess of the number of hours declared in Part I. of this Notice to be the normal number of hours for that week the Overtime Rate shall be:—

- (a) For the first six hours of Overtime TIME-AND-A-QUARTER,
- (b) For all time after the first six hours of Overtime ...... TIME-AND-A-HALF, except in so far as higher overtime rates are payable under the provisions of Sections I. and II. of this Part of this Notice.

## PART V.

DEFINITIONS AND APPLICABILITY OF RATES.

Section I.—For the purpose of this Notice, the following expressions have the several meanings hereinafter assigned to them, that is to say:—

(1) The expression "Trade Holidays"

means for all classes of workers in the trade! of whatever age and of both sexes:either

(a) The days allowed as Holidays to women and young persons under Section 35 of the Factory and Workshop Act, 1901;

- (b) Such day, half day or half days as may be substituted as a holiday in lieu of any of the days specified in paragraph (a) above in the case of those workers who in fact work on one of the days specified in the said paragraph (a) and are granted another holiday or one of two half holidays in lieu thereof, whether the same be granted under and by virtue of the provisions of Section 35 of the Factory and Workshop Act, 1901, or otherwise.
- (2) The expression "the weekly short day" means:—
  - (a) In the case of workers to whom the Shop Acts apply, the day which under those Acts constitutes the weekly short
  - (b) Sunday, in the case of those workers of the Jewish Religion who are usually employed on Sundays instead of Saturdays or such other day as may be substituted for Sunday whether under the provisions of the Factory and Workshop Act, 1901, or otherwise.
  - (c) In all other cases Saturday, or such other day as may be substituted for Saturday, whether under the provisions of Section 43 of the Factory and Workshop Act, 1901, or otherwise.
- (3) The expression "the weekly day of rest" means "Saturdays" in the case of those workers of the Jewish Religion who are usually employed on Sundays instead of Saturdays whether under and by virtue of the provisions of Section 48 of the Factory and Workshop Act, 1901, or otherwise. In all other cases the said expression means "Sundays."
- " Time-and-aexpressions Quarter," "Time-and-a-Half" and "Double-Time " mean respectively, one-and-a-quarter times, one-and-a-half times, and twice the appropriate General Minimum Time Rate otherwise applicable.

Section II.—The Overtime Rates shall not apply to Piece-Workers.

SECTION III.—The hours which Women, Young Persons, and Children are allowed to work are subject to the provisions of the Factory and Workshop Acts, of the Employment of Women, Young Persons and Children Act, 1920, of the Education Acts and of the Shop Acts.

## PART VI.

APPLICATION OF PROPOSED OVERTIME RATES.

The above Proposed Overtime Rates of Wages shall apply, subject to the provisions of the Trade Boards Acts, to all Male Washhouse and General Inside Workers (not being workers wholly or mainly employed as Transport Workers, Enginemen or Stokers) and to all Female Workers who are employed on time- \*Excluding outbreaks in Army horses.

work in respect of all overtime (as defined above) during which they are employed in Great Britain in any branch of the trade specified in the Appendix to the Trade Boards (Laundry) Order, 1919, as varied by certain other Orders as set out in the above-mentioned Notices W. (11), W. (13) and W. (15).
