WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 31st day of August 1926 (G.H. 26136), in the words following, viz.:—

"Whereas by section 20 of the Greenwich Hospital Act, 1865, it is enacted, inter alia, that the Admiralty shall from time to time continue or appoint such officers, clerks and servants for the purposes of the Hospital and Schools as seem fit, and may (subject to the approval of Your Majesty in Council) fix the salaries of such officers and clerks:

"And whereas by section 8 of the Greenwich Hospital Act, 1872, it is enacted that the provisions of section 20 of the Greenwich Hospital Act, 1865, so far as the same relate to salaries, shall extend to pensions and pecuniary benefits of any kind:

"And whereas Mr. W. T. Franklin, a former Assistant Master in the Royal Hospital School, Greenwich, is eligible for the award of superannuation allowances from the funds of Greenwich Hospital in respect of that portion of his service at Greenwich prior to the 31st March 1895:

"And whereas by Your Majesty's Order in Council dated the 17th May 1920, the scale of salary of the Chief Officer of the Royal Hospital

School, Greenwich, was fixed at £200 to £300 a year rising by annual increments of £10, with quarters:

"And whereas Mr. A. A. Rutter, Clerk in Charge of the Greenwich Hospital Department of the Admiralty retired from the service of Greenwich Hospital on the 16th August 1926, on account of age:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the following payments from the Funds of Greenwich Hospital, viz.:—

"(1) A pension to Mr. W. T. Franklin at the rate of Five pounds, nineteen shillings and two pence (£5 19s. 2d.) per annum as from the 26th March 1926, and a gratuity of Fifteen pounds, seventeen shillings and tenpence (£15 17s. 10d.).

"(2) The scale of salary of the Chief Officer of the Royal Hospital School, Greenwich, being increased from £200 to £250 per annum to £250 to £350 per annum, rising by £10 annually, with quarters, as from the 30th April 1926.

"(3) A pension to Mr. A. A. Rutter as from the date of his retirement at the rate of Four hundred pounds (£400) per annum, a supplementary pension of Ninety-seven pounds, fifteen shillings and sixpence (£97 15s. 6d.) per annum, re-assessed quarterly in accordance with the variation in the Civil Service Bonus cost of living figure and subject to an overriding maximum of One hundred and eleven pounds fourteen shillings and sixpence (£111 14s. 6d.)

per annum; and a gratuity of One thousand four hundred and seven pounds, seven shillings and fourpence (£1407 7s. 4d.)."

- "And whereas it is by the said Act also enacted that Your Majesty in Council may, from time to time, make such Orders as may seem meet for the better execution of the said Act:
- "And whereas, in pursuance of the said Act, certain Regulations as to the manner and incidence of payment of such shares as aforesaid were made by Order in Council, dated the 6th February 1917:
- "And whereas we consider it no longer necessary to keep Prize Money accounts open so long as forty years from the date of distribution as provided by Clause 9 of the aforesaid Order in Council:
- "We beg humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction the reduction of the period to ten years from the date of distribution, awards still open at this date, which will have been over 10 years in distribution on 31st December 1926, being finally closed as from that date.

- "And whereas Your Majesty was further graciously pleased by Your Order in Council bearing date the 6th day of February 1925 to sanction revised regulations governing the relative rank of Naval, Military and Air Force Officers, which provide, inter alia, that Royal Marine Officers shall in future rank at all times in accordance with their rank in the Royal Marines ashore:
- "And whereas we consider that the allowances of Royal Marine Officers should not be adversely affected by Your Majesty's Order in Council last mentioned:
- "We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to direct that the allowances payable to Officers of Your Majesty's Royal Marines prior to the 6th day of February 1925, shall remain unaffected by the changes in their relative rank made by Your Order in Council of that date.

" SCHEDULE.

"Temporary Special Retirement Scheme (1926) for Quartermasters, Sergeants-Major, and Superintending Clerks, Royal Marines, retired between the 3rd March 1926 and the 3rd September 1926, for the purpose of re-

ducing the lists.
"1. Quartermasters over the age of 50 and Warrant Officers over the age of 45 on the 3rd June 1926, retired under these regulations to be granted the rates of retired pay for which they would have been eligible under the regulations ordinarily applicable to them on attaining the age of 55 or 50 respectively, had they continued to serve until reaching that age, but in assessing such rates no promotions other than automatic promotions to be taken into account. For this purpose, promotion from Warrant Officer to Commissioned Officer from Warrant rank to be regarded as automatic on the attainment of ten years' seniority as Warrant Officer, provided the Officer's record is satisfactory.

"These Officers to be granted in addition to these rates of retired pay a gratuity on retirement at the rate of £37 10s. Od. for each complete three months intervening between

retired pay and the day on which they would attain the age of 55 and 50 respectively subject to a maximum gratuity of £500 in each

case.
"2. Officers of these ranks or classes who had not reached the age of 50 or 45 respectively on the 3rd June 1926, to be granted the rates of retired pay for which they would Honourable the Lords Commissioners of the have been eligible by rank and service had they continued to serve on full pay until the 3rd June 1928, subject, in each case, to the maximum rate of retired pay laid down for the rank held on the 3rd March 1926, a gratuity

of £500 to be granted in each case in addition.

"3. All rates of retired pay granted under the provisions of this Schedule to be subject to revision on the 1st July 1927, and subse-

" 4. Nothing in these regulations shall confer upon any Officer retired during the currency of the scheme under any regulations which may have been applicable to his case, a right to retired pay or gratuity under these regulations.'

" Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being, or having been, an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions as are, from time to time, directed by Order in Council:

" And whereas by Section 2, Sub-Section (1), of the Ministry of Pensions Act, 1916, it was enacted, inter alia, that the powers and duties of the Admiralty with respect to pensions and grants to persons who have served as men, other than service pensions, so far as such pensions and grants are payable out of moneys provided by Parliament, and not provided exclusively for the purpose of Greenwich Hospital, should be transferred to the Minister

of Pensions:
