#### TENDERS FOR TREASURY BILLS.

- 5. Tenders must be made through a London Banker, Discount House or Broker.

The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday, 12 o'clock) on the day on which the relative Bills are to be dated.
- 7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms, which may be obtained from the Chief Cashier's Office, Bank of England.

# "ANGLO-MEXICAN REVOLUTIONARY CLAIMS CONVENTION.

A convention has been concluded between the British and Mexican Governments for the adjustment of pecuniary claims for losses incurred by British subjects in Mexico on account of revolutionary acts which occurred between November 1910 and May 1920.

Claims of this kind are to be submitted to a commission composed of a British, a Mexican and a neutral member. The commission will take cognisance of two classes of claims for damages arising from revolutionary action, viz., direct and indirect claims claims are for losses or damages suffered either directly by British subjects or by British companies directly holding the property affected. Indirect are those for losses or damages suffered by British subjects indirectly, i.e., by reason of their holdings in non-British companies operating in Mexico. In the case of indirect claims, it will be necessary, if the claim is to come before the Anglo-Mexican Revolutionary Claims Tribunal, that at least fifty-one per cent. of the interest in the non-British company in question shall have been held by British subjects at the time the damages were sus-Such claimants must also produce documentary evidence from the company that the company make over to the claimants the proportionate share of the company's rights in the matter of damages.

The convention lays down that the losses or damages in respect of which the commission is to take cognisance of claims 'must have been caused during the period included between the 20th November 1910 and the '31st May 1920, inclusive, by one or any of the following forces:

' 1. By the forces of a Government  $de\ jure$  ' or  $de\ facto$  :

'2. By revolutionary forces which, after 'the triumph of their cause, have established 'Governments de jure or de facto, or by 'revolutionary forces opposed to them:

"3. By forces arising from the disjunction of those mentioned in the next preceding paragraph, up to the time when a de jure Government had been established, after a particular revolution:

'4. By forces arising from the disbandment of the Federal Army:

'5. By mutinies or risings, or by insurrectionary forces other than those referred to under sub-divisions 2, 3 and 4 of this article, or by brigands, provided that, in each case, it be established that the competent authorities omitted to take reasonable measures to suppress the insurrections, risings, riots or acts of brigandage in question, or to punish those responsible for the same; or that it be established in like manner, that the authorities were blamable in any other way.

'The Commission shall also deal with claims for losses or damages caused by acts of civil authorities, provided such acts were due to revolutionary events and disturbed conditions within the period referred to in this article and that the said acts were committed by any of the forces specified in sub-divisions 1, 2 and 3 of this article.'

From the above it will be seen that it is

important that claimants should furnish as complete evidence as possible to establish the identity of the forces responsible for the acts giving rise to their claims.

It is to be noted that under the terms of the convention His Majesty's Government undertake not to present to the Mexican Government, otherwise than under the convention, any claims for losses or damages arising in the manner and during the period above mentioned. It is important that any British subjects or companies, with claims of this nature against the Mexican Government, should in their own interests at once communicate with the Under Secretary of State for Foreign Affairs at the Foreign Office, drawing attention to any claims which they have already filled with the Foreign Office or with His Majesty's Legation or Consulate in Mexico City, and furnishing any further particulars which may appear necessary in the light of the above resumé of the terms of the convention. Any British subjects or companies, who have not yet formally filed with the Foreign Office or with His Majesty's Legation or Consulate in Mexico City a documented statement of their claim, should at once communicate with the Under-Secretary of State for Foreign Affairs at the Foreign Office giving as full particulars as possible.

His Majesty the KING has been graciously pleased to award the Edward Medal to George Edward Thorpe, George Gaunt, Thomas John Taylor and John Henry Perkins, in recognition of their gallantry in the following circumstances:—

On 7th January 1927, a shaft 20 feet in diameter and 50 feet deep, was being sunk at Greenwich. Six men, including George Thorpe, were working at the bottom of the shaft under compressed air when an explosion occurred which blew off the top of the shaft and caused a heavy fall of timber and concrete. At the same time the water which before the explosion, was held back by the compressed air, rapidly invaded the shaft. When the accident occurred, George Thorpe was partially sheltered from the falling material, but was rendered unconscious for a short time by the concussion. On regaining consciousness, he heard the cry of a companion, Martyn, who was pinned under fallen timber. Despite the fact that he was dazed by the explosion, and by the sudden release of air pressure, he left his shelter and held Martyn's head above the water until rescue came, preferring so to risk his life rather than to seek safety by climbing out of the shaft. He was all the time exposed to falling material, and the water was rapidly flooding the shaft.

As soon as the explosion occurred, Gaunt, a foreman, Taylor and Perkins at once sought means to descend the shaft and finally, by improvising a ladder 40 feet long, reached the bottom. They succeeded in freeing Martyn and bringing him and Thorpe to the surface. Further descents were made in a vain search

for the other four workers who were held down by wreckage and were submerged in the rising water. Martyn subsequently died from his injuries.

During the time they were engaged on the work of rescue debris was continually falling, and as the cause of the disaster was unknown so was it unknown whether the first explosion would not be followed by a second. rescue operations great promptitude and embarked on a highly perilous enterprise in a calm and intelligent manner, with a total disregard for their own

NOTICE OF INTENTION TO MAKE A SPECIAL ORDER TO BE CITED AS THE TRADE BOARDS (Corset) Order, 1927.

The Minister of Labour hereby gives Notice that with a view to varying the description of the Corset Trade contained in the Trade Boards (Corset) Order, 1919, he intends, pursuant to the powers conferred upon him by Section ! and Section 2 of the Trade Boards Act, 1918, to make a Special Order varying the Trade Boards (Corset) Order, 1919, in the manner shown in the Draft Special Order contained in the Appendix hereto.

### DRAFT SPECIAL ORDER. TRADE BOARDS.

THE TRADE BOARDS (CORSET) ORDER, 192, SPECIAL ORDER DATED MADE BY THE MINISTER OF LABOUR UNDER SECTIONS 1 AND 2 OF THE TRADE BOARDS ACT, 1918 (S AND 9 GEO. V. C. 32), VARYING THE DESCRIPTION OF THE CORSET TRADE CONTAINED IN THE APPENDIX TO THE TRADE BOARDS (CORSET) ORDER, 1919.

Whereas it is provided by sub-Section 1 of Section 2 of the Trade Boards Act, 1918, that every Special Order may be varied or revoked

by a subsequent Special Order.

And whereas the Minister of Labour (hereinafter referred to as the Minister) by a Special Order cited as the Trade Boards (Corset) Order, 1919, and dated the 6th May 1919, applied the Trade Boards Act, 1909 and 1918, to the trade specified in the Appendix to the said Special

And whereas the Minister is of opinion that it is desirable to vary the said Special Order by altering the description of the trade specified

in the Appendix thereto

Now, therefore, the Minister by virtue of the powers conferred on him by the Trade Boards Acts, 1909 and 1918, and of any other powers enabling him in that behalf hereby makes a Special Order varying the Trade Boards (Corset) Order, 1919:

1. The description of the trade set out in the Appendix to this Order shall be substituted for that set out in the Appendix to the Trade Boards (Corset) Order, 1919.

2. This Order may be cited as the Trade Boards (Corset) Order, 192

# APPENDIX. CORSET TRADE.

Subject to the provisions of this Appendix the Corset Trade shall consist of the following operations-

- All work in connection with:—
- (a) the manufacture of corsets, corselettes, stays, children's corset bodices, and infants staybands.
- (b) the manufacture of bust confiners.(c) the manufacture of support or abdominal belts or similar articles.
- (d) the manufacture (including assembling) of stocking suspenders, suspender belts and suspender pads, when carried on in conjunction with, or in association with the manufacture of any of the above articles.
- 2. Work in connection with the manufacture specified in para. 1 hereof shall include:-
  - (a) the altering, repairing, renovating or remaking of any of the articles specified in para. 1 hereof, when carried on in conjunction with, or in association with such manufacture.
  - (b) warehousing, packing, marking, letter press stamping, when incidental to such manufacture.
- 3. Notwithstanding anything in this Appendix the following operations shall not be operations in the Corset Trade:-
  - (a) the manufacture of bust confiners,

when carried on in a department mainly engaged on the making of articles specified in the Appendix to the Trade Boards (Women's Clothing) Order, 1919.

- (b) the manufacture of any of the articles specified in para 1 hereof when made in association with or in conjunction with the manufacture of surgical instruments or appliances.
- (c) the manufacture of corset steels and busks
- (d) printing, clerical work, cleaning, caretaking, and general maintenance work.

## (DRAFT) INSTRUCTIONAL CIRCULAR. TRADE BOARDS (CORSET) ORDER, 1927.

Purpose of Circular.—It has been represented to the Minister of Labour that it might prove of assistance to employers and workers and others concerned in the application of the Trade Boards Acts, 1909-1918, if, in suitable cases, when he makes an Order applying the Acts to a Trade for the first time or when he makes an Order varying the existing description of a trade contained in an Order made under the said Acts, some information were given by a departmental Instructional Circular as to his understanding of the scope of the Order.

An authoritative interpretation of the Trade Boards Acts and of Orders made thereunder can be given only by the Courts of Law and, on the understanding that any views which he may express provisionally as to the inclusion within, or exclusion from the scope of the Acts and Orders made thereunder, of any trade, process, operation, article, or of any class of worker are given on the information at the time in his possession and are subject to revision in the light of further information, the Minister makes the following observations for the guidance of all concerned in the application of the Trade Boards (Corset) Order, 1927.

General effect of the Amendment of the Order.—The Order of 1927 is designed to bring the description of the Corset trade for the purposes of the Trade Boards Acts into line with recent developments in the trade. The following paragraphs deal with the changes thus made. A copy of the definition contained in the Order of 1919 is attached for the purpose of comparison and reference.

#### (A) Inclusion Clauses.

The Inclusion Clauses of the new definition are set out in paragraphs 1 and 2 of the Appendix to the Order whilst the Exclusion Clauses are set out in paragraph 3 of the same.

Corsets, Corselettes, Stays, Children's Corset Bodices and Infants' Stay Bands (Paragraph 1 (a) of definition).—In accordance with the general principle indicated above, corselettes are now included because they form an important item in the Corset trade. The omission of the words "when boned or with elastic webbing in their construction" has the effect of bringing definitely within the scope of the Corset trade modern types of corsets which contain neither bone nor elastic webbing in their construction.

Bust Confiners (Paragraph 1 (b) of definition).

—The words "bust confiners" are understood to cover brassieres and bandeaux. The latter terms are therefore omitted from the new definition.

Support Belts, Stocking Suspenders, Suspender Belts and Suspender Pads (Paragraph 1 (c) and (d) of definition).—The Support Belts mentioned in paragraph 1 (c) include Belts which serve the dual purpose of bodily support and the support of suspenders. The manufacture of such articles, wherever carried on, is within the scope of the Order, subject to the exclusions in paragraph 3.

The Suspender Belts and Pads affected by paragraph 1 (d) are those made for the sole purpose of holding suspenders. Such articles are, subject to the exclusions, within the scope of the Order only when made in association with the manufacture of the articles mentioned in 1 (a) to (c) of the Order.

Altering, repairing, &c., in association with Manufacture (Paragraph 2 (a) of definition).—Repair work in corset factories is now brought under the Order. It should be noted that the effect of the clause is that, if any one of the specified articles is manufactured then the repair of any others in the same establishment will be included.

(Paragraph 2 (b) of definition).—The addition of the words "Marking, letterpress stamping" makes the paragraph more comprehensive and specific. The revised paragraph, whilst it does not include work recognised as forming a part of the printing trade, enables the work of stamping or otherwise marking the firm's name or trademark on the articles to be included as being incidental to the manufacture of corsets &c. as defined.

#### B. Exclusion Chauses.

Bust Confiners in association with Dressmaking (Paragraph 3 (a) of definition).—The object of this clause is to obviate the overlapping of Corset trade wage determinations in the Dressmaking trade. In the event, however, of a department of a dressmaking firm being mainly engaged upon the manufacture of bust confiners the latter work would fall within the Corset Order.

Manufacture in association with Surgical Appliances (Paragraph 3 (b) of definition).—The object of this exception is to avoid overlapping between the Corset Trade and the Surgical Trade. The word "appliances" has been added to the words of the corresponding exclusion in the Order of 1919.

Corset Steels and Busks (Paragraph 3 (c) of definition).—These are generally manufactured under conditions bringing them within the scope of the Stamped or Pressed Metal-Wares Trade and they are covered by Sections (3) and (4) of the Appendix to the Stamped or Pressed Metal-Wares Order, 1924. The work in question is the manufacture of corset steels and busks up to and including capping. Any subsequent operations such as the covering of the completed steels and busks with cloth or with a composition preparatory to inserting them into corsets, is treated as a part of the manufacture of corsets and is therefore included with the Corset Trade as defined.

DESCRIPTION OF THE CORSET TRADE CONTAINED IN THE TRADE BOARDS (CORSET ORDER), 1919.

- (a) "The manufacture of Corsets, Stays, Children's Corset Bodices, Infants' Stay Bands, Bust Confiners, such as Brassieres and Bandeaux, when boned or with elastic webbing in their construction.
- (b) The manufacture of Support or Abdominal Belts and similar articles, except when made in association with or in conjunction with the manufacture of Surgical Instruments.
- (c) The assembling of Stocking Suspenders in conjunction with or in association with the manufacture of any of the above-mentioned articles.
- (d) All Warehousing, Packing, or other operations incidental to or appertaining to the manufacture of any of the above-mentioned articles.
