- N.B.—These regulations are liable to alteration from time to time. Competitions do not take place at fixed intervals, but are held as occasion arises.

1. Candidates must have attained the age of 25 on a date to be fixed in respect of the competition in which they are to take part, but must not have attained 30 years of age on that date.

Candidates who have served or are serving in the Navy, Army or Air Force may deduct from their actual age, for this purpose, any time during which they have so served, but not exceeding 5 years.

2. Candidates must be natural-born British subjects and sons of fathers also natural-born British subjects; provided that exception may be made in the case of candidates serving in a civil situation to which they were admitted with the certificate of the Civil Service Commissioners, and provided that exception may be made as to the father in the case of candidates who have served in His Majesty's Armed Forces during the Great War between the 4th August 1914 and the 11th November 1918.

No person will be eligible who obtained from any tribunal established under the Military Service Acts, 1916 to 1918, exemption from service in His Majesty's Forces under those Acts on the ground of a conscientious objection to the undertaking of military service, or, although not so exempted, declined to comply with obligations imposed upon him by those Acts.

4. Persons holding situations in the Civil Service must obtain the permission of the authorities of their Department to apply for appointment.
