Opium Regulations, 1921, and by Regulation 12 of the Dangerous Drugs Regulations, 1921, as amended by Regulation 5 of the Dangerous Drugs Regulations, 1926, I hereby give notice that I withdraw as from to-day's date, from the said Dr. Tyler Pleydell Carter, the authorisation granted by the said Regulations to duly qualified medical practitioners to be in possession of and supply raw opium and the drugs to which Part III. of the Dangerous Drugs Act, 1920, applies:

And I also direct, as from the same date, that the exception in Regulation 4 of the Dangerous Drugs Regulations, 1921, which permits dangerous drugs to be supplied on a prescription given by a duly qualified medical practitioner shall not apply in respect of prescriptions given by Dr. Tyler Pleydell Carter.
