#### TENDERS FOR TREASURY BILLS.

Lords Commissioners of 1. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

#### Whitehall, October 21, 1927.

His Majesty The KING has been graciously pleased to award the Edward Medal to Lewis Miller, in recognition of his gallantry in the following circumstances:

On the 7th September 1927 the steamship "Endymion" was being unloaded in the City Docks, Bristol, and was lying about two or three feet away from the quay side. The cargo was being discharged by means of a crane which lifted the sacks from the ship to a platform about 20 feet above the quay level. C.V.O., and G. W. M'O. C have been appointed Naval the King in the places of Domvile, C.B., C.M.G., A. Maclean, C.B., C.V.O., D.S. moted to Flag rank, to date 2nd July 1927, respectively.

A man named Johns who was assisting to pull the sacks inwards from the crane to the platform was struck by a sack and fell from the platform to the quay wall and then rolled into the water between the quay side and the ship. On observing Johns fall into the water Miller immediately jumped in and held him up by means of the chains at the water level until Miller then fastened a rope was lowered. Johns to the rope and first Johns and then Miller were pulled out of the water. There is no doubt that Miller was fully aware of the risk of being crushed between the wall and the ship, and of the difficulty and danger of rescuing Johns in the confined space. The Coroner, when holding an inquest on Johns, who subsequently died as the result of his injuries, expressed very high admiration of Miller's conduct and the jury also highly commended his action. This is the sixteenth occasion on which Miller has rescued persons from the water.
