His Majesty The KING has been graciously pleased to award the Edward Medal to Archibald Burton in recognition of his gallantry in the following circumstances:—

At about 3 a.m. on 12th November 1927, two miners, Burton and Gleaves, were engaged in inserting timbers at the Burley Colliery, Apedale, Staffordshire, when, without warning, a fall of roof occurred which pinned Gleaves by the feet, and extinguished the lamps of both In complete darkness Burton succeeded in locating Gleaves but, finding that he was unable to release him, groped about for timber, and having found it, succeeded in erecting a shield to protect his comrade from further falls. He then left to fetch lamps and assistance. As he was leaving a further fall occurred which buried Gleaves to the hips. Burton travelled some 150 yards, including some steep inclines, in complete darkness before he could get a lamp and send for assistance. Having secured a lamp, he returned to the scene of the fall and was soon joined by another miner, Moss. Together these two placed more timber in position to protect the imprisoned man. They were then joined by others who assisted in the work of clearing the fall. They had worked their way along under the protecting timber to Gleaves' feet when they had to withdraw on account of the imminence of another fall. This further fall was heavier than the previous two, and completely buried Gleaves, breaking all the protecting timber except that originally erected by Burton. No further falls occurred, and after between four and five hours' work the imprisoned man was extricated.

Burton, in waiting to erect a protection for his trapped comrade, undoubtedly saved Gleaves' life and gravely imperilled his own.

REPORT OF THE STANDING COMMITTEE.

With reference to the Notice which was published in the London, Edinburgh, and Belfast Gazettes of the 2nd September 1927, regarding of Trade and the Civil Service Commissioners,

Civil Service Commission, June 12, 1928.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:—

REGULATIONS FOR THE APPOINTMENT OF OFFICIAL RECEIVERS AND ASSISTANT OFFICIAL RECEIVERS IN THE BANKRUPTCY (HIGH COURT) AND COMPANIES (WINDING-UP) DEPARTMENTS AND IN SALARIED PROVINCIAL BANKRUPTCY OFFICES OF THE BOARD OF TRADE.

These Regulations are liable to alteration from time to time.

- 1. When the Board of Trade think it desirable that persons not on the permanent staff of the Board should be admitted to compete together with permanent officers of the Department for appointment to the above posts, they will take such steps as they think most appropriate by public advertisement in the Press or otherwise to make known the existence of the vacancies, and the Civil Service Commissioners will satisfy themselves that the steps taken have been such as to secure all desirable publicity. The advertisement will fix the last day on which applications can be received, and the date by which the age-limits will be reckoned. The Board of Trade will send a notice of the vacancies to the authorities of other Departments having professional legal or accounting staff.
- 2. Application will be addressed to the Board of Trade on the appropriate form. After the last day for application has been reached the Board will scrutinise all the applications received and recommend to the Commissioners such candidates as appear to them best qualified for the duties. They will at the same time forward to the Civil Service Commissioners the application forms of the candidates recommended, together with the application forms of any candidates not recommended who are employed in a Government Department; and the list of candidates to be interviewed by the Selection Board will then be settled by agreement between the Board of Trade and the Civil Service Commissioners,

who may, if dissatisfied with the candidates recommended, take such steps in consultation with the Department as they may think fit to obtain other candidates.

3. Candidates recommended by the Board of Trade and accepted by the Civil Service Commissioners will be summoned to an interview before a Selection Board, who will select for the vacancies existing those candidates who appear to them to possess the qualifications most suited to the posts to be filled. The Selection Board will usually comprise representatives of the Civil Service Commission and of the Board of Trade.

Until further notice, and other things being equal, preference will be given by the Selection Board to candidates who are debarred from more active employment by a physical impairment due to the War and not of a nature to interfere with the discharge of the duties of the post. Other things being equal and subject to this preference, preference will also be given to candidates who have served in His Majesty's Forces between 4th August 1914 and 11th November 1918, and among these preference will be given to such as have served or are serving in a Government Department over candidates without such service.

- 4. Candidates must have attained the age of 30 and must not have attained the age of 45 (50 in the case of permanent officers of the Board of Trade) on a date to be fixed in respect of the competition in which they are to take part. The upper age limit may, however, be extended in favour of a candidate who has served in His Majesty's Forces between the 4th August 1914 and the 11th November 1918, and is or has been employed in a Government Department or under the Board of Trade as a Non-Salaried Official Receiver in Bankruptcy.
- 5. Candidates should in general have legal or accountancy qualifications, but the Board of Trade may recommend other applicants whom they consider to have special qualifications for the post. Women candidates must be unmarried or widows, and will be required to vacate their appointments on marriage.
- 6. No person will be eligible for appointment who is not a natural-born British subject, and the child of a father also a natural-born British subject, provided that exception may be made in the case of candidates serving in a civil situation to which they were admitted with the certificate of the Civil Service Commissioners, and provided that exception may be made as regards the father in the case of candidates who served in His Majesty's Armed Forces during the Great War between the 4th August 1914 and the 11th November 1918.
- 7. No person will be eligible who obtained from any tribunal established under the Military Service Acts, 1916 to 1918, exemption from service in His Majesty's Forces under those Acts on the ground of a conscientious objection to the undertaking of military service or, although not so exempted, declined to comply with obligations imposed upon him by those Acts.
- 8. Persons holding situations in the Civil Service must obtain the permission of the authorities of their Department to apply for appointment.

No person actually serving in the Army, Navy or Air Force will be eligible for consideration unless he produces, when called upon to do so, the permission of his Commanding Officer to apply for appointment, dated before his appearance before the Selection Board, and given in accordance with such orders as may from time to time be issued.

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commissioners.

- 9. The appointment of selected candidates will be subject to their satisfying the Civil Service Commissioners of their eligibility in respect of age, nationality, health and character, and will not be confirmed unless and until they have passed the prescribed period of probation to the satisfaction of the Department.
- 10. Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons will disqualify them for appointment. The Selection Board will disregard spontaneous recommendations from persons who are not personally acquainted with the candidate's work.
- 11. Candidates selected for appointment will be required to pay a fee of £8.
