#### LOCAL GOVERNMENT (SCOTLAND) ACTS.

COUNTY COUNCIL ELECTORAL DIVI-SIONS OF RENFREWSHIRE.

ORDER BY THE SECRETARY OF STATE.

Whereas by the Order of the Secretary for Scotland, dated the 29th May 1913, the portion of the Parish of Cathcart situate in the County of Renfrew was divided into two Electoral Divisions called the Cathcart North and Cathcart South Electoral Divisions;

And whereas by the Order of the Boundary Commissioners for Scotland, dated the 29th September 1891, determining the contents and boundaries of the Electoral Divisions of the County of Renfrew, a certain portion of the Parish of Eastwood was formed into an Electoral Division called the Thornliebank Electoral Division;

And whereas by the Order of the Secretary for Scotland, dated the 29th May 1913, the portion of the Parish of Eastwood, exclusive of the portions thereof included within the limits of the Electoral Division of Thornliebank and the Citv of Glasgow, was divided into two Electoral Divisions called the Giffnock and Eastwood Electoral Divisions;

And whereas by the Order of the Secretary for Scotland, dated the 18th February 1895, a certain portion of the Abbey Parish was divided

into two Electoral Divisions called th. Hilet and Elderslie Electoral Divisions;

And whereas by the Order of the Secretary for Scotland, dated the 4th March 1895, the said Abbey Parish was united with the Parish of Paisley as then existing, and with a portion of the Parish of Renfrew, to form a new Parish called the Parish of Paisley;

And whereas by the Order of the Secretary for Scotland, dated the 30th July 1907, the portion of the Parish of Paisley exclusive of the portions included within the limits of the Burgh of Paisley and of the Police Burgh of Johnstone and of the Police Burgh of Barrhead and of the Electoral Divisions of Hurlet and Elderslie was divided into two Electoral Divisions called the Cardonald and Paisley Electoral Divisions;

And whereas by the Order of the Secretary for Scotland, dated the 29th May 1913, the portion of the Parish of Renfrew situate in the County of Renfrew which was outwith the limits of the Burgh of Renfrew was divided into three Electoral Divisions called the Scotstounhill, Yoker West and Yoker East Electoral Divisions;

And whereas by the Order of the Secretary for Scotland, dated the 29th May 1913, the number of County Councillors for the County of Renfrew was fixed at 43;

And whereas by the Glasgow Boundaries Act, 1925, the boundaries of the City and Royal Burgh of Glasgow were extended so as to include the whole areas comprised by the Electoral Divisions of Scotstounhill and Yoker East and portions of the areas comprised by the Electoral Divisions of Cathcart North, Eastwood, Thornliebank, Hurlet, Cardonald, and Yoker West, all areas thus brought within the boundaries of the said City and Royal Burgh of Glasgow thereafter forming part of the County of Lanark;

And whereas the County Council of the County of Renfrew have represented to me that by reason of the change of circumstances caused by the extension of the boundaries of the City and Royal Burgh of Glasgow by the Glasgow Boundaries Act, 1925, and the change of circumstances in respect of the population and annual value of the Giffnock Electoral Division, it is desirable to alter the description, contents and boundaries of certain of the Electoral Divisions in the Parishes of Cathcart, Eastwood, Paisley and Renfrew;

And whereas I am of opinion that it is

expedient to give effect to the representation of the County Council;

Now therefore I, the undersigned, one of His Majesty's Principal Secretaries of State, in virtue of the powers conferred on me by Section 51 of the Local Government (Scotland) Act, 1889, do hereby order as follows:

1.—The number of County Councillors for the County of Renfrew shall be reduced from 43 to 41.

II.—The Order of the Secretary for Scotland, dated the 29th May 1913, in so far as relating to the Parish of Cathcart is hereby recalled, and the portion of the said Parish situate in the County of Renfrew shall be divided into two County Council Electoral Divisions having the following names and contents, that is to say: —

Cathcart (North)	That part of the Paish of Cathcart which is included within the following boundaries, viz.:—Commencing at the Carmunnock Road south of Aitkenhead House at the point where the boundaries of the City of Glasgow, the County of Lanark and the County of Renfrew meet, thence proceeding in a westerly direction along the boundary between the City of Glasgow and the County of Renfrew to the eastern boundary of the Parish of Eastwood at Muirend, thence following the boundary between the Eastwood and Cathcart Parishes in a southerly direction to the east side of the Lanarkshire and Ayrshire section of the London, Midland and Scottish Railway south west of Williamwood, thence passing in an easterly direction in a straight line to a point on the Clarkston Road just south of Williamwood South Lodge, thence passing along a farm service road in an easterly direction and continuing in the same direction along the northern boundary of enclosure 372 on the Ordnance Survey Map (Ren- frewshire) 1913, to meet the White Cart Water, thence passing in a northerly direction along the boundary between the County of Renfrew and the County of Lanark to the point of commencement.
Cathcart (South).	The remainder of the Parish of Cathcart so far as situate in the County of Renfrew.

III.—The Order of the Boundary Commissioners for Scotland, dated the 29th September 1891, dealing with the Electoral Divisions of the County of Renfrew, in so far as relating to the Electoral Division of Thornliebank, and the Order of the Secretary for Scotland, dated the 29th May 1913,

so far as relating to the Giffnock and Eastwood Electoral Divisions, are hereby recalled, and the portion of the Parish of Eastwood situate in the County of Renfrew shall be divided into four County Council Electoral Divisions having the following names and contents, that is to say:—

Giffnock (North).	That part of the Parish of Eastwood which is included within the following boundaries, viz.:—Commencing in the north east at a point near Muirend which is the junction of the boundaries of Eastwood and Cathcart Parishes and the City of Glasgow, thence following in a southerly direction the boundary between Eastwood and Cathcart Parishes to the point where this boundary meets the road from Giffnock to Clarkston known as the Eastwoodmains Road, thence following that road in a westerly direction to a point opposite the east lodge of Rouken Glen Park, thence following in a northerly direction the road to Giffnock Colliery past the Wood Farm to the point where that road meets the road from Thornliebank to Giffnock known as the Burnfield Road, which forms at that point the boundary between the City of Glasgow and the County of Renfrew, and following that boundary to the point of com- mencement.

That part of the Parish of Eastwood which is included within the follow- ing boundaries, viz.:—Commencing in the north east at the point where the boundary of Eastwood and Cathcart Parishes crosses the road from Giffnock to Clarkston known as the Eastwoodmains Road, thence in a southerly direction following the boundary between Eastwood and Cath- cart Parishes to the point of junction of Eastwood Parish, Cathcart Parish and Mearns Parish, thence following the boundary between East- wood Parish and Mearns Parish to the Kilmarnock Road north west of Roddinghead Hill, thence following the Kilmarnock Road in a northerly direction to its junction with the Davieland Road, thence following the Davieland Road in a north westerly and northerly direction to the road between Thornliebank and Giffnock known as the Eastwoodmains Road, thence following that road in an easterly direction to the point of com-						
Thornliebank.	That part of the Parish of Eastwood which is included within the following boundaries, viz.:—Commencing in the north east at a point on the London Midland and Scottish Railway, East Kilbride Branch, south east of Burnfield, being a point in the southern boundary of the City of Glasgow, thence following the City boundary in a generally westerly direction till it meets a point on the branch line of the London Midland and Scottish Railway to Speirsbridge, thence following along said line in a southerly direction to meet the Main Road at Speirsbridge, thence north- wards along this road to the Eastwoodmains Road, thence along this road to a point opposite the East Lodge of Ruken Glen Park, thence follow- ing in a northerly direction the road to Giffnock Colliery past the Wood Farm to the point of commencement.

IV.—The Order of the Secretary for Scotland, dated the 18th February 1895, so far as relating to the Abbey Parish, and the Order of the Secretary for Scotland, dated the 30th July 1907, so far as not recalled by the Order of the 29th May 1913, are hereby recalled, and the portion of the Parish of

Paisley exclusive of the portions included within the limits of the Burgh of Paisley and of the Police Burgh of Johnstone and of the Police Burgh of Barrhead shall be divided into three County Council Electoral divisions having the following names and contents, that is to say:—

Hurlet and Oldhall.	(1) That part of the Parish of Paisley which is included within the following boundaries, viz.:—Commencing in the north east at a point of junction of the Parliamentary boundary of the City of Glasgow with the Paisley Parish boundary at the east end of the enclosure marked Hillington Wood, thence passing in a southerly direction along the boundary between the City of Glasgow and the County of Renfrew to the Glasgow and 'Kilmannock Joint Railway near Waterside, thence following the east boundary of Paisley Parish in a southerly and subsequently in a north westerly direction to meet the boundary of the Police Burgh of Barrhead at Dubbs Road, thence following the boundary of Paisley Parish till it reaches Cross Stobs, thence passing in a northerly direction along the road from Paisley boundary in a northerly direction along the Paisley Burgh boundary near Dykebar House, thence following the Paisley Burgh boundary in a north east of Gallowhill where the Paisley Burgh boundary reaches the Renfrew Parish boundary, thence following the Paisley boundary to the point of commencement. Paisley.	The remainder of the Parish of Paisley exclusive of the portions included within the limits of the Burgh of Paisley and of the Police Burgh of Johnstone and of the Police Burgh of Barrhead.						

V.-The Order of the Secretary for Scotland, dated the 29th May 1913, so far as not recalled by Articles 11. and III. of this Order, is hereby recalled, and the portions of the Parish of Renfrew situate in the

County of Renfrew exclusive of the portion included within the limits of the Burgh of Renfrew shall form one County Council Electoral Division called the Renfrew Electoral Division.

# COUNTY OF ANGUS (FORMERLY FORFAR).
