WHEREAS there was this day read at the VV Board a Memorial from the Right Honcurable the Lords Commissioners of the Admiralty, dated the 22nd day of October 1928 (C.W. 5650 28), in the words following, viz.:

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, o other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, or to the widow or any relative of a deceased Officer, Seaman or Marine, shall be paid in such manner, and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas, under various Orders in Council, provision is made for the payment of gratuities to Officers of Your Majesty's Naval and Marine Forces on retirement or discharge, and of allowances to the children and brothers and sisters of deceased Officers:

"And whereas we consider it undesirable, as a general rule, that these gratuities and allowances should be paid direct to persons under the age of 21 years:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to authorize us, at our

ances to the parent or guardian of the Officer or child, or to such other person as we may think fit."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

V HEREAS by Section 659 of the Merchant Shipping Act, 1894 (which is a Section in Part XI, of that Act), it is (among other things) enacted that His Majesty may, by Order in Council, fix the establishments to be maintained by each of the General Lighthouse Authorities, on account of the services of lighthcuses, buoys and beacons, or the annual or cther sums to be paid cut of the Mercantile Marine Fund in respect of these establishments, and that an increase of any establishment or part of an establishment so fixed shall not be made without the consent of the Board of Trade:

And whereas by Section 1 of the Merchant Shipping (Mercantile Marine Fund) Act, 1898, discretion, to pay such gratuities and allow- lit is (among other things) provided that

references in Part XI of the Merchant Shipping Act, 1894, to the Mercantile Marine Fund shall be construed as references to the General Lighthouse Fund by the now reciting Act constituted:

And whereas by Orders in Council made on the 14th day of December 1922, the 16th day of December 1925, and the 22nd day of March 1928, respectively, in pursuance of the above recited powers, the clerical and engineering establishments which might be maintained by the Corporation of the Trinity House of Deptford Strond (hereinafter referred to as "the Corporation") being one of the General Lighthouse Authorities referred to in the Merchant Shipping Act, 1894, and the amount of the salaries to be paid to the officers of the said establishments were duly fixed:—

And whereas it is expedient that the engineering establishment of the Corporation should be varied in manner hereinafter appearing:

And whereas it has been made to appear to IIis Majesty that the Board of Trade have consented to such variation:

Now, therefore, His Majesty, by virtue of the power vested in Him by the Merchant Shipping Act, 1894, and of any other powers Him thereunto enabling, and by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, as follows:—

- 1. This Order may be cited as the Trinity House (Variation of Establishment) (No. 2) Order, 1928.
- 2. In addition to the posts specified in the before-mentioned Orders in Council there shall, as from the 1st day of November 1928, be included in the engineering establishment of the Corporation a post of Marine Engineer Inspector with a salary commencing at £300 per almum, and rising by annual increments of £10 to a maximum of £350 per annum.
- 3. The salary payable under the provisions of this Order shall be paid out of the General Lighthouse Fund.

WHEREAS His Majesty the King has power and jurisdiction in the territories of South Africa known as Northern Rhodesia:

And whereas by an Order of His Majesty in Council bearing date the 16th day of July 1914, and entitled "The Northern Rhodesia Naturalisation Order in Council, 1914," (hereinafter referred to as the Principal Order) provision was made for the grant of letters of naturalisation to aliens in Northern Rhodesia:

And whereas it is expedient to amend the said Order by the addition of the provisions hereinafter contained:

Now, therefore, His Majesty is pleased, by and with the advice of Ilis Privy Council, to order, and it is hereby ordered, as follows:—

- I. This Order may be cited as "The Northern Rhodesia Naturalisation Order in Council, 1928," and shall be read and construed as one with the Principal Order.
- II. A person to whom letters of naturalisation have been granted in Northern Rhodesia under the Principal Order and who, when in any foreign state and not under disability, by obtaining a certificate of naturalisation or by any other voluntary and formal act, becomes naturalised therein, shall thenceforth be deemed to have ceased to possess the local status of British subject in Northern Rhodesia, and the wife and evry minor child of that person shall thereupon also cease to possess that status.
- III.—(1) Where the Governor is satisfied that letters of naturalisation granted under the Principal Order have been obtained by false representation or fraud, or by concealment of material circumstances, or that the person to whom such letters are granted has shown himself by act or speech to be disaffected or disloyal to His Majesty, the Governor shall, by order, revoke such letters.

(2) Without prejudice to the foregoing provisions the Governor shall by order revoke letters of naturalisation in any case in which he is satisfied that the person to whom such letters were granted either:—

(a) has during any war in which Ilis Majesty is engaged unlawfully traded or communicated with the enemy or with the subject of an enemy state, or been engaged in or associated with any business which is to his knowledge carried on in such manner as to assist the enemy in such war; or

(b) has within five years of the date of the grant of such letters been sentenced by any court in His Majesty's dominions or in a British Protectorate to imprisonment for a term of not less than twelve months, or to a term of penal servitude, or to a fine of not less than one hundred pounds; or

(c) was not of good character at the date of the grant of such letters; or

- (d) has since the date of the grant of such letters been for a period of not less than seven years ordinarily resident out of Northern Rhodesia otherwise than as a representative of a British subject, firm, or company carrying on business, or an institution established, in Northern Rhodesia or in His Majesty's dominions, or in the service of the Crown, and has not maintained substantial connection with Northern Rhodesia; or
- (e) remains according to the law of a state at war with His Majesty a subject of that state:

and that (in any case) the continuance of such letters is not conducive to the public good.

- (3) The Governor may, if he thinks fit, before making an order under this article refer the case for such inquiry as is hereafter specified.
- (4) An inquiry under this article shall be held by a committee constituted for the purpose by the Governor presided over by a person appointed by the Governor and shall be conducted in such manner as the Governor may direct.

Provided that any such inquiry may, if the Governor thinks fit, instead of being held as aforesaid be held by the High Court, and the practice and procedure on any inquiry so held shall be regulated by rules of court.

A committee appointed under this article shall have all such powers, rights and privileges as are vested in the High Court or in any judge thereof on the occasion of any action, in respect of the following matters:-

- (a) the enforcing the attendance witnesses and examining them on oath affirmation, or otherwise, and the issue of a commission or a request to examine witnesses abroad: and
- (b) the compelling the production of documents; and

(c) the punishing of persons guilty of con-

and a summons signed by one or more members of the committee may be substituted for and shall be equivalent to any formal process capable of being issued in any action for enforcing the attendance of witnesses and compelling the production of documents.

(5) Where the Governor revokes letters of naturalisation, the revocation shall have effect from such date as the Governor may direct, and thereupon the letters shall be given up and cancelled, and any person refusing or neglecting to give up such letters shall be liable on summary conviction to a fine not exceeding one hundred pounds.

IV.—(1) Where letters of naturalisation are revoked the Governor may by order direct that the wife and minor children (or any of them) of the person whose letters are revoked shall cease to possess the local status of British subject in Northern Rhodesia and the wife or child, as the case may be, shall thereupon be regarded as an alien within the limits of Northern Rhodesia, but except where the Governor directs as aforesaid, the local status of British subject in Northern Rhodesia possessed by the wife and minor children of the person whose letters are revoked shall not be affected by the revocation, and they shall continue to possess the local status of British subject in Northern Rhodesia: Provided that

(a) it shall be lawful for the wife of any such person within six months after the date of the order of revocation to make a declaration of alienage, and thereupon she and any minor children of her husband and herself shall cease to possess the local status of British subject in Northern Rhodesia: and

- (b) the Governor shall not make any such order as aforesaid in the case of a wife who was at birth a British subject, unless he is satisfied that if she had held letters of naturalisation in her own right the letters could properly have been revoked under this Order and the provisions of this Order as to referring cases for inquiry shall apply to the making of any such order as they apply to the revocation of letters of naturalisation.
- (2) The provisions of this article shall, as respects persons affected thereby, have effect in substitution for any other provisions of the Principal Order as amended by this Order as to the effect upon the wife and children of any person where the person ceases to possess the local status of British subject in Northern

Rhodesia, and such other provisions shall accordingly not apply in any such case.

(3) Where letters of naturalisation are revoked the former holder thereof shall be regarded within the limits of Northern Rhodesia as an alien and as a subject of the state to which he belonged at the time the letters were granted.

CENTRAL CHANCERY OF THE ORDERS OF KNIGHTHOOD.

St. James's Palace, S.W.1, 9th November 1928.

The KING has been graciously pleased to approve of the Award of the Medal of the Military Division of the Most Excellent Order British Empire to the underthe mentioned:-

For Gallantry.

Leading Aircraftman Walter 363339 Arnold, Royal Air Force, for conspicuous gallantry displayed at Digby Aerodrome on the 20th June 1928.

This airman was a passenger in a machine which was wrecked upon landing and immediately caught fire. Arnold extricated himself from the burning wreckage and, although fully aware of the grave risk he was taking, re-entered the flames and succeeded in dragging the pilot, who was unconscious and very severely injured, to a position of safety. Arnold sustained burns to his face, neck and hands, and his prompt and courageous action undoubtedly saved the pilot's life, since the burning petrol spread rapidly and rendered any subsequent approach to the wreckage impossible.

TENDERS FOR TREASURY BILLS.

- 1. Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief

Cashier's Office, Bank of England.

TRADE BOARDS ACTS, 1909 AND 1918.

The Trade Boards (Hollow-Ware Making)
Order, 1928.

The Minister of Labour hereby gives notice that he has made a Special Order dated 26th October 1928, altering the description of the trade contained in the Appendix to Order III. of the Schedule to the Trade Boards Provisional Orders Confirmation Act, 1913, by substituting the following description:—

APPENDIX.

- 1. Subject to the provisions of this Appendix the Hollow-ware Making trade consists of the following operations:—
- (a) All work in connection with:—
 - (i) the manufacture from sheet iron or sheet steel (hereinafter called black plate of articles of hollow-ware or parts thereof;

(ii) the manufacture of baths and dustbins from black plate or from black plate coated with any metal, of an average thickness not exceeding .0392 of an inch (200 Birmingham Cauga)

inch (20 Birmingham Gauge);
(iii) the manufacture of kegs, drums,
tapers, taper-necked cans and
painters' pots, or parts thereof:—
from black plate of less than .125

of an inch thickness or from black plate coated with any metal and of an average thickness exceeding .01745 of an inch (27 Birmingham Gauge) but less than .125 of an inch:

and the repair thereof;

- (iv) the manufacture of boxes, canisters and bottles, or parts thereof from black plate whether coated or not with any metal when carried on in an establishment, branch or department mainly engaged in the work specified in paragraph 1 (a) (iii) hereof:
- (v) the manufacture of kegs, drums, taper-necked tapers, cans painters' pots, or parts thereof from black plate coated with any metal and of an average thickness not exceeding .01745 of an inch (27 Birmingham Gauge) when carried on in an establishment, branch or departn ent mainly engaged in the work specified in paragraph 1 (a) (iii) hereof;

and the repair thereof;

- (vi) the manufacture from any iron or steel of forged, stamped or pressed mountings or fittings, or parts thereof, for articles specified in paragraph 1 (a) (i), (ii) and (iii) hereof, when done by workers wholly or mainly so engaged, or in association or conjunction with the manufacture specified in paragraph 1 (a) (i), (ii) and (iii) hereof.
- (b) All work in a tin box establishment in connection with-
 - (i) the manufacture of boxes, canisters and bettles, or parts thereof from black plate whether coated or not with any metal;
 - (ii) the manufacture of kegs, drums, taper-necked tapers, cans painters' pots, or parts thereof from black plate coated with any metal and of an average thickness not exceeding .01745 cf an inch (27 Bitmingham Gauge); and the repair thereof;

(iii) the manufacture of boxes partly from black plate whether coated or not with any metal and partle from paper, chip, cardboard, pulp-board, or other similar box board;

(iv) the manufacture of any other articles or parts thereof from black plate whether coated or not with any

- (c) All work in connection with the manufacture of cans of a kind ordinarily used to contain petrol.
- 2. Work in connection with the manufacture specified—
- (a) in paragraph 1 (a) hereof includes—

(i) finishing;

- (ii) the work of persons employed in the factory or workshop in counting or weighing materials handed wo kers and articles or parts thereof receive l from workers;
- (iii) packing, writehousing, despatching,

- the work of inside messengers, yardworkers and stokers and work of a similar nature;
- (b) in paragraph 1 (b) and 1 (c) hereof includes finishing.
- 3. Notwithstanding anything in this Appendix the following operations are not operations in the Hollow-ware Making trade-
- (a) Work specified in paragraph 1 (a) hereof when performed in an establishment, branch or department (not being a tin box establishment) mainly engaged on other work and in which the jointing and finishing of articles or parts of articles specified in paragraph 1 (a) hereof are done by workers mainly employed in jointing and finishing other articles;
- (b) the finishing (other than enamelling) of articles or parts of articles specified in paragraph 1 hereof when performed in a department in which the main business carried on is the finishing of articles other than articles specified in paragraph 1 hereof and in which no manufacture specified in paragraph 1 hereof is carried
- (c) packing, warehousing, despatching, the work of inside messengers, yard workers and stokers, and work of a similar nature when performed in an establishment not otherwise engaged on operations in the Hollow-ware Making trade;

(d) the manufacture of baths or dustbins from black plate or from black plate coated with any metal, of an average thickness exceeding .0392 of an inch (20 Birming-

ham Gauge);

(e) the manufacture of baths or dustbins from black plate or from black plate coated with any metal, of an average thickness not exceeding .0392 of an inch (20 Birmingham Gauge) in an establishment, branch or department mainly engaged in operations other than those specified in paragraph 1 (a) hereof or in the manufacture specified in paragraph 3 (d hereof or both in such operations and such manufacture;

(f) the manufacture of component parts of motor vehicles, motor plants, aircraft,

cycles or motor cycles;

(g) the man facture of any article or part of any article when made in an establishment mainly engaged in the manufacture of motor vehicles, motor plants, aircraft, cycles or motor cycles or of comporent parts thereof;

(h) all clerical work other than work specified

in paragraph 2 (a) (ii) hereof;
(i) the making of loose linings for packing cases when such linings cannot be used apart from the packing cases;

- (j) the making of uniform cases, suit and dress cases, bonnet and helmet boxes, handmade cash boxes, deed boxes, dispatch boxes and letter boxes;
- (k) the manufacture of tin rollers, tin roller drums, card cans, coiler cans and other articles for use with textile or other machinery;
- (1) the manufacture of pen b xes in a establishment mainly engaged in pen manufacture:

- (m) the sealing or closing of filled tin boxes | born British subjects; provided that exception and tin canisters;
- (n) the following operations when performed in a tin-box establishment or in connection with the manufacture of cans of a kind ordinarily used to contain petrol;

(i) the receiving, handling, and storing in bulk of raw materials;

- (ii) the work of persons employed in the factory or workshop in counting or weighing materials handed workers and articles or parts thereof received from workers;
- (iii) packing, warehousing and despatch-
- (iv) the work of inside messengers, yard workers and stokers, and work of of a similar nature;
- (v) all processes of lithographic printing and processes of varnishing or lacquering done in connection therewith;
- (p) all work in connection with the maintenance or upkeep of premises, machinery or plant.
- 4. For the purpose of this Appendix the expression of "tin box establishment" means an establishment, branch or department in which the main business carried on is the manufacture specified in paragraph 1 (b) (i) or paragraph 1 (b) (ii) hereof, or paragraphs 1 (b) (i) and 1 (b) (ii) hereof.

The expression "finishing" includes the operations of coating, polishing and cleaning articles.

The Minister has also issued Regulations dated 26th October 1928, under the above Order, with a view to setting up separate Trade Boards for the Hollow-ware, Tin Box and Keg and Drum Sections of the trade. Civil Service Commission, November 9, 1928.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:-

REGULATIONS FOR A COMPETITION FOR POSTS OF MECHANICAL ENGINEERING DRAUGHTSMAN IN WAR DEPARTMENT ESTABLISHMENTS.

- 1. Candidates must have attained the age of 24 years on the 20th December 1928; candidates who become eligible for appointment as a result of this competition will be assigned for unpensionable service if they have attained the age of 50 years on the 20th December 1928; and no offer of appointment will be made to any candidate who has reached the age of 60.
- 2. Candidates must be natural-born British subjects and the sons of fathers also natural-

may be made:-

- (a) In the case of candidates serving in a civil situation to which they were admitted with the certificate of the Civil Service Commissioners.
- (b) In the case of natural-born British subjects who served in His Majesty's Armed Forces in the Great War between 4th August 1914 and 11th November 1918.

(c) In the case of natural-born British subjects who have satisfactorily completed a period of not less than five years' service on full pay in His Majesty's Regular Forces.

Provided also that if the Civil Service Commissioners are satisfied, in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and up-bringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalization or by any other voluntary and formal act.

- The competition will be open to:—
- (a) Draughtsmen who are serving on the 20th December 1928, in a War Department establishment and
- (b) Other Engineering Draughtsmen who have either served in His Majesty's Forces or served at sea and been awarded the British War Medal or the Mercantile Marine War Medal.
- 4. Other things being equal, preference will be given to candidates who served in His Majesty's Forces during the Great War between the 4th August 1914, and the 11th November 1918; and as between candidates with such war service preference will be given to those who have had temporary employment in a Government Department.
- 5. No person will be eligible who obtained from any tribunal established under the Military Service Acts, 1916 to 1918, exemption from service in His Majesty's Forces under those Acts on the ground of a conscientious objection to the undertaking of military service or, although not so exempted, declined to comply with obligations imposed upon him by those Acts.

6. Applications shall be made to the Secretary, Civil Service Commission, on the prescribed form to be obtained from that Department, and completed application forms must be received by the Civil Service Commissioners not later than the 20th December 1928.

7. Candidates will, in the first place, be required to qualify in an examination in Drawing to be held at the offices of the Civil Service Commission, Burlington Gardens, W.1, on the 5th February 1929. This test will be waived in the case of candidates holding one of the following qualifications:-

> A.M.I.C.E.A.M.I. Mech.E., A.M.I.E.E., or
