WHEREAS His Majesty was pleased by His Commission dated the 4th day of December 1928, to nominate and appoint Her Majesty The Queen, His Royal Highness The Prince of Wales, K.G., K.T., K.P., G.C.S.I., G.C.M.G., G.C.I.E., G.C.V.O., G.B.E., His Royal Highness The Duke of York, K.G., K.T., G.C.M.G., G.C.V.O., the Most Reverend Father in God Cosmo Gordon, Archbishop of Canterbury, the Right Honourable Douglas M'Garel, Baron Hailsham, Lord High Chancellor of Great Britain, and the Right Honourable Stanley Baldwin, Prime Minister and First Lord of the Treasury, or any three of them, during His Majesty's illness, to summon and hold on His Majesty's behalf His Privy Council, and to signify thereat His Majesty's approval of any matter or thing to which His Majesty's approval in Council is required:

And whereas there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty,

dated the 3rd day of May 1929 (C.W. 3844/29), in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas Your Majesty was graciously pleased by Your Order in Council bearing date the 2nd day of August 1918, to sanction the grant, at our discretion, of Temporary Commissions as Acting Chaplains to Ministers of Religious Bodies, not in conformity with the Church of England, who rendered full time service in the Royal Navy during the period of the late war:

"And whereas Your Majesty was graciously pleased by Your Order in Council bearing date the 13th day of October 1922, to sanction the continuance of the grant of temporary commissions to such Ministers under the same conditions in time of peace, subject to their being designated 'Temporary Chaplains' and not 'Acting Chaplains';

''And whereas the Reverend Frederick Kerr
M'Clement, D.C.L., M.A., was granted a Temporary Commission as Acting Roman Catholic
Chaptain (now styled 'Temporary Roman
Catholic Chaptain') with seniority of the 2nd
