CIVIL SERVICE.

REGULATIONS dated the sixth day of June 1929 made by the Treasury under Article 6 of the Order in Council dated the 22nd July 1920 with respect to the sick leave pay to be allowed to Civil Servants to whom the provisions of Article 19 of the Order in Council of 10th January 1910 have hitherto been applied.

In pursuance of Article 6 of the said Order of 22nd July 1920 the Treasury hereby make the following Regulations :---

1. Sick leave may be granted by the Head of his Department to any officer to whom these regulations apply subject to the following conditions, viz.:—

(i.) (a) After two days' continuous absence a certificate by a duly qualified medical practitioner shall be furnished stating the cause of such absence; and further medical certificates shall be furnished from time to time thereafter as may be required by the Head of the Department.

(b) If the number of days during which any officer is absent on sick leave in any period of twelve months without such certifi-
