NATIONAL GALLERIES OF SCOTLAND.
(APPLICATION OF TRANSFERRED PROPERTY)
ORDER, 1929.

Whereas by the National Galleries of Scotland (Application of Transferred Property) Order, 1908, it was prescribed that the fund known as the Scottish National Portrait Gallery Decoration Fund should, until otherwise prescribed, be applied for the purpose of decorating the Scottish National Portrait Gallery

Building according to such scheme as should from time to time be determined by the Board of Trustees with the approval of the Secretary for Scotland:

And whereas it has been represented to me by the Board of Trustees that the balance of the fund, which at this date amounts to £950, or thereabouts, is not likely to be required for purposes of further decoration in terms of the said Order, and that part of such balance could be advantageously utilized for the purpose of providing a lift in the said building:

Now therefore I, the Right Honourable William Adamson, One of His Majesty's Principal Secretaries of State, in virtue of the powers conferred on me by Sub-section two of Section six of the National Galleries of Scotland Act, 1906 (6. Edw. 7, c. 50), as read with the Secretaries of State Act, 1926, do hereby prescribe with regard to the said Fund as follows:

A sum not exceeding £850 may be applied out of the said Fund, in accordance with a scheme agreed between the Board of Trustees and H.M. Office of Works, for the purpose of providing a lift in the Scottish National Portrait Gallery Building to serve the Scottish National Portrait Gallery and the National Museum of Antiquities.

This Order may be cited as the National Galleries of Scotland (Application of Transferred Property) Order, 1929.
