PARISHES OF AUCHTERGAVEN AND LOGIEALMOND.

Whereas it has been represented to me by the County Council of the County of Perth that I should issue an Order under Section 51 of the Local Government (Scotland) Act, 1889, and Section 46 of the Local Government (Scotland) Act, 1894, annexing to the Parish of Auchtergaven that portion of the Parish of Logicalmond which lies to the north and northeast of the Shochie Burn.

And whereas, after consulting with the authorities concerned, I am of opinion that it is expedient to give effect to the said representation;

Now therefore I, the undersigned, one of His Majesty's Principal Secretaries of State, do, in virtue of the powers conferred upon me by the Local Government (Scotland) Acts, order as follows:—
