ORDER by the Secretary of State determining the contents and boundaries of the electoral divisions of the County of Dumfries, the number of county councillors for the County and the apportionment of these county councillors between the landward area and the burghs entitled to be represented on the County Council.

THE LOCAL GOVERNMENT (TOWN COUNCIL OF UNITED BURGH OF BONNYRIGG AND LASS-WADE) ORDER (SCOTLAND), 1929, DATED OCTOBER 1929, MADE BY THE SECRETARY OF STATE UNDER SECTION 10 (5) OF THE LOCAL GOVERNMENT (SCOTLAND) ACT, 1929 (19 & 20 GEO. 5, CH. 25).

In pursuance of the powers vested in him by Section 10 (5) of the Local Government (Scotland) Act, 1929, the Secretary of State hereby makes the following Order:-

1.—(1) The Foot-and-Mouth Disease (Infected Areas) Order of 1929 (No. 25) as amended by the Order of the Minister (No. 4759), dated the 11th September 1929, and the Foot-and-Mouth Disease (Infected Areas) Order of 1929 (No. 26), shall be read and have effect as if the Area described in the Schedule to this Order were substituted for the Infected Area described in the Schedule to the last-mentioned Order.

(2) This Article shall come into operation on the eleventh day of October nineteen hundred and twenty-nine.

Release of Infected Area from Restrictions.

2. The Area described in the Schedule to this Order shall cease to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925, as from the eighteenth day of October, nineteen hundred and twenty-nine.

Short Title.

3. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1929 (No. 27).
