COUNTY OF FIFE.

LOCAL GOVERNMENT (SCOTLAND) ACT, 1929.

DISTRICT COUNCIL SCHEME made by the County Council of the County of Fife in accordance with the provisions of Section 25 of the Local Government (Scotland) Act, 1929.

There shall be constituted a District Council for each of the Districts mentioned in Column 1 of the Schedule appended hereto, comprising the County Council Electoral Divisions named in Column 2 of said Schedule. District Councillors shall be elected as indicated in said Schedule for each of the said Electoral Divisions (named in Column 2) or for Wards thereof as shown in Column 3. The number of District Councillors to be elected for each District shall be as shown in Column 4. The County Councillors for the Electoral Divisions comprised in each District shall, in terms of the Act, be ex officio members of the District Council.

TENDERS FOR TREASURY BILLS.

- 1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday the 21st March 1930, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914-1919, to the amount of £30,000,000.
- 2. The Bills will be in amounts of £5000 or £10,000. They will be dated at the option of the Tenderer on any business day from Monday the 24th March 1930 to Saturday the 29th March 1930, inclusive, and will be payable at three months after date.
- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.
- 7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

DANGEROUS DRUGS ACTS, 1920-1925. WITHDRAWAL OF AUTHORITY.

(CHARLES CECIL DUTTON).

Whereas Charles Cecil Dutton, of 105 Main Street, Addingham, Ilkley, in the County of York West Riding, being a person duly regis-tered under the Pharmacy Act, 1868, as amended by the Poisons and Pharmacy Act, 1908. has been convicted of offences against the Dangerous Drugs Acts:

And whereas the said Charles Cecil Dutton cannot, in my opinion, properly be allowed to be in possession of or supply raw opium, coca leaves and Indian hemp, nor to carry on the business of manufacturing, selling or distributing any of the drugs to which Part III. of the Dangerous Drugs Act, 1920, applies:

Now, therefore, after consultation with the Council of the Pharmaceutical Society of Great Britain, and in pursuance of the powers conferred on me by No. 6 of the Raw Opium Regulations, 1921, as extended by the Coca Leaves and Indian Hemp Regulations, 1928, and by No. 7 of the Dangerous Drugs (Consolidation) Regulations, 1928, I hereby give notice that I withdraw, as from to-day's date, from the said Charles Cecil Dutton the authority granted by the said Regulations to persons who lawfully keep open shop for the retailing of poisons to be in possession of and supply raw opium, coca leaves and Indian hemp, to manufacture any extract or tincture of Indian hemp, any preparation, and to carry on the business of retailing, dispensing or compounding the drugs or preparations to which Part III. of the Dangerous Drugs Act, 1920, applies.
