The following are the Regulations to be observed:—

- 1. Peers, Bishops, His Majesty's Lieutenants of Counties, Deputy Lieutenants of Counties, Members of Parliament, Officials connected with the Houses of Parliament, Clergy of all Denominations, and all gentlemen other than those mentioned in the following Regulations, should communicate with the Comptroller, Lord Chamberlain's Office, St. James's Palace. No applications can be received from gentlemen in the foregoing categories wishing to be presented. Their names must be forwarded by the gentlemen making the presentation.
- 2. All gentlemen referred to in the following Regulations, wishing to attend or be presented at a Levée, should make a written application as directed below.
- 3. All Officers, whether on the active or retired lists of the Royal Navy and the Royal Marines, will communicate with and obtain their cards, whether for attendance or presentation, from the Private Secretary to the First Lord of the Admiralty.
- 4. All Officers on the active, retired, and reserve lists of the Regular Army, the Militia, and the Territorial Army, except Officers of the Household Cavalry and the Brigade of Guards, and except Officers of the Indian Services and Indian Army and Colonial Service and Colonial Forces, will communicate with and obtain their cards, whether for attendance or presentation, from the Under-Secretary of State, War Office.

Officers of the Household Cavalry and the Brigade of Guards will communicate, through their Regimental Headquarters, with the Comptroller, Lord Chamberlain's Office, St. James's Palace, to obtain their cards for attendance or presentation.

- 5. All Officers on the active list of the Royal Air Force and Officers of the Special Reserve and Auxiliary Air Force will obtain their cards, for attendance or presentation, through the usual channels. Officers of the Reserve of Air Force Officers and Officers on the retired list of the Royal Air Force will communicate with and obtain their cards, whether for attendance or presentation, from the Secretary, Air Ministry, Kingsway, W.C.2.
- 6. All Officers of His Majesty's Civil Service will communicate with and obtain their cards for attendance or presentation from the Department under which they serve.
- 7. All Officers of the Indian Services and of the Indian Army, whether on the active or retired lists, will communicate with and obtain their cards for attendance or for presentation, from the Political A.D.C. to the Secretary of State at the India Office, Whitehall.
- 8. All Officers of the Colonial Service and Colonial Forces, whether on the active or retired lists, will communicate with and obtain their cards, whether for attendance or presentation, from the Ceremonial and Reception Secretary, Colonial Office, Whitehall, with the exception of Officers of the local Forces of the self-governing Dominions, who will apply to the Under-Secretary of State, War Office, for their cards for attendance or for presentation, supporting their application in all cases by a credential from Governor-General, the Governor, Officer commanding the local-Forces, or the representative in London of the Dominion concerned.
- 9. Gentlemen connected with the Treasury, the Foreign Office, and other Government Departments will make their applications, whether for attendance or for presentation, through the Private Secretaries to the Ministers of the respective Departments. Gentlemen serving under the Colonial Office will communicate with the Ceremonial and Reception Secretary, Colonial Office.
- 10. Lord Mayors and Mayors, High Sheriffs, Sheriffs, Recorders, Chairmen of Quarter Sessions, Metropolitan Police Magistrates and other Stipendiary Magistrates, and gentlemen connected with the Home Office, will make their applications, whether for attendance or for presentation through the Ceremonial and Reception Secretary, Home Office.
- 11. Lord Provosts and Provosts and Conveners of County Councils will make their applications for attendance or for presentation through the Private Secretary to the Secretary of State for Scotland, at the Scottish Office, Whitehall.

Scottish Judges, Law Officers, King's Counsel and Legal Officials in Scotland should make their applications through the Legal Secretary to the Lord Advocate.

12. Chairmen of County Councils, and gentlemen connected with the Ministry of Health, will similarly make their applications through the Private Secretary to the Minister of Health.

MERCHANDISE MARKS ACT, 1926.

In accordance with the provisions of Section 2, Sub-section (4) of the Merchandise Marks Act, 1926, the Board of Trade give notice that in pursuance of an application received by them for the making of an Order in Council to require imported steel shafts for golf clubs to bear an indication of origin, they have made a reference to the Standing Committee appointed by them under the Act in respect thereof.

Attention is called to the fact that, while, under the provisions of the above Act, the Committee must in every case referred to them consider whether the goods should bear an indication of origin at the time of sale or exposure for sale, they may also at their discretion consider and report upon the question whether such goods should bear an indication of origin at the time of importation.

SOUTH-EASTERN COUNTIES OF SCOT-LAND JOINT SANATORIUM BOARD ORDER, 1930, made by the Department of Health for Scotland under Section 64 (3) of the National Insurance Act, 1911.

Whereas by Order dated 12th December 1913 (hereinafter referred to as "the principal Order") made by the Local Government Board for Scotland under subsection (3) of Section 64 (as applied to Scotland by Section 80) of the National Insurance Act, 1911, which Order was amended by the South-Eastern Counties of Scotland Joint Sanatorium Board Order, 1921, and the South-Eastern Counties of Scotland Joint Sanatorium Board Order, 1922 (hereinafter referred to as "the amending Orders"), it is provided that the County Councils of the Counties of Berwick, East Lothian (Haddington), West Lothian (Linlithgow), Midlothian, Peebles, Roxburgh, and Selkirk, shall be combined for

the purposes of (1) providing, furnishing, managing and maintaining a central institution or sanatorium, such institution to include a sanatorium proper, hospital and clearing house or observation wards, and (2) making such other provision as may, subject to the approval of the said Local Government Board, he deemed necessary by the Joint Board constituted in terms of the said Order to be made at or in connection with the said central institution or sanatorium for the treatment, isolation and observation primarily of persons in these Counties suffering from or suspected of tuberculosis, and that the provision of such central institution or sanatorium, and the furnishing, management and maintenance thereof, shall be undertaken by a Joint Board to be called the South-Eastern Counties of Scotland Joint Sanatorium Board (hereinafter referred to as "the Joint Board '')

And whereas by the principal Order provision is made for the direct representation on the Joint Board of Burghs in the said Counties which are small Burghs within the meaning of the Local Government (Scotland) Act, 1929:

And whereas it is provided by Section 11 (8) of the last mentioned Act, that notwithstanding anything in any Order for combining local authorities for the provision of sanatoria and other institutions under subsection (3) of section sixty-four of the National Insurance Act, 1911, no small burgh shall be entitled to receive direct representation on any joint committee, joint board or other body thereby constituted:

And whereas the Department of Health for Scotland have, after consultation with the Joint Board, resolved to amend the principal Order as hereinafter contained:

Therefore the Department of Health for Scotland, by virtue of the powers competent to them under the enactment before referred to and of all other powers enabling them in that behalf, do hereby order as follows:—

1. (1) This Order may be cited as the South-Eastern Counties of Scotland Joint Sanatorium Board Order, 1930, and the principal Order and the amending Orders (hereinafter together referred to as "the existing Orders") shall be read as one with this Order, and the existing Orders and this Order may be cited together as the South-Eastern Counties of Scotland Joint Sanatorium Board Orders, 1913 to 1930.

(2) The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

2. The following paragraphs shall be substituted for paragraphs (2) and (3) of Article 2 of the principal Order:—

"Article 2 (2). The Joint Board shall consist of thirty-nine members, or such other number as the Department may from time to time determine. Such members shall be members of the Combining Authorities and shall hold office only so long as they remain members of the Combining Authorities.

(3) Of the said members, the County Council of the County of Berwick shall appoint three, the County Council of the County of East Lothian shall appoint six, the County Council of the County of Midlothian shall appoint eleven, the County Council of the County of Peebles shall appoint two, the County Council of the County of Roxburgh shall appoint three, the County Council of

the County of Selkirk shall appoint three, and the County Council of the County of West Lothian shall appoint eleven, provided that when it appears to the Department necessary they may readjust the representation of the Combining Authorities on the Joint Board.

3. (1) Paragraph (4) of Article 2 of the Principal Order shall be repealed and paragraphs (5), (6) and (9) of that Article shall be construed accordingly.

(2) Article 2 of the South-Eastern Counties of Scotland Joint Sanatorium Board Order 1922

shall be repealed.

4. Notwithstanding anything in Article 2 (5) of the principal Order, all members of the Joint Board shall go out of office on 15th May 1930, and as soon as may be thereafter the Combining Authorities shall appoint members in terms of Article 2 (3) of the principal Order as amended by this Order. Members so appointed shall hold office until the month of December 1930.

5. At the first meeting of the Joint Board held after 15th May 1930, the members shall elect one of their members to be Chairman for the period to December 1930, and another to be Vice-Chairman for the same period.

6. This Order shall come into operation on 16th May 1930.
