WHEREAS in pursuance of the powers conferred upon Him by the Air Navigation Act, 1920, His Majesty in Council was pleased to make the Air Navigation (Consolidation) Order, 1923, and the Air Navigation (Amendment) Order, 1925, the Air Navigation (Amendment) Order, 1927, the Air Navigation (Amendment) Order, 1928, the Air Navigation (Amendment) (No. 2) Order, 1928, the Air Navigation (Amendment) (No. 3) Order, 1928, the Air Navigation (Amendment) (No. 4) Order, 1928, the Air Navigation (Amendment) (No. 4) Order, 1929, the Air Navigation (Amendment) (No. 2) Order, 1929, and the Air Navigation (Amendment) (No. 3) Order, 1929, amending the first-mentioned Order:

And whereas it is expedient that the first-mentioned Order as so amended (hereinafter referred to as "the principal Order") should be further amended in manner hereinafter appearing:

And whereas the provisions of the Rules Publication Act, 1893, have been complied with:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

1. The following proviso shall be inserted at the end of paragraph 1 of Schedule VI. to the principal Order:—

- "Provided that, where the aircraft has been previously registered in Great Britain and Northern Ireland and the Secretary of State is satisfied—
 - (a) that the certificate of registration last issued in respect of the aircraft lapsed by reason of the sale of the aircraft by the registered owner; and
 - (b) that the registered owner of the aircraft immediately before the sale was the constructor thereof or a dealer in aircraft; and
 - (c) that the aircraft has not been flown since a certificate of registration was last issued in respect thereof, except for the purpose of—
 - (i.) an experiment or test carried out in the ordinary course of construction or in order to obtain a certificate of airworthiness; or
 - (ii.) a demonstration to a prospective purchaser; or
 - (iii.) delivering the aircraft to a purchaser;

the fee chargeable for the issue of the certificate shall be five shillings."

2. The following paragraphs shall be substituted for paragraph 6 of Schedule VI. to the principal Order:—

"6. Subject to the provisions of this paragraph and paragraph 6B of this Schedule, the fees chargeable in respect of the grant of licences for personnel shall be in accordance with the following table—

6B. Where an applicant for the grant or renewal of any licence referred to in paragraph 6 of this Schedule is not required to pass any particular part of the appropriate technical examination or official flying test by reason of his having passed that part on some previous application or for any other reason, the fee chargeable for the technical examination or official flying test, as the case may be, may be reduced by such amount as the Secretary of State may think proper in the circumstances of the case.

6c The fee chargeable in respect of the

issue or renewal of a licence for a competent person under paragraph 11 of Schedule II. to this Order shall be 5s. for technical examination and 5s. for the licence.

6D. The fee chargeable for the issue of a master pilot's certificate shall be 10s."

The Lords Commissioners of His Majesty's Treasury hereby give notice that at a Trial of the Pyx begun at Goldsmiths' Hall in the City of London on the 11th March and concluded on the 7th May 1930, the following Verdicts of the Pyx Jury were delivered to the King's Remembrancer, viz.:—

TRIAL OF THE PYX OF THE LONDON MINT.

VERDICT.

WE, whose names are hereunder written, having been sworn on the eleventh day of March one thousand nine hundred and thirty, before the King's Remembrancer, at Goldsmiths' Hall in the City of London, have made the assays and trials of His Majesty's silver coins in the Pyx of the Royal Mint in London, which, according to accounts produced by the Officers of the Mint, were coined in the

said Mint from the 1st day of January one thousand nine hundred and twenty-nine to the 31st day of December one thousand nine hundred and twenty-nine, both days inclusive. We found that there were no gold coins in the said Pyx. We ascertained the number of coins in each packet produced to us, and that such number corresponded with the number which the Officers of the Mint represented it to contain, and we took one coin from each of such packets of silver coins, making altogether 2 crowns, 82 half-crowns, 68 florins, 70 shillings, 76 sixpences, 4 fourpences, 3 three-pences, 4 twopences and 3 pennies. We then weighed each one pound troy weight (at its standard weight) of the coins so taken out and ascertained that the said coins so bulked were within the remedy as to weight prescribed by the Coinage Acts, 1870 to 1920. We then took for assay one pound troy (at its standard weight) of the coins so weighed comprising 1 crown, 10 half-crowns, 10 florins, 10 shillings, 10 sixpences, 1 fourpence, 1 threepence, 2 twopences, and 1 penny, and we ascertained that the amount of variation from the standard weight allowed under the Coinage Acts, 1870 to 1920, was, for such pound so taken for assay plus three thousandths (+.003) of an ounce on the whole, and that, therefore, such pound troy of silver coins weighed and assayed as aforesaid was on the whole within the variation We then from standard weight so allowed. assayed separately the coins in the pound troy so taken for assay, comparing them with the standard Trial Plate made of pure silver (as prescribed by the Coinage Act, 1920) produced by the Board of Trade, so as to ascertain whether the metal of the said coins was on the whole within the remedy as to fineness prescribed by the Coinage Acts, 1870 to 1920, and we found that the amount of variation from the standard fineness so prescribed was minus two ten thousandths (-.0002) on the whole of the coins in such pound, and that, therefore, the said pound troy of silver coins weighed and assayed as aforesaid was, on the whole, within the variation from fineness allowed under the Coinage Acts, 1870 to 1920. We weighed in bulk the residue of the coins remaining in the said packets of silver coins and we ascertained that they were on the whole within the remedy as to weight allowed under the Coinage Acts, 1870 to 1920, being five hundred and seventy-five thousandths of an ounce (-.575) below the standard weight prescribed by the said Acts.

TRIAL OF THE PYX OF THE PRETORIA BRANCH MINT.

VERDICT.

WE, whose names are hereunder written, having been sworn on the eleventh day of March one thousand nine hundred and thirty, before the King's Remembrancer, at Goldsmiths' Hall in the city of London, have made the assays and trials of His Majesty's gold coins in the Pyx of the Branch Mint at Pretoria in the Union of South Africa, which, according to accounts produced by the Officers of the Mint, were coined in the said Branch Mint from the first day of January one thousand nine hundred and twenty-nine to the thirty-first day of December one thousand nine hundred and twenty-nine, both days inclusive. We ascertained the number of coins in each packet produced to us and that such number corresponded with the number which the officers of the Mint represented it to contain, and we took out one coin from each of such packets of gold coins, amounting altogether to 121 sovereigns or twenty-shilling pieces, and we weighed separately each of the said coins so taken out, and ascertained that they were within the remedy as to weight prescribed by the Coinage Acts, 1870 to 1920. We found that the amount of variation from the standard weight so prescribed was plus one thousandth of an ounce (+ 001 oz.) on the whole of such coins. We then melted all the said gold coins so taken out and separately weighed into an ingot, and assayed such ingot, comparing it with the standard Trial Plate of gold produced by the Board of Trade, so as to ascertain whether the metal of the said ingot was within the remedy as to fineness prescribed as aforesaid, and we found that the amount of variation thereof from the standard fineness so prescribed was minus three hundred thousandths (or -.00003), and that therefore the said metal was within the remedy as to fineness allowed under the Coinage Acts, 1870 to 1920. We weighed in bulk the residue of the said coins remaining in the said packets of gold coins, and we ascertained that they were on the whole within the variation from the standard weight allowed under the Coinage Acts, 1870 to 1920, being eighteen thousandths (- 018) of an ounce below the standard weight prescribed by the said Acts. We then took from such residue five sovereigns and weighed and assayed them separately, and we found that such sovereigns weighed respectively,—the first 123.286 grains, the second 123.283 grains, the third 123.227 grains, the fourth 123.222 grains, the fifth 123.140 grains and that therefore the said sovereigns were respectively the first twelve thousandths of a grain above (+ 012), the second nine thousandths of a grain above (+.009), the third forty seven thousandths of a grain below (-.047), the fourth fifty two thousandths of a grain below (-.052), the fifth one hundred and thirty four thousandths of a grain below (-134), the standard weight prescribed by the Coinage Acts, 1879 to 1920.

We then assayed the said five sovereigns separately, and we found the millesimal fineness of such sovereigns to be, the first 916.72, the second 916.53, the third 916.63, the fourth 916.76, the fifth 916.57, and that therefore the

said sovereigns were respectively,—the first six hundred-thousandths above $(+\cdot00006)$, the second thirteen hundred-thousandths below $(-\cdot00013)$, the third three hundred thousandths below $(-\cdot00003)$, the fourth ten hundred thousandths above $(+\cdot00010)$, the fifth nine hundred-thousandths below $(-\cdot00009)$, the standard fineness prescribed as aforesaid.

TRIAL OF THE PYX OF THE PERTH BRANCH MINT.

VERDICT.

WE, whose names are hereunder written, having been sworn on the Eleventh day of March One thousand nine hundred and thirty, before the King's Remembrancer, at Gold-smiths' Hall in the city of London, have made the assays and trials of His Majesty's gold coins in the Pyx of the Branch Mint at Perth in the State of Western Australia, which, according to accounts produced by the Officers of the Mint, were coined in the said Branch Mint from the First day of January One thousand nine hundred and Twenty-nine to the Thirty-first day of December One thousand nine hundred and twenty-nine, both days inclusive. We ascertained the number of coins in each packet produced to us and that such number corresponded with the number which the officers of the Mint represented it to contain, and we took out two coins from each of such packets of gold coins, amounting altogether to 36 sovereigns or twenty-shilling pieces, and we weighed separately each of the said coins so taken out, and ascertained that they were within the remedy as to weight prescribed by the Coinage Acts, 1870 to 1920. We found that the amount of variation from the standard weight so prescribed was nil of an ounce (nil oz.) on the whole of such coins.

We then melted all the said gold coins so taken out and separately weighed into an ingot, and assayed such ingot, comparing it with the Standard Trial Plate of gold produced by the Board of Trade, so as to ascertain whether the metal of the said ingot was within the remedy as to fineness prescribed as aforesaid, and we found that the amount of variation thereof from the standard fineness so pre-

(or - 00012), and that therefore the said metal was within the remedy as to fineness allowed under the Coinage Acts, 1870 to 1920. We weighed in bulk the residue of the said coins remaining in the said packets of gold coins, and we ascertained that they were on the whole within the variation from the standard weight allowed under the Coinage Acts, 1870 to 1920, being five thousandths (+ 005) of an ounce above the standard weight prescribed by the said Acts. We then took from such residue three sovereigns and weighed and assaved them separately, and we found that such sovereigns weighed respectively,—the first 123.332 grains, the second 123 292 grains, the third 123 272 grains, and that therefore the said sovereigns were respectively the first Fifty-eight thousandths of a grain above (+.058), the second Eighteen thousandths of a grain above (+ 018), the third Two thousandths of a grain below (- 002), the standard weight prescribed by the Coinage Acts, 1870 to 1920.

We then assayed the said three sovereigns separately, and we found the millesimal fineness of such sovereigns to be the first 916.54, the second 916.54, the third 916.51, and that therefore the said sovereigns were respectively,—the first Twelve hundred-thousandths below (-.00012), the second Twelve hundred-thousandths below (-.00015), the third Fifteen hundred-thousandths below (-.00015), the standard fineness prescribed as aforesaid.

TRIAL OF THE PYX OF THE MELBOURNE BRANCH MINT.

VERDICT.

WE, whose names are hereunder written, having been sworn on the Eleventh day of March One thousand nine hundred and Thirty, before the King's Remembrancer, at Goldsmiths' Hall in the City of London, have made the assays and trials of His Majesty's gold coins in the Pyx of the Branch Mint at Melbourne in the State of Victoria, which, according to accounts produced by the Officers of the Mint, were coined in the said Branch Mint from the First day of January One thousand nine hundred and Twenty-nine to the Thirty-first day of December One thousand nine hundred and Twenty-nine, both days

inclusive. We ascertained the number of coins in each packet produced to us and that such number corresponded with the number which the Officers of the Mint represented it to contain, and we took out Five coins from each of such packets of gold coins, amounting altogether to 25 sovereigns or twenty-shilling pieces, and we weighed separately each of the said coins so taken out, and ascertained that they were within the remedy as to weight prescribed by the Coinage Acts, 1870 to 1920. We found that the amount of variation from the standard weight so prescribed was plus one thousandth of an ounce (+.001 oz.) on the whole of such coins. We then melted all the said gold coins so taken out and separately weighed into an ingot, and assayed such ingot, comparing it with the standard Trial Plate of gold produced by the Board of Trade, so as to ascertain whether the metal of the said ingot was within the remedy as to fineness prescribed as aforesaid, and we found that the amount of variation thereof from the standard fineness so prescribed was minus four hundredthousandths (or -.00004), and that therefore the said metal was within the remedy as to fineness allowed under the Coinage Acts, 1870 to 1920. We weighed in bulk the residue of the said coins remaining in the said packets of gold coins, and we ascertained that they were on the whole within the variation from the standard weight allowed under the Coinage Acts 1870 to 1920, being Five thousandths (+ 005) of an ounce above the standard weight prescribed by the said Acts. We then took from such residue two sovereigns and weighed and assayed them separately, and we found that such sovereigns weighed respectively,—the first 123.313 grains, the second 123.202 grains, and that therefore the said sovereigns were respectively the first Thirty-nine thousandths of a grain above (+ 039), the second Seventy-two thousandths of a grain below (- 072), the standard weight prescribed by the Coinage Acts, 1870 to 1920.

We then assayed the said two sovereigns separately, and we found the millesimal fineness of such sovereigns to be, the first 916.55, the second 916.55, and that therefore the said sovereigns were respectively, the first Eleven hundred-thousandths below (-.00011), the second Eleven hundred-thousandths below (-.00011), the standard of fineness prescribed as aforesaid.

WELFARE OF WORKERS IN FACTORIES AND WORKSHOPS.

The Secretary of State for the Home Department hereby gives notice that on the 2nd May 1930 he made an Order under Section 7 of the Police, Factories, &c. (Miscellaneous Provisions) Act, 1916, for securing the welfare of the workers employed in all factories and workshops, or parts thereof, in which are carried on the processes of liming and tanning of raw hides and skins (including the retanning of tanned or partly tanned hides and skins) and processes incidental thereto.

A draft of this Order was issued in August last, and certain objections lodged against the draft were referred, in pursuance of the statutory procedure, to Sir Harold Morris, K.C., as Referee, for settlement. The Report of the Referee has now been received, and the Order as finally made by the Secretary of State is based on that Report.

This Order, which may be cited as the Tanning Welfare Order, 1930, will come into force on 1st July 1930, from which date the Order made by the Secretary of State on the 22nd March 1918 for factories or parts of factories in which bichromate of potassium or sodium is used in tanning by the "two bath" process, will be revoked in so far as it affects factories or parts of factories to which the new Order applies.
