Now, therefore, His Majesty, in pursuance of the powers conferred upon Him by Section 8 (2) of the Dangerous Drugs Act, 1920, is pleased by and with the advice of His Privy Council, to declare and it is hereby declared that Part III. of the Dangerous Drugs Act, 1920, shall henceforth apply to Di-hydromorphinone and its salts and any preparation, admixture, extract or other substance containing any proportion of Di-hydro-morphinone.

MERCHANDISE MARKS ACT, 1926.

MERCHANDISE MARKS (IMPORTED GOODS) EXEMPTION DIRECTION (No. 3), 1930.

In accordance with the provisions of Section 3, sub-section (2) of the Merchandise Marks Act, 1926, the Board of Trade give notice that they have, in pursuance of the powers conferred upon them by the said Section 3, given a Direction in the following terms:-

Whereas by Section 3, sub-section (1) of the Merchandise Marks Act, 1926 (16 & 17 Geo. 5, c. 53), it is provided that if, where an Order in Council has been made under that Act with respect to any goods, it is shown to the satisfaction of the appropriate Department by persons appearing to the Department to have a substantial interest in the matter that the application of the provisions of the Order or of some of those provisions to any particular class or description of those goods has caused or is likely to cause injury or hardship to the said persons or any of them, the Department may direct that the Order or any particular provisions of the Order shall cease to apply to goods of that class or description or shall apply to such goods subject only to such modifications and conditions as the Department think fit, and the Order shall, while the Direction is in force, have effect subject thereto:

And whereas it is provided by Article 15 of the Merchandise Marks (Imported Goods) No. 5 Order, 1929,* that it shall not be lawful to sell or expose for sale in the United Kingdom any imported knitted hose, knitted gloves and other knitted articles of apparel and knitted fabrics made of cotton, wool, silk, artificial silk or mixtures thereof unless they bear an indication of origin;

And whereas it is provided by Article 16 of the same Order that the indication of origin shall be applied as follows :---

(i) Hose.

To be stamped or printed on, or applied by transfer to, one of each pair in a contrasting colour.

(ii) Gloves.

As therein provided.

- (iii) Other articles of apparel.
 (a) To be stamped or printed on each article or applied thereto by transfer in a contrasting colour; or
 - (b) Woven into, or stamped or printed on, or applied by transfer to, a tab of woven material securely sewn to each article.
- (iv) Fabrics.

As therein provided.

And whereas by Article 20 of the same Order, it is provided that Part III. of the Order (which includes the above recited articles) shall come into force on the 1st August 1930;

And whereas the Board of Trade, being the appropriate Department in this case, having considered representations made to them in that behalf by persons appearing to the Board to have a substantial interest in the matter, are satisfied that the application of the said provisions of the Order to the particular classes or descriptions of the goods hereinafter specified is likely to cause hardship to the said persons;

Now therefore the Board of Trade, in pur-

suance of the powers conferred upon them by the said Section 3, hereby direct as follows:-

1. Article 16 of the Merchandise Marks (Imported Goods) No. 5 Order, 1929, shall not apply to knitted hose or other knitted articles of apparel (other than knitted gloves) which were imported before the 17th day of December 1929, and are sold or exposed for sale before the 31st January 1931, and which bear an indication of origin applied by means of a label securely attached by wire or by a metal clip in the following manner:-

(a) Hose.

To one of each pair.

(b) Other articles of apparel (other than gloves).

To each article.

2. This Direction may be cited as the Merchandise Marks (Imported Goods) Exemption Direction No. 3, 1930.

RETAIL BESPOKE TAILORING TRADE BOARD (SCOTLAND).

PROPOSAL TO VARY CERTAIN OVERTIME RATES OF WAGES FOR MALE AND FEMALE WORKERS EMPLOYED ON PIECE-WORK.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 21st April 1927, the Retail Bespoke Tailoring Trade Board (Scotland) hereby give notice that they propose to Vary certain of the Overtime Rates for Male and Female Workers set out in the Schedule to their Notice R.B.S. (4), dated 24th January 1930, in their application to piece-workers, as shown below.

This Notice is issued with the consent of the Minister of Labour.

SCHEDULE.

PROPOSED VARIATION OF OVERTIME RATES FOR MALE AND FEMALE WORKERS EMPLOYED ON

Paragraph 1.

Minimum Rates for Overtime set out in their Notice R.B.S.(4) in their application to Male and Female Workers employed on Piece-work by substituting the following Overtime Rates for those at present in operation for Pieceworkers:

PROPOSED OVERTIME RATES FOR MALE AND Female WORKERS EMPLOYED ON PIECE-WORK.

Paragraph 2.

Weekly Overtime Rate.

For the first two hours worked in excess of 48 hours in any week . . . TIME-AND-A-QUARTER except in so far as higher Overtime Rates are payable under the provisions of Paragraph 3 below.

For overtime after the first two hours of overtime in any week . . . TIME-AND-A-HALF except in so far as a higher overtime rate is payable under the provisions of Paragraph 3 below.

Provided that where it is the established practice of the employer to require attendance only on alternate Saturdays, the weekly Overtime Rates specified in this paragraph shall apply as follows:-

- (a) In the week in which attendance on Saturday is required, the weekly Overtime Rate shall not be payable until 50 hours have been worked, and shall be Time-and-a-quarter for the first two hours worked in excess of 50 hours in the week and Time-and-a-half thereafter;
- (b) In the week in which no attendance on Saturday is required, the weekly Overtime Rates shall be payable after 45 hours have been worked, and shall be Time-and-a-quarter for the first three hours worked in excess of 45 in the week and Time-and-a-half thereafter.

Paragraph 3.

Daily Overtime Rates.

- (a) Weekly Short Day (as defined in Paragraph 14 of the above-mentioned Notice R.B.S.(4), all overtime, *i.e.* all time worked in excess of 5 hours . . TIME-AND-A-HALF.
- (b) Sunday and Customary Public and Statutory Holidays all time worked . . . DOUBLE TIME.
- (c) Any Day (except the Weekly Short Day, Sunday, and Customary Public and Statutory Holidays) . . . ORDI-NARY TIME.

Paragraph 4.

ATTENDANCE ON SUNDAY IN PLACE OF SATURDAY.

Notwithstanding anything hereinbefore contained, where it is the established practice of an employer to require attendance on Sunday instead of Saturday, the provisions of this PIECE-WORK. aragraph 1. The Trade Board propose to Vary the Schedule apply in like manner as if in such provisions the word "Sunday" were substituted for "Saturday" and the word "Saturday" for "Sunday." Paragraph 5.

- (a) In the case of Male and Female Workers employed on Piece-work to which the general minimum piece rates are applicable the expressions " ordinary time," "time-and-a-quarter," "time-and-a-half" and "double time," mean the appropriate General Minimum Piece-Rate with, respectively, no addition, the addition of an amount equal to one-quarter of, the addition of an amount equal to onehalf of, and the addition of an amount equal to the whole of the Piece-Work Basis Time-Rate or General Minimum Time Rate, as the case may be, which would have been applicable to the worker if he she had been employed on work to which the General Minimum Piece-Rates were not applicable.
- (b) In the case of Male and Female Workers employed on Piece-work to which the General Minimum Piece Rates are not applicable, the expres-sions "ordinary time," "time-and-a-quarter," "time-and-a-half" and "double_time" double time '' mean piece-rates each of which is sufficient to yield, in the circumstances of the case, to an ordinary worker not less than the appropriate Piece-work Basis Time-Rate or, if no Piece-work Basis Time-Rate is applicable to the worker, not less than the appropriate General Minimum Time-Rate with, respectively, no addition, the addition of an amcunt equal to one-quarter of, the addition of an amount equal to onehalf of, and the addition of an amount equal to the whole of the appropriate Piece-work Basis Time-Rate or General Minimum Time-Rate as the case may be.
- Note.—No variation is proposed in the Overtime Rates for Time-Workers.

Pursuant to Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will consider any Objections to the above Proposal to Vary which may be lodged with them within two months from the 27th day of June 1930, the date on which notice of the Proposal was given in the Edinburgh Gazette. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary, Retail Bespoke Tailoring Trade Board (Scotland), 1 Whitehall Gardens, London, S.W.1.

It is desirable that objections should state precisely and, so far as possible, with reasons, what is objected to.
