## COAL MINES ACT, 1930.

THE CENTRAL (COAL MINES) SCHEME, 1930, submitted to the Board of Trade by the representatives of the majority of the owners of coal mines situated in Great Britain under the provisions of the Coal Mines Act, 1930.

#### TITLE.

1. This Scheme may be cited as the Central (Coal Mines) Scheme, 1930, and is hereinafter throughout referred to as "the Scheme," which expression shall include any amendment of the Scheme for the time being in force.
