## TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday the 4th December 1931, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914-1919, to the amount of £45,000,000.

2. The Bills will be in amounts of £5000 or £10,000. They will be dated at the option of the Tenderer on any business day from Monday the 7th December 1931 to Saturday the 12th December 1931 inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

PROPOSAL TO VARY the Minimum Rates of Wages for Female Workers in the Cerement Making Section of the Trade for Special Periods NOT dependent upon the Cost-of-Living Index Figure, and TO CANCEL all the Minimum Rates of Wages for Male and Female Workers in the Coffin Furniture Section of the Trade in their application to Workers employed in the Casting Shop, the Plating Shop and the Engraving Department.

This Notice is issued with the consent of the Minister of Labour.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated the 21st April 1927, the Coffin Furniture and Cerement Making Trade Board (Great Britain), established under the Trade Boards Acts, 1909 and 1918, HEREBY GIVE NOTICE that (A) as the specified period of operation of the minimum rates of wages set out in the Trade Board's Notice U. (28), dated 27th March 1931, will expire on the 31st March 1932, they again PROPOSE TO VARY the General Minimum Time Rates, Piece-Work Basis Time Rates and Overtime Rates for Female Workers in the Cerement Making Section of the Trade which are set out in the Schedule to the Trade Board's Notice U. (16), issued by the Trade Board and dated 2nd December 1924, and which would,

unless varied by the Trade Board, be effective on and after 1st April 1932, BY PROVIDING THAT the minimum rates of wages set out in the Trade Board's Notice U. (28), dated 27th March 1931, for the periods 1st April to 30th September 1931 and 1st October 1931 to 31st March 1932 respectively, shall be continued in operation for the corresponding six-monthly periods 1st April to 30th September 1932 and 1st October 1932 to 31st March 1933; (B) they PROPOSE TO CANCEL all the Minimum Rates of Wages for Male and Female Workers in the Coffin Furniture Section of the Trade, set out in their Notices U. (13) and U. (16), dated 31st December 1923 and 2nd December 1924 respectively, in their application to Workers employed in the Casting Shop, the Plating Shop and the Engraving Department.

Pursuant to Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will consider any Objections to the above Proposal to Vary and to Cancel which may be lodged with them within two months from the 1st day of December 1931. **SKELMORLIE ELECTRIC SUPPLY  
(EXTENSION).**

**N**OTICE is hereby given that application has been made to the Electricity Commissioners by The Skelmorlie Electric Supply Company Limited, whose registered office is at 2 West Regent Street, Glasgow (hereinafter referred to as "the Undertakers"), for a Special Order (hereinafter referred to as "the Order") under the Electricity (Supply) Acts, 1882 to 1928, for the following among other purposes (that is to say):—

That part of the area of supply authorised by the Greenock Electricity (Extension) Special Order 1925 comprising that portion of the Parish of Inverkip in the County of Renfrew included within the area bounded by a line commencing at a point on the Kelly Burn approximately 966 yards if measured in a straight line east of a point on the high water mark in the mouth of said burn in the said Parish of Inverkip and proceeding thence eastwards along the line of the said Kelly Burn forming the County Boundary between the Counties of Ayr and Renfrew along the bends thereof to the outfall of the Kelly Aqueduct part of the Greenock Corporation Water Works thence in a northerly and north-easterly direction along the West side of the said Aqueduct to the sluice at the Compensation Reservoir also belonging to the said Greenock Corporation Water Works; thence in a westerly and north-westerly direction along the south and west sides of the Aqueduct leading from the said Reservoir to Shielhill Farm (Bench Mark 570.6) thence on the easterly and northerly side of road following the bends via Dunrod and Auchness Bridge to the junction of said road with the road from Ardrossan to Greenock (Bench Mark 144.1); thence in a southerly direction along the West boundary of said last-mentioned road for a distance of approximately 100 feet thence along the south-west side of the fence and track running in a north-westerly direction through Bargane Plantation to the junction in the track approximately 510 yards from said last-mentioned road thence in a westerly direction from said junction passing along to the south of the Curling Pond to the point where the northern edge of the said plantation turns north-eastwards a distance of approximately 845 yards, thence in a north-easterly westerly and north-westerly direction along the northern and north-eastern edge of the extension west of the said plantation to the north end of the extension westward a distance

of approximately 1625 yards, thence along the north and east edge of said plantation for approximately 466 yards to a point approximately 200 feet south-west of Underheugh Cottage thence along the south edge of the Tannel Hill Plantation until it strikes the Burn entering the sea approximately 330 yards to the North of the Black Rocks and thence along the course of said Burn to the sea.

2. To extend the powers of the Undertakers under the principal Order to the added area with such variations as are or may be contained in the Order.

3. The Order will or may empower the Undertakers to make both within their existing area of supply and in the added area charges varying from or in excess of those chargeable within their existing area of supply and such charges may be based either upon the actual quantity of energy supplied to the consumer with an additional periodical fixed or service rental charge or by any other method of charge which may be settled and approved by the Electricity Commissioners.

4. To authorise the Undertakers to exercise within the added area such of the powers contained in the Electricity (Supply) Acts 1882 to 1928 and in the enactments incorporated therewith as are usually conferred upon distributors of electrical energy and to incorporate with the Order and make applicable to the Undertakers and to the undertaking with such variations as are or may be contained in the Order all or some of the provisions contained in the Schedule to the Electric Lighting (Clauses) Act 1899.

5. The streets or parts of streets not repairable by the Local Authority within the added area which the Undertakers propose to take special power by the Order to break up are specified in the draft Order as applied for.

6. The streets and parts of streets within the added area in which it is proposed that electric lines shall be laid down within the period specified in the Order are the roads or parts of roads set out in the Third Schedule to the draft Order.

7.
