TREASURY MINUTE DATED THE 14TH DECEMBER 1931.

My Lords read Section 8 of the Currency and Bank Notes Act, 1928.

The Chancellor of the Exchequer informs the Board that the Governor and Company of the Bank of England have represented to him that it is in their opinion expedient that the amount of the fiduciary note issue be maintained at 275 million pounds, to which it was increased under the authority of Treasury Minutes dated the 1st August 1931, the 21st August 1931, the 11th September 1931, the 2nd October 1931, the 30th October 1931, and the 30th November 1931. He proposes accordingly that the authority to the Bank to issue fiduciary bank notes to the total amount of 275 million pounds should be further extended until the 31st January 1932.

My Lords approve and direct that the Bank of England be notified accordingly.

PREVENTION OF EPIDEMIC, ENDEMIC AND INFECTIOUS DISEASES.

THE PUBLIC HEALTH (CHICKENPOX) AMENDMENT REGULATIONS (SCOTLAND), 1931, DATED DECEMBER 4, 1931, MADE BY THE DEPARTMENT OF HEALTH FOR SCOTLAND UNDER SECTION 78 OF THE PUBLIC HEALTH (SCOTLAND) ACT, 1897 (60 & 61 VICT. c. 38).

The Department of Health for Scotland, in pursuance of the powers competent to them under Section 78 of the Public Health (Scotland) Act, 1897, and of all other powers enabling them in that behalf, hereby make the following Regulations:—

- 1. These Regulations may be cited as the Public Health (Chickenpox) Amendment Regulations (Scotland), 1931, and shall be read as one with the Public Health (Chickenpox) Regulations (Scotland), 1927 (S. R. & O. 1927 (No. 270) p. 1005) (hereinafter referred to as "the principal Regulations").
- 2. The principal Regulations shall continue to have effect until the thirty-first day of December 1932, in the same manner as if that date were substituted in paragraph (2) of Article 1 of those Regulations for the thirtieth day of September 1927.
