

#### TENDERS FOR TREASURY BILLS.

- LordsCommissioners of Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday the 4th March 1932, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914-1919, to the amount of £40,000,000.
- 2. The Bills will be in amounts of £5000 or £10,000. They will be dated at the option of the Tenderer on any business day from Monday the 7th March 1932 to Saturday the 12th March 1932 inclusive, and will be payable at three months after date.
- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. The persons whose Tenders are accepted

The Secretary for Mines announces that he has made an Order under Section 61 of the Coal Mines Act, 1911, regulating the use of electrical shot-firing apparatus in coal mines. The effect of the Order may be summarised as follows:—

- (a) After the 31st March every new exploder taken into use in any mine or part of a mine in which permitted explosives are compulsory must be of a type that has been approved by the Board of Trade. Exploders not of approved types now in use in such mines must be replaced by exploders of approved types not later than the 31st December next.
- (b) The exclusive use of magneto exploders is no longer required; battery exploders and dynamo exploders will be approved if they pass the official tests.
- (c) Provisions are included for guarding against exploders being rendered unsafe by unauthorised interference, and for periodical examination and efficient maintenance of approved exploders.

Civil Service Commission, February 26, 1932.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:—

REGULATIONS RUSPECTING OPEN COMPETITIVE EXAMINATIONS FOR THE SITUATION OF WRITING ASSISTANT (FEMALE) IN THE CIVIL SERVICE.

These Regulations are liable to alteration from time to time.

- 1. The limits of age are 16 and 17. For an examination beginning in one of the first six months of the year, the governing date on which candidates must be of the prescribed age is the first of March; for an examination beginning in one of the last six months of the year, the governing date is the first of Septem-A candidate who attained the age of 16 on the governing date would be admitted, but a candidate who attained 17 on that date would not be admitted. Candidates who have served in any established civil situation to which they were admitted with the certificate of the Civil Service Commissioners may deduct from their actual age any time not exceeding two years which they may have spent in such service.
- 2. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject.

Provided that if the Civil Service Commissioners are satisfied in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalization or by any other voluntary and formal act.

- 3. Candidates must be unmarried and will be required to satisfy the Civil Service Commissioners that they are duly qualified in respect of health and character.
- 4. The subjects of examination are as follows, viz.:—
  - 1. English.
  - 2. Handwriting.
  - 3. Spelling.
  - 4. Arithmetic.
  - 5. Geography.

Candidates must obtain such an aggregate of marks in the examination as a whole as to satisfy the Civil Service Commissioners.

5. It will rest with the Civil Service Commissioners to determine the Departments to which the successful candidates shall be assigned. In making the assignments the Commissioners will be guided by the requirements of the public service. Subject to this

condition, the wishes of the candidates will, where possible, be respected. Candidates will be assigned, save in exceptional circumstances, only to offices within daily travelling distance of their places of residence.

- 6. Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commissioners.
- 7. Application for permission to attend an examination must be made at such times and in such manner as may be fixed by the Civil Service Commissioners.
- 8. A fee of ten shillings will be required from every candidate applying for admission to attend an examination.

The Civil Service Commissioners further give notice that an Open Competitive Examination will be held under the foregoing Regulations on the 7th June 1932.

Chatham, Chester, Devonport, Gloucester, London, Newcastle-on-Tyne, Portsmouth, Reading, Sheerness, York.

The Examinations are restricted to persons whose homes are in or near the town for which they desire to compete.

No person will be admitted to Examination from whom the Secretary of the Civil Service Commission has not received, on or before the 14th April 1932, an application, in the Candidate's own handwriting, on a prescribed form, which may be obtained from the Secretary at once.
