The KING's Most Excellent Majesty in Council.

WHEREAS the Department of Health for Scotland have, in pursuance of the powers competent to them under the Burial Grounds (Scotland) Act, 1855, made a Representation that they have received a copy of an Interlocutor pronounced by the Sheriff-Substitute of Aberdeen, Kincardine and Banff, dated 4th December 1929, finding that the Old Churchyard of Fordoun adjoining the Parish Church of Fordoun in the Parish of Fordoun and County of Kincardine is so situated and so crowded as to be offensive and dangerous to health and contrary to decency:

And whereas in the said Representation it is recommended that Burials be forthwith discontinued in the said Burial Ground in terms of Section 5 of the aforesaid Act except for the burial therein of relicts having spouses interred in said Burial Ground prior to the date of the Order in Council closing the same; Provided always as regards future interments that the exercise of the right of burial be not injurious to public health or offensive or contrary to decency; that notice be given to the District Sanitary Inspector not later than the day preceding that on which a grave is to be opened and that no interment shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper side of

the coffin and that without interference with the remains of a previous interment:

Now, therefore, His Majesty in Council is pleased to give notice of such Representation and to Order that the same be taken into consideration on the 27th day of April next.

And His Majesty is further pleased to direct that this Order, or Notice thereof, be published in the Edinburgh Gazette, and that copies of this Order or Notice thereof, be fixed as required by the aforesaid Act on the doors of the Church of, or on some other conspicuous places within, the parish or parishes affected one month before such Representation is considered.

TENDERS FOR TREASURY BILLS.

1. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

TRADE BOARDS ACTS, 1909 AND 1918.

VARIATION OF MINIMUM RATES OF WAGES FOR FEMALE WORKERS IN THE CEREMENT-MAKING SECTION OF THE COFFIN FURNITURE AND CEREMENT-MAKING TRADE, AND CANCELLATION OF MINIMUM RATES IN THEIR APPLICATION TO CERTAIN MALE AND FEMALE WORKERS IN THE COFFIN FURNITURE SECTION OF THE TRADE.

SCOTTISH BORDER ELECTRICITY.

which area is hereinafter called "the area of supply."

2. To authorise the Company to exercise within the area of supply all powers usually conferred on distributors of electricity.

3. To make provision as to the supply of electricity and the maximum prices which may

be charged by the Company within the area of supply.

4. To empower the undertakers for the purposes of the Berwick-upon-Tweed Electric Lighting Order 1900 by agreement to sell and to authorise the Company to purchase and take a transfer of the undertaking authorised by that Order or any part thereof and to provide for the revocation or amendment of that Order and extend and apply to and within the area of supply thereunder the powers and provisions of the intended Order or some of them.
