COUNTY OF ARGYLL.

LOCAL GOVERNMENT (SCOTLAND) ACT, 1929.

Amending District Council Scheme made by the County Council of the County of Argyll in accordance with the Provisions of Section 25 as read with Section 14 of the Local Government (Scotland) Act, 1929.

- (1) The District Council Scheme made by the County Council of the County of Argyll and approved by the Secretary of State on the 1st March 1930 is hereby revoked.
- (2) There shall be constituted a District Council for each of the ten Districts named in Column 1 of the Schedule appended hereto, comprising the County Council Electoral Divisions named in Column 2 of the said Schedule (the Mull (South), Tiree and Coll, Lismore and Appin, Kintyre (West), and Jura and Colonsay Electoral Divisions being divided into Wards as there defined).

The number of District Councillors to be elected for each Electoral Division or Ward, the number of ex officio members (i.e. County Councillors), and the total membership of each District Council shall be as shown in Columns 3, 4, and 5 respectively of the said Schedule.

- (3) In connection with the establishment of the District Council for the Tiree and Coll District as defined by this Scheme, the provisions of Section 5 (1) of the Local Government (Scotland) Act, 1929, shall apply as if the functions of the Tiree and Coll District Councils as existing at the date hereof were by this Scheme transferred to the District Council for the Tiree and Coll District as defined by this Scheme.
- (4) The provisions of Sub-sections (1), (2), and (4) of Section 6 of the Local Government (Scotland) Act, 1929, shall with the necessary modifications apply for the purpose of transferring the property and liabilities of the Tiree and Coll District Councils as existing at the date hereof to the District Council for the Tiree and Coll District as defined by this Scheme as if such Councils were transferor and transferee authorities respectively.
 - (5) This Scheme shall come into operation forthwith for the purposes of the election of

District Councillors to be held on the 6th December 1932, and for all other purposes on the 6th December 1932.

TENDERS FOR TREASURY BILLS.

- 1. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.
- 7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.
