# BY THE KING. A PROCLAMATION.

GEORGE R.

Whereas our Parliament stands prorogued to Thursday the 17th day of December next, we, with the advice of our Privy Council, do hereby publish and declare, that the said Parliament shall be farther prorogued on the said 17th day of December next to Thursday the 21st day of January next; and we have given order to our Chancellor of that part of our united kingdom called Great Britain, to prepare a commission for proroguing the same accordingly; and we do farther hereby, with the advice aforesaid, declare our will and pleasure, that the said Parliament shall, on the said 21st day of January next, be held and sit for the dispatch of divers urgent and important affairs; and the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Com-missioners for Shires and Burghs of the House of Commons, are hereby required and commanded to give their attendance accordingly at Westminster on the said 21st day of January next.

Given at our Court at the Queen's Palace, the 25th day of November 1807, in the 48th year of our reign.
