Public Health (Imported Food) Regulations, 1925.

Public Health (Imported Food) Amendment Regulations, 1933.

The Minister of Health gives notice, in pursuance of the above-named Regulations, that he hereby recognises for the purposes of items (a) and (c) of the Second Schedule to the Amendment Regulations, *i.e.*: —

(a) A severed part of the carcase of an animal (including the head or any part thereof, and the whole carcase without the head, but not including any part of the carcase of a pig which has been salted, cured, pickled, dried or smoked or otherwise prepared in the manner in which bacon or ham is ordinarily prepared), from which no submaxillary, pre-scapular, pre-crural, superficial inguinal, supramammary, or popliteal gland has been taken out;

(c) All edible parts of an animal other than (i) the head or other severed parts of the carcase, (ii) the intestines prepared in the form of sausage casings, and (iii) meat which has before importation been made ready for human consumption in the form of a sausage or other prepared or manufactured article of food;

the Official Certificate of which particulars are given in the Schedule hereto as evidence that the meat to which it relates has been derived from an animal which was free from disease at the time of slaughter and has been dressed or prepared and packed with all necessary precautions for the prevention of danger to public health.

The recognition applies only if the label is securely affixed to the meat, or to the package containing the meat, and if the label has not


